Gene Guerra, president of the Travis Civic Association expressed his concerns about NYC School Construction Authority's proposed new 476-seat public elementary school on the St. Anthony of Padua R.C. Church's property in Travis.

Frank Fontana, the Staten Island liaison for the NYC Department of Buildings reported the following:

David Carr, Chief of Staff to Council Member Matteo explained to the committee that Council Member Matteo voted against the DOB's local laws mandating the green roof additions for new construction and major alterations, but he did support the tax credit because he supports incentivizing green buildings, just not mandating it.

David Carr read Council Member Matteo's testimony regarding his support of the proposed school for the site located at 24 Shelley Avenue. Testimony is attached.

Saman Mahmous of Congress Member Max Rose's office spoke about a Nonprofit Security Grant Program Workshop that the Congress Member will be hosting in Brooklyn for local nonprofit organizations and religious institution to learn how to apply for funding to help improve security systems that best fit the needs of the institutions. Speakers at the workshop will include representatives from the Federal Emergency Management Agency (FEMA), which oversees the grant program, as well as from the NYS Homeland Security and Emergency Sservices and the NYPD, who will speak to actions being taken on the state and city. Congress Member Rose is planning additional workshops. Congress Member Rose will have a Cyber Security Workshop.

Jermaine Williams of NYC HRA spoke about the Fair Fares Program. Fair Fares NYC is a city program created by Mayor de Blasio and Council Speaker Corey Johnson, and members of the City Council to help New Yorkers with low incomes manage their transportation costs. https://www1.nyc.gov/site/fairfares/index.page.
