Page 2 - March 19, 2024 Full Board Meeting minutes

Chair Fred R. Guinta called the meeting to order at 7:00 P.M. and opened with a pledge to the American Flag.

Acceptance of the Agenda: Chair Guinta called for a motion to accept the agenda. A motion was made and seconded. The agenda was unanimously approved.

Acceptance of the February 20, 2024, Full Board Minutes: Chair Guinta called for a motion to accept the minutes. A motion was made and seconded. The minutes were unanimously approved.

Standing Committee Reports:

Parks: Jordan Hafizi, Chair reported that the committee met with representatives of the NYC Department of Parks and Recreation on March 12, 2024, at 7:00 P.M. in the Community Board Office. Parks provided a PowerPoint presentation of the design plans for the reconstruction of the Midland Playground project. The cost of the project is \$4.2 M. \$1,775 M from Council Member David Carr and \$2,425 M from Borough President Vito Fossella. The committee supported the plan as presented.

Environmental Protection: Stephen W. Zaderiko, Chair reported that at the Parks and Environmental Protection Joint Committee meeting on March 12, 2024, an issue came up about long-term leaks in the middle of roads such as Snake Hill Road, Rockland Avenue near Florida Street and by Burton Court, by St. Andrew's Parking lot, and by the College of Staten Island. This leaking water erodes the road. In the winter, the roads ice and salt are put down which goes into the salt marshes that we need and destroys the growth there that we need to protect us from flooding. The committee is putting together a list of long-term road conditions where there is a leak in the middle of the road. We have half a dozen roads on the list. If anyone on the board has a location they'd like to share, please email Debbie or myself. We will invite DEP and DOT to a committee meeting to see if they can work together to remedy these leaks and road damage.

Public Service: Michael Lanza, Chair reported that on March 11, 2024, the committee met in the Community Board 2 office to review a New Application and Temporary Retail Permit to the NYS Liquor Authority for a Restaurant Wine Liquor License (includes the Patio or Deck) for a new restaurant at 2211 Hylan Boulevard, SINY 10305. It was the committee's opinion that this restaurant would be good for the community.

The camera on Manor Road near the JCC is the most revenue camera, yet nothing has been done in the last three years to improve the road to make it safer. I would like to put a proposal before the board that every speed camera on Staten Island that has more than 100 tickets in a sixmonth period, which is a lot of tickets to install signage
