- Developmental,
- Substance use, and/or behavioral challenges

If you've received any services in the child-serving systems below then you meet criteria to become a YPA

- Juvenile Justine
- Foster care
- Special education
- Addition recovery

FTNYS in partnership with the NYS Office of Children and Family Services (OCFC), is seeking to employ Family Policy Advisors at the state level to assist OCFC in developing policies and procedures that promote the voice of parents throughout the child welfare system.
