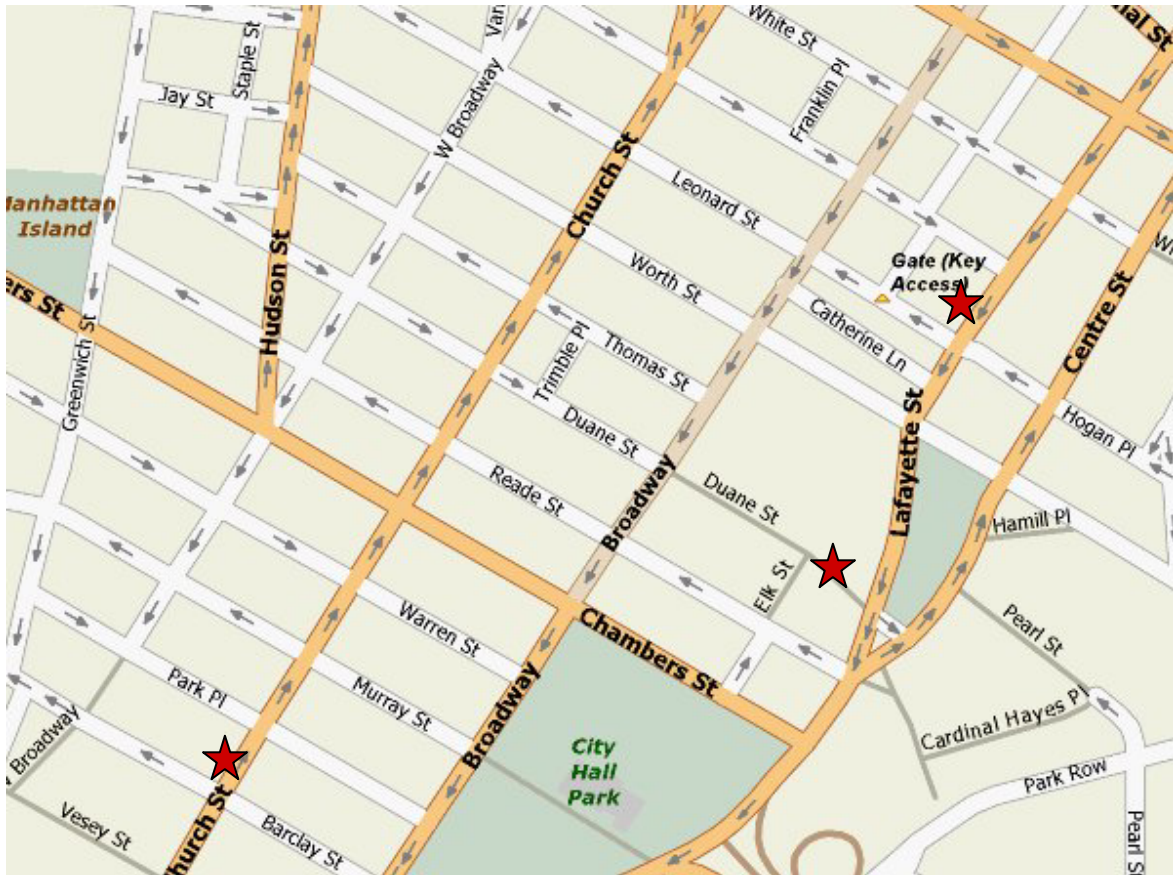


**AREA MAP OF 100 CHURCH STREET, 52 DUANE STREET &

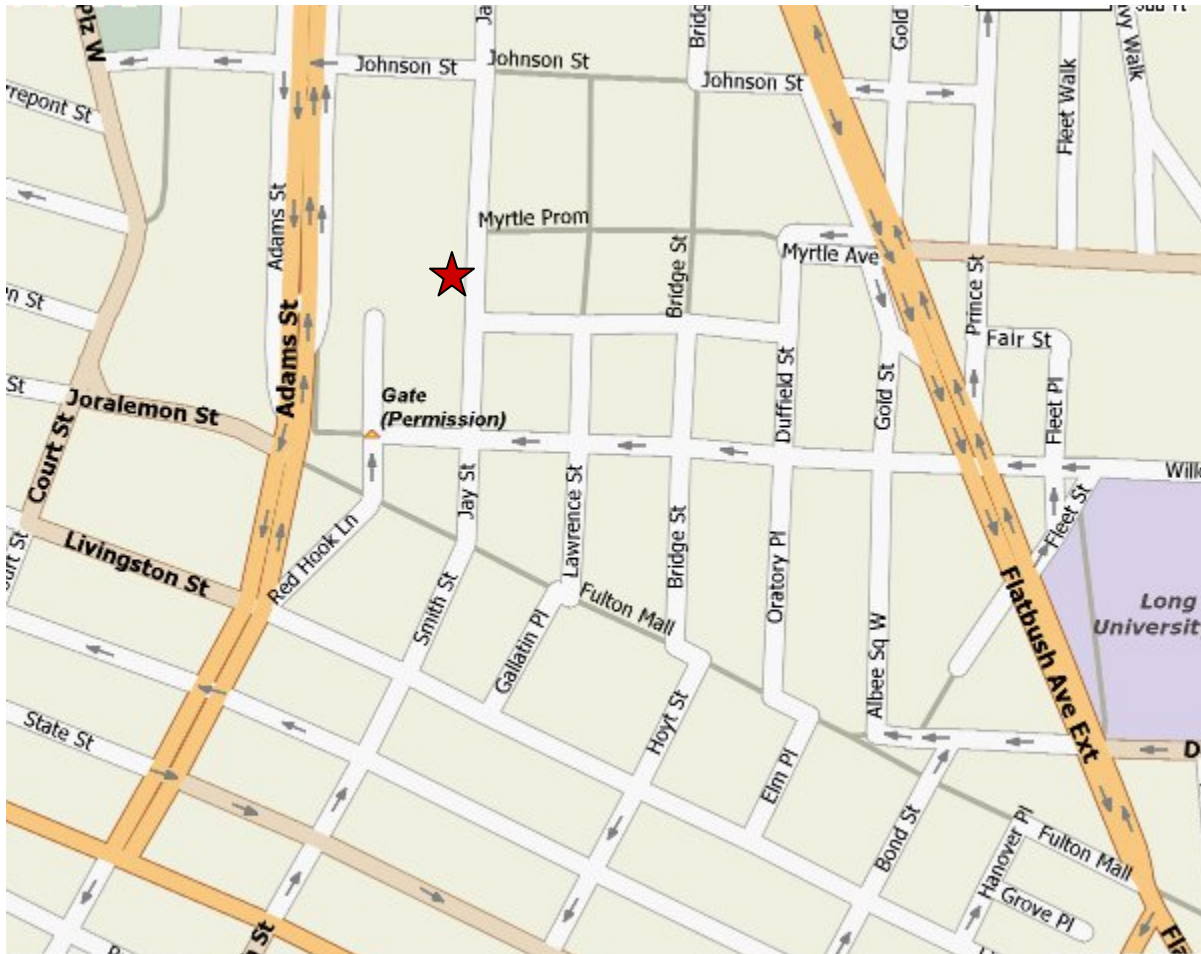

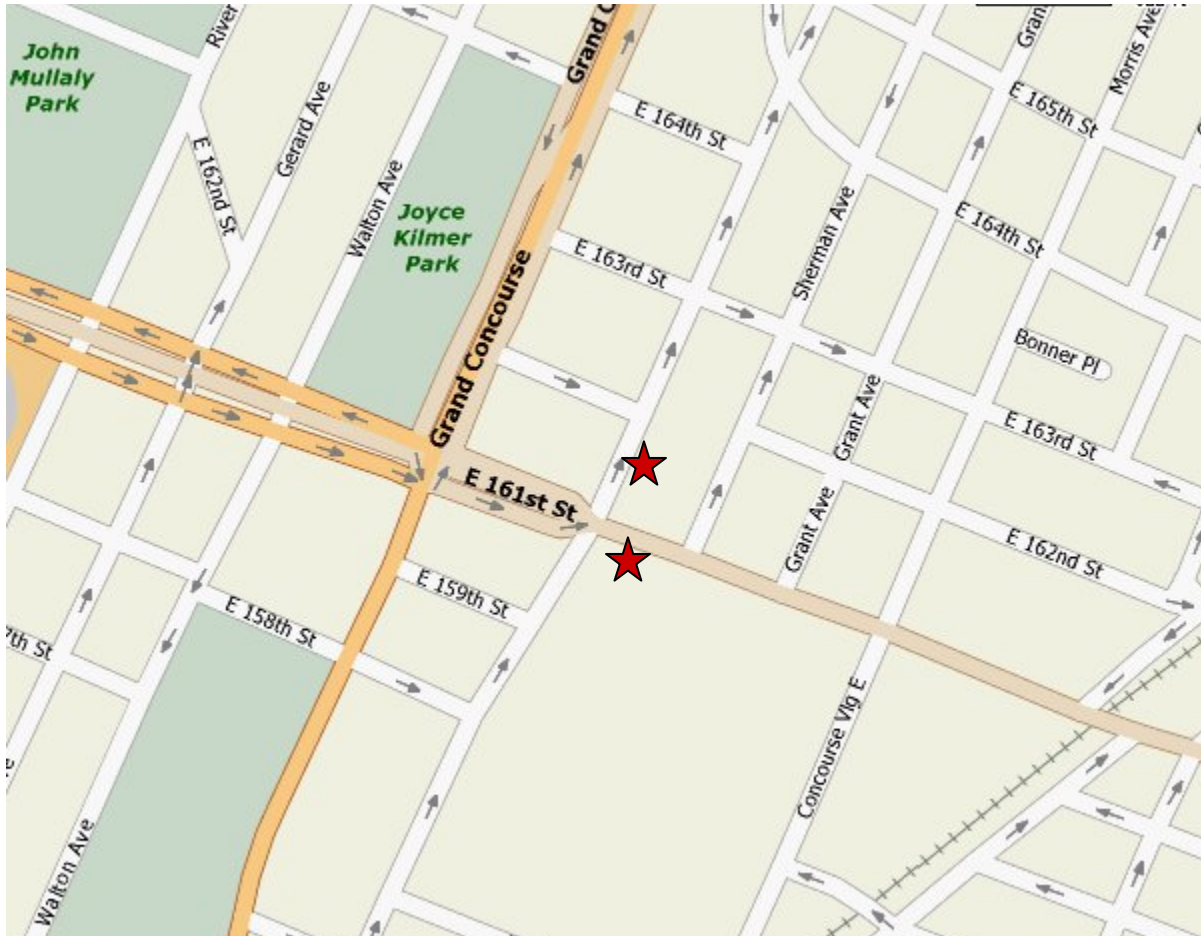

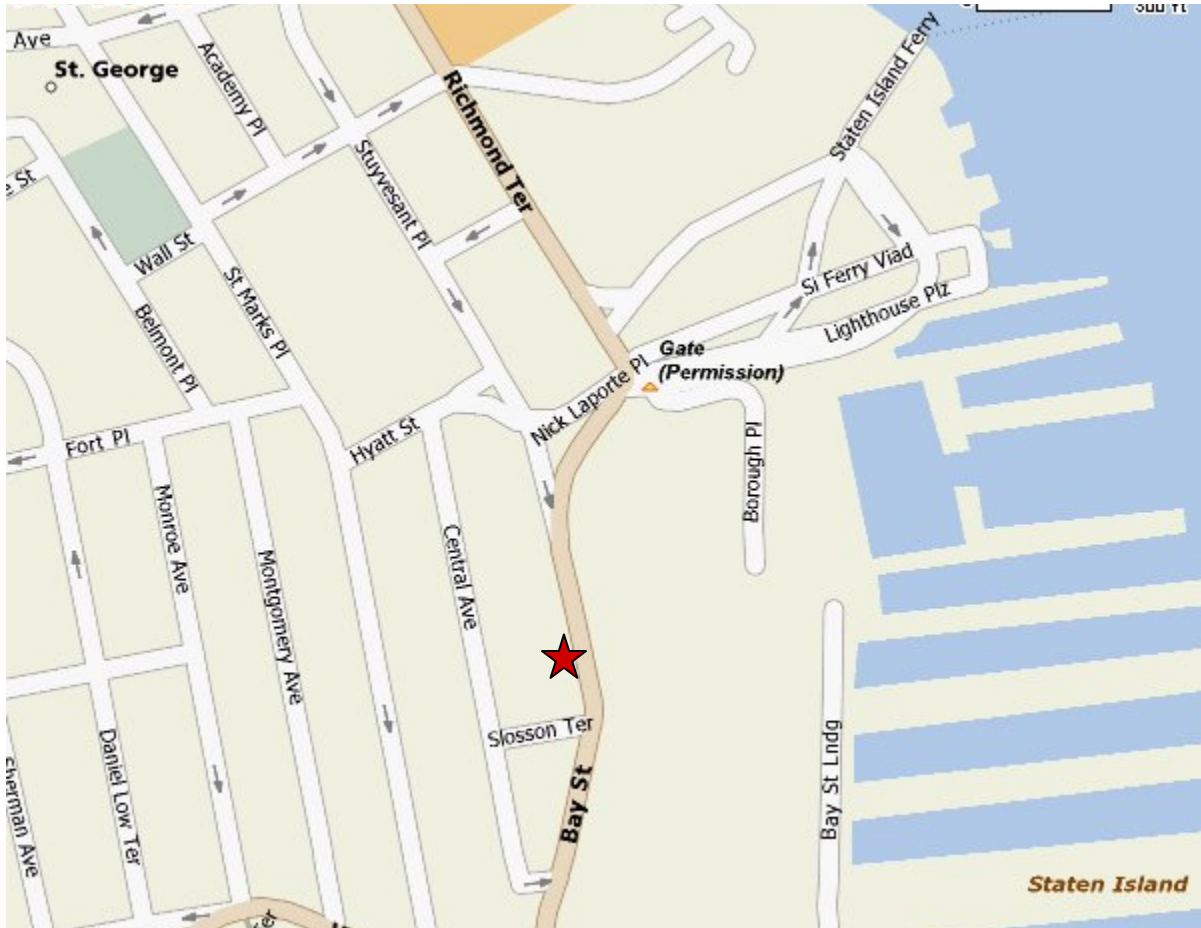
