OF AVAILABILITY FOR HEARINGS

For purposes of entering dates in our computer scheduling program, please mark on the calendar below dates between **April 01st and December 31st** when no one in your firm will be available. Whenever possible, the Tax Commission will not assign you or your firm hearings on the dates you mark below, EXCEPT: during the hearing period for condos, tentatively planned for May 06th through July 24th (only single-rep), condo hearings will be scheduled without regard to submitted availability, except during the week of June 29th. Where condo and non-condo hearings conflict, the non-condo hearing will be rescheduled to a later time that same day. Please notify tcinfo@oata.nyc.gov if you can be scheduled for more than one hearing on the same day at different times. NOTE: If you do not submit an availability form or if you do not mark a date as unavailable, the Tax Commission may schedule you for hearings on any weekday between April 01st and December 31st, other than a City holiday. City government offices will be closed Memorial Day May 25th, Juneteenth Day on June 19th, Independence Day on July 04th(observed on the 03th), Labor Day September 07th, Columbus Day October 12th, Election Day November 03rd, Veterans' Day November 11th and Thanksgiving Day November 26th. Sign, date, and upload the form to Box.com, so it is received by **March 16, 2026**.
