

4. A motion was made to approve the base station license application recommendations. The motion passed unanimously.
  
5. Item 5 on the Agenda, proposing amendments to the rules to update the in-vehicle camera system (IVCS) specifications for taxis and street hail liveries and to remove the requirement that livery vehicles be equipped with a partition or an IVCS. The rule was presented for a vote, and the rule passed by a unanimous vote.
  
6. Item 6 on the Agenda, proposing s a new rule that: 1) creates a new short-term storage program for For-Hire Vehicle (FHV) licenses (“Short-Term FHV Storage Program”); and 2) clarifies that, after August 31, 2023, the end date of the previous storage program, created during the height of the COVID-19 pandemic (“COVID-19 FHV Storage Program”), licenses remaining in that program will not transfer over to the new Short-Term FHV Storage Program, and if not expired, will be subject to fines and suspension for failure to follow directives to exit the storage program, as well as revocation for non-use. The rule was presented for a vote, and the rule passed by a unanimous vote.
