- 4. A motion was made to approve the base station license application recommendations. The motion passed unanimously.
- 5. Item 5 on the Agenda, Russell Glynn, Director of Policy Research, presented a report on the Street Hail Livery Pilot.

- 6. Item 6(a) on the Agenda, proposing amendments to the rules pursuant to Local Law 78 of 2025 to require that all taxicabs and for-hire vehicles add cyclist awareness decals inside the rear passenger doors. The rule was presented for a vote, and the rule passed by a unanimous vote.
- 7. Item 6(b) on the Agenda, proposing amendments to the rules pursuant to Local Law 90 of 2025 to update its personal injury insurance coverage requirements. The rule was presented for a vote, and the rule passed by a unanimous vote.
- 8. Item 6(c) on the Agenda, proposing amendments to the rules that govern the ways in which a non-accessible vehicle can be converted to a Wheelchair Accessible Vehicle. The rule was presented for a vote, and the rule passed by a unanimous vote.
- 9. Item 6(d) and 6(e) on the Agenda, proposing amendments to the rules to adjust the minimum per-mile rate for high-volume for-hire vehicle trips that begin in New York City and end outside of New York City. The rule was presented for a vote, and the rule passed by a unanimous vote. A motion was made for expedited implementation of the rule waiving the 30-day promulgation period, and the motion was passed unanimously.
