**Electric Taxi Pilot Program -- What It Is:**

Nissan North America Inc. and New York City will be piloting six Nissan LEAF all-electric vehicles beginning in spring 2012. These cars will be put into normal taxi service (with an existing taxicab medallion) and will provide passengers with a new and unique experience. In addition to providing a special passenger experience, we will need owners and drivers – like you – to volunteer to be the city's first electric cab operators. You will receive a lease for a Nissan LEAF to use for taxi service free-of-charge (no rental payment for lease) for up to one year. Just like today, you will pick up passengers and collect fares, but we will also want your feedback. This pilot program is dependent on feedback from all participants – drivers, owners, passengers, and the public.
