TLC ANNOUNCES BEAVER STREET, LONG ISLAND CITY AND STATEN ISLAND FACILITY CLOSURES.

The New York City Taxi and Limousine Commission (TLC) wishes to alert its licensees that the TLC's 33 Beaver Street, Long Island City and Staten Island Facilities will be closed tomorrow October 30th, 2012. If you had a scheduled Office of Administrative Trials and Hearings (OATH) hearing at 33 Beaver Street or Long Island City or an application appointment scheduled at Long Island City or Staten Island, it will be rescheduled as follows:

33 Beaver Street:

If you were scheduled for a hearing at 33 Beaver Street, you will receive a letter in the mail from OATH with a new date for your hearing.

Long Island City and Staten Island Facility Application Appointments

If you had an appointment to submit an application for licensure tomorrow, Tuesday(10/30), please come to the facility at the same time on Wednesday (10/31), as you would have appeared on Monday(10/29) or Tuesday(10/30).

If you were scheduled for a hearing at Long Island City, you will receive a letter in the mail from OATH with a new date for your hearing.

NOTES:

- Although our Woodside Facility is open, due to inclement weather, S&E will NOT be issuing summonses for the week of 10/29-11/2 due to missed inspections.
