

COVID-19 LIVERY VEHICLE RECOVERY ACT APPLICATION

Qualifications:

- Your Livery Vehicle License must have expired between March 7, 2020, and September 12, 2022;
- You must have been affiliated with a livery base at the time of the expiration;
- You must have the same SSN (Social Security Number) / EIN (Employee Identification Number) that is on file with TLC

Restrictions:

- If your license was suspended or revoked at the time it expired, you may not be eligible.
- These licenses will carry the same restrictions they had when they expired. For example, a license that was restricted to an electric vehicle may only be renewed as an electric vehicle, and a license restricted to a wheelchair accessible vehicle may only be renewed as a wheelchair accessible vehicle.
- Although the original license must have been affiliated to a livery base, licenses renewed under this Rule can also be affiliated to black car and luxury bases. However, they may NOT be affiliated with a high-volume for-hire base (Uber/Lyft).

If you are deemed eligible, you will be able pay a vehicle license renewal fee on [LARS](#) and upload the necessary documents online via [TLCUP](#).

Note: The owner is responsible for providing the most up to date base, vehicle, and plate information.

Base & Vehicle Affiliation: The following **must** be submitted with the completed application:

- ☐ **Government issued photo ID** (*driver's license, passport, etc.*) is required for the individual submitting the application;
- ☐ **Completed application** signed by the for-hire vehicle owner, and owner or principal of the **affiliating** base;
- ☐ **Proof of Vehicle Ownership** – One of the following in the applicant's name: Current DMV registration, Bill of Sale, Certificate of Origin or Certificate of Title (Front and Back).

Note: We do **not** accept a car dealership's Temporary Certificate of Registration (**MV-50**).

Vehicles licensed out of New York State must provide **DMV registration** that specifies the vehicle's seating capacity.

- ☐ Current **For-Hire Commercial Insurance** Certificate (FH-1);
- ☐ Current **Certificate of Liability Insurance**, showing levels of insurance coverage;
- ☐ Current **Insurance Declaration Page**, directly from the insurance company, showing levels of insurance coverage;
