

## For-Hire Vehicle Annual Accessibility Report

Year 6 July 1, 2023 – June 30, 2024





### **EXECUTIVE SUMMARY**

The NYC Taxi and Limousine Commission (TLC) is committed to ensuring accessible service is readily and widely available to the riding public. TLC monitors accessible service in the FHV sector through specified wait time standards. Since 2021, authorized wheelchair accessible vehicle dispatchers must provide 80% of trips in 10 minutes or less and 90% of trips in 15 minutes or less. In Fiscal Year 2024, the FHV sector provided 48,000 trips per month in 15 minutes or less, where the passenger specifically requested a wheelchair accessible vehicle. TLC's minimum wait time rules ensure that FHV WAV service is consistent and reliable for the many New Yorkers who depend on an accessible vehicle to get around.


Since the accessible wait time service rules went into effect, the number of wheelchair accessible vehicles (WAVs) increased dramatically. At the end of Fiscal Year 2024, there were 5,800 wheelchair accessible for-hire vehicles in circulation compared to 339 that were available in January 2019. Year 6 boasted almost 560,000 completed wheelchair accessible trips between July 2023 and June 2024. Moreover, 88% of passengers are picked up within 10 minutes of their request. This exceeds the wait time standard that 80% of trips have a wait time of 10 minutes or less.

Recently, the TLC held a public hearing and voted to adopt new rules requiring FHV WAV dispatchers to serve 90% of trips in 10 minutes or less. The enhanced wait time requirement will further improve access to wheelchair accessible vehicles across the five boroughs.



## FHV Fleet Growth Number of WAVs on the Road

- In Year 6 the number of FHV WAVs on the road grew by almost 20%.
- As the number of WAVs grew, the number of completed trips steadily increased as illustrated in the following report.







TLC Chapter 59 rules governing wheelchair accessibility in the FHV sector were adopted in January 2019. The rules provide two options for bases to satisfy the accessible service requirements. The majority of trips are serviced by approved FHV WAV dispatchers and a small share of traditional FHV bases.

- > Option 1: FHV WAV Dispatch (Central Dispatch Exception)
  Rule Criteria
  - Base contracts with authorized FHV WAV Dispatcher
  - FHV WAV Dispatcher provides trips
  - Trips are measured based on a wait time standard
    - 90% < 15minutes
    - 80% < 10 minutes</p>


 Base is required to dispatch 25% of trips in an FHV WAV regardless of passenger request



# FHV WAV Dispatch Completed Accessible Trips

(Central Dispatch Exception)

- In FY 2024 there were almost 560,000 completed accessible trips compared to a little over 335,000 completed trips in the previous reporting period. This represents a 65% growth over Year 5.
- Uber and Lyft demonstrated greater consistency in their number of completed trips.






# FHV WAV Dispatch 10-minute Wait Time Standard

FHV WAV Dispatch
Central Dispatch Exception
10-minute service Level Standards

- Year 6 service level standards required 80% of trips to arrive within 10 minutes of the passenger request. Both Uber and Lyft exceeded standards with an average wait time of 88% and 91%, respectively.
- From January-March, Uber sustained a 91% average for the 10-minute service threshold. Despite Uber's fluctuation, the rideshare service has not fallen below the 80% threshold.
- During the same months, January-March, Lyft was able to sustain and serve nearly 95% of trips in 10 minutes or less.
- Since Year 5, both Uber and Lyft were more consistent in their ability to meet wait time thresholds.

#### FHV WAV Dispatch Central Dispatch Exception 15-minute service Level Standards


Year 6: July 1, 2023 - June 30, 2024

- Year 6 service level standards required
   90% of trips to arrive within 15 minutes of the passenger request.
- Uber and Lyft both performed similarly, ensuring a wait time of 15 minutes of less 97% of the time.
- Lyft improved on their trip performance in Year 6. They exceeded the minimum wait time threshold and maintained a 96%, or above, compliance rate for the 15-minute service level standard.









## TRIP MANDATE AUDIT

#### Base Audit Responses







TLC conducted an audit of Bases affiliated with the Trip Mandate Rule (TMR). The rule requires that Bases dispatch 25% of trip request in a WAV even if a WAV was not requested by the passenger. Calls were made to 963 bases to determine if they were still operational and providing WAV services.

- 19%: Bases were suspended, in a fail to renew status, closed, or out of business
- 35%: Bases did not answer the phone when called
- 28%: Bases were able to dispatch a WAV at the time of the call
- 18%: Bases did not have a WAV available at the time of the call

The TMR Base Audit survey was designed to capture a Bases' ability to dispatch a WAV at the time of request. Survey responses indicate only 28% of Bases were able to provide a WAV when requested.

Similarly, the Trip Mandate Base Compliance List found in Appendix A, provides another indicator of compliance. TLC analyzed trip data for TMR bases and found only 20% met the TLC rule requirement to dispatch 25% percent of trip requests in a WAV. In contrast, 80% of bases fell short of the service requirement.



As of December 2023, FHV WAV dispatchers, Uber and Lyft, served over 96% of WAV requests in under 15 minutes.

## POLICY SHIFTS: RULE AMENDMENT

While this is better service than what was available several years ago, there is still a gap in wait time between WAV requested and non-WAV requested trips.

To address the gap in wait time and move towards greater parity between WAV and non-WAV trips, TLC adopted new rules requiring FHV WAV dispatchers to service 90% of trips in 10 minutes or less.

The new wait time standard went into effect March 2025 and will be evaluated on a yearly basis at the end of the calendar year moving forward.



### **RECOMMENDATIONS**

01

Monitor impact of new wait time standard of 90% of trips services in 10 minutes or less.

02

Reevaluate the FHV WAV Dispatch (Central Dispatch Exception) and Trip Mandate models.

03

Analyze results from audit of Trip Mandate Bases and propose recommendations.

04

Survey and engage bases that are contracting with FHV WAV dispatchers to get feedback on program.
