## NEW YORK CITY TAXI AND LIMOUSINE COMMISSION

## **Minutes of Commission Meeting**

April 17, 2008

## Present:

- 1. The Chair called the meeting to order and reported the following:
  - The Chair reported that TLC's Driver Recognition Ceremony held on March 27, 2008 at the Top of the Rock was a success. Speakers included Ben Bailey of Cash Cab fame, and actor Tom Wopat. (Tr. pp. 3-5)
  - The Chair reported on the death of Marvin Greenberg. Mr. Greenberg was the longest serving Commissioner at the TLC. (Tr. pp. 5-6)
  - The Chair reported on the death of Judge Alex Sherman. Judge Sherman had been an Administrative Law Judge for the TLC for over 30 years. A moment of silence was observed to remember Mr. Greenberg and Judge Sherman. (Tr. pp. 6-7)
  - The Chair reported that in preparation for the Pope's April 20, 2008 visit to Yankee Stadium certain areas will be designated as pick-up and drop-off locations. Details will be available on the TLC website. (Tr. p. 8)
  - The Chair reported on Operation Secret Rider, an initiative to enhance customer service for taxi riders. The compliance rate remains at 91 percent. A total of 3,037 tests were conducted resulting in a total of 402 summonses issued. The Chair noted that the compliance rate for cell phone usage is 94% and the compliance rate for credit card acceptance is 99%. (Tr. p. 8)

- The Chair reported on the Taxi of Tomorrow project. The TLC issued a Request for Information (RFI) requesting information from potential manufacturers in terms of what they believe they can do to build the Taxi of Tomorrow and what interest there is out there by various manufacturers. The due date for final responses is April 21, 2008. So far, the TLC has had over 200 downloads of the RFI from our website. (Tr. p. 9)
- The Chair reported that the upcoming medallion sale and bid collection will start on Monday, April 28, 2008 at 9:00 AM to 12:00 PM and will continue to Thursday, May 1, 2008 at 12:00 PM. Bid opening will take place on Friday, May 2, at 9:00 AM. In total 89 medallions will be auctioned, including: 86 corporate accessible (sold in lots of two, minimum bidding price per lot is \$700,000); one independent accessible medallion (minimum bidding price is \$189,000); and two independent alternative fuel medallions (minimum bidding price of \$300,000). In preparation for the auction, seminars will be held at our Rector Street facility, on Tuesday, April 22, 2008 at 1:00 PM and 7:00 PM. A technical workshop, for those interested in submitting bids, will be held on Friday April 25, 2008 at 1:00 PM and 7:00 PM at our Rector Street facility. More information is available on the TLC website. (Tr. pp. 9-11)
- The Chair reported on the Taxi Technology Customer Service Enhancements. 10,000 taxis have installed the credit card and taxi technology equipment. That is about 81% of the total fleet. Tips continue to average 20%. Taxicab Technology Corp. (TTC), one of the taxicab technology vendors, has gone bankrupt. Affected medallions are free of their contract with TTC and may approach one of the three remaining vendors. (Tr. pp. 11-12)
- The Chair reported on the Accessible Dispatch Program. The contract was approved by the Comptroller and has been executed and we are in the process of issuing a notice to proceed. We have been meeting with potential driver trainers and expect to post a list of trainers on the website in the near future. (Tr. pp. 12-13)
- The Chair reported that a lease cap hearing was held last month. The response to TLC inquiries for information pertaining to lease caps was disappointing. Due to this lack of response, the deadline for the submission of written comments has been extended through the end of this month. (Tr. pp. 13-14)
- The Chair reported that the LiveScan system is once again online at our Staten Island facility. LiveScan is the system by which fingerprints can be transmitted electronically for processing, expediting the application process greatly. (Tr. pp. 14-15)
- The Chair reported that a taxi stand has opened near Grand Central Station, at the intersection of 43<sup>rd</sup> Street and Vanderbilt Avenue. This stand was opened

in conjunction with Grand Central Partnership and they are providing dispatchers to staff the area. (Tr. p. 15)

- The Chair announced tentative dates for the next two commission meetings. The Commission expects to meet on Thursday, May 8<sup>th</sup>, 2008 and Thursday, June 12<sup>th</sup>, 2008. (Tr. pp. 15-16)
- 2. A motion was made by Commissioner Arout to adopt the minutes of the March 13, 2008 Commission meeting. The motion was seconded by Commissioner Kay, and it was passed 7-0 (Commissioners Daus, Arout, Giannoulis, Gonzales, Kay, Polanco, and Vargas). (Tr. p. 16)

Commissioner Arout made a motion to extend the pilot project. Commissioner Kay seconded the motion, and it passed 6-0 (Commissioners Daus, Arout, Giannoulis, Gonzales, Kay, and Polanco). - Commissioner Arout made a motion to adjourn the meeting and go into executive 8. session without the Chair being present, to consider the appeal of Harold Jean-Baptiste, hack license number 435679. Commissioner Giannoulis seconded the

motion, and it passed 6-0 (Commissioners Daus, Arout, Giannoulis, Gonzales, Kay, and Polanco). (Tr. p. 123)
