Minutes of Commission Meeting

June 15, 2006

- 1. The Chair called the meeting to order and reported the following:
 - The Commissioner expressed condolences and observed a moment of silence in memory of Danielle Ricco, who was killed in a traffic accident involving a taxi, and Shiva Ranjutsingh, a livery driver killed in another accident. (Tr. pp. 3-4,7)
 - The medallion sale is in progress and will be complete by June 22, 2006. (Tr. pp. 4-7)
 - Negotiations continue to progress with other municipalities regarding reciprocity legislation. (Tr. pp.8-9)
 - There was a City Council hearing on June 14, 2006 on eleven proposed bills regarding the TLC, mainly involving hybrid and accessible vehicles. (Tr. pp.8-10)
 - The Commissioner recognized Joseph Cassius, Andre Fequiri, and Samuel Dubaton for helping to catch the recent subway stabber. (Tr. p.10-11)
 - The TLC will report on the pilot program proposals later in the summer. (Tr. p.12)
 - The next Commission meetings are scheduled for July 18, 2006, and August 10, 2006. (Tr. 12-13)

- 5. Commissioner Weinshall made a motion to approve all of the base station license applications that were recommended for approval. Commissioner Sander seconded the motion, and it passed unanimously. (Tr. p. 29)
- 6. The Chair asked the Licensing Division to follow up with the following base stations to ensure that they are adhering to their business plans: Bloomingdale Car Service, Blue Diamond Car Service, Castle Car Service, D&J Service Inc. doing business as Citicar Private Car Service, Eastern LPB Inc., Ecuadoor Corp., Ecua Line Corp. doing business as New Eastern Car & Limo Service, Ecua Mex Incorporated doing business as Cancun Express C&L, GTWY Inc. doing business as Gateway Car & Limo, Hollywood Radio Dispatch Inc., Metropolitan Multiplex Car Service Corp., New Family Radio Dispatcher Inc., New York 88 Express Corp, Promenade Car Leasing Inc., Puebla Express Corp. d/b/a Poblana C&L, RPDW doing business as New Richmond Car Service, Shaheeda Corp. doing business as Jamaica Express #2 Car Service, St. George Express Car Service Inc., Tov Too Transportation Inc., High Class Bronx Limo & Car Service Corp., Hunts Point CS Corp. doing business as Redi-Eagle CS, and New Mexicana CS Inc. - 6. A public hearing was held on proposed rules allowing ownership of a taxicab medallion by a limited liability company. Commissioner Sander made a motion to adopt the rules. Commissioner Weinshall seconded the motion, and it passed unanimously. (Tr. pp. 52-54)
- Pansy Mullings, *Deputy Commissioner*, *Uniformed Services Bureau*, delivered a presentation on padlock procedures. Commissioner Vargas made a motion to approve the following language: "The Commission hereby delegates its authority to issue a written directive pursuant to Section 19-528(e) of the Administrative Code and its authority to order that premises be unsealed pursuant to Section 19-528(f) of the Administrative Code, to the Chair or his or her designee," with the a provision stating that any time the written directive is issued, the Commissioners are notified at the next meeting. Commissioner Sander seconded, and the motion passed with all votes in favor, and the Chairman abstaining. (Tr. pp. 54-74).
- 8. Commissioner Weinshall made a motion to adjourn the public portion of the meeting and go into executive session. Commissioner Vargas seconded the motion, and it passed unanimously. (Tr. p. 74)
- 9. At the executive session, the appeal of Luc Cajuste was considered. The respondent and his attorney, and the Commission's prosecuting attorney attended. By vote of 5-0, the Commission voted to modify the penalty appealed from revocation and fine to suspension for time served and a one-year probation.

The meeting was adjourned at approximately 12 p.m.
