## **Minutes of Commission Meeting**

October 15, 2015

#### Present:

- 1. Chairperson Joshi called the meeting to order at 10:20 a.m. with Commissioners Aguado, Carone, Gonzales, Jiha, Marino, and Polanco present and reported the following:
  - TLC Licensing Offices will be moving to a new facility mid-November. Forthcoming industry notices will provide details about the move and service disruptions.
  - Beginning October 26, new driver applicants will need to go online to schedule an
    appointment. The new system aims to increase efficiency and lower foot traffic at the
    Licensing Offices.
  - TLC will be rolling out a new text messaging system to notify driver applicants about any issues with their application.
- 2. Item 4 on the Agenda, Adoption of Minutes (September 17, 2015, Commission meeting). The minutes were presented for approval. A motion was made to adopt the minutes. The minutes were approved by a unanimous vote.

- 4. A motion was made to approve the base station license applications recommended for approval and deny the bases recommended for denial. The motion passed unanimously.
- 5. Item 6, Taxi Improvement Fund Rules, was presented for commission action. The rules will establish fund payments to medallion owners and drivers and a lease credit to drivers of wheelchair accessible taxis. Following a public hearing on September 17, several changes were made to the rules, namely, that vehicle owners will be required to participate in the accessible dispatch program in order to receive fund payments and that the fund payments will be made to both owners of restricted accessible medallions and owners of unrestricted medallions that are required to be hacked up as an accessible taxi. General Counsel then called for a vote on the rules, and the rules passed unanimously.
- 6. Item 7, Leasing Pilot, was presented for commission action. Jeff Roth, TLC Deputy Commissioner of Policy and External Affairs, gave a presentation on the pilot resolution, which will exempt participants from the 12-hour taxi lease requirement and allow for taxis to be leased for no more than 35% of the fare box revenue. The General Counsel called for a vote on the pilot resolution, and it passed unanimously.

7. Item 8, Alternative Technology Pilot, was presented for commission action. Jeff Garber, Policy Advisor at TLC, gave a presentation on the pilot resolution, which will allow the use of GPS-based meters in taxis and the removal of the Passenger Information Monitor (or "Taxi TV"). Commissioners Carone, Gonzales, Aguado, and Marino spoke in support of the program. The Commission first considered an amendment to the resolution, which revises the 1000 vehicle cap by limiting the number of vehicles in which a participant can pilot alternative technology at 250. The General Counsel called for a vote on the amendment, and the amendment passed unanimously. The General Counsel then called for a vote on the pilot resolution, and it passed unanimously.

8. The meeting was adjourned at approximately 10:52 a.m.
