# TLC HOSTS FIFTH ANNUAL VISION ZERO SAFETY HONOR ROLL

The New York City Taxi and Limousine Commission (TLC) today hosted its fifth annual *Vision Zero Safety Honor Roll* ceremony to celebrate the achievements of more than 400 of the city's safest TLC-licensed drivers. While drivers were at the center of this celebration of safety, the TLC also recognized the contribution of taxi fleets and for-hire vehicle bases to the City's goal of Vision Zero. Once again, the TLC also honored drivers and businesses that have made significant contributions to the TLC's Accessible Dispatch Program, which greatly expanded its service area to encompass citywide pickups this year. The agency also recognized drivers that have placed customer service at the forefront of their work.

"Today we honor the men and women who are the model of road safety every day transporting thousands of passengers while navigating New York City's infamous traffic and congestion," said Commissioner Meera Joshi. "They are heroes to all of us who use our streets whether walking, driving, riding a bike or as a passenger. We are here to celebrate their admirable work and ask that everyone join us in thanking these drivers for making our city safer every day."

## 2018 Honor Roll: By The Numbers

Who they are: TLC Safety Honor Roll drivers are full-time drivers who have had <u>no</u> crashes whatsoever involving fatality or injury, <u>no</u> traffic violations, and <u>no</u> violations of TLC safety-related rules for four or more years.

- > 269 drive yellow taxis
- > 37 drive green taxis
- > 152 drive For-Hire Vehicles (black car, livery car, or luxury limousine)
- > 29 drive commuter vans
- Six drivers have consecutively made the Honor Roll since 2014
- > Drivers from **all five boroughs** are represented:
  - o 46% are from Queens
  - 24% are from Brooklyn
  - 7% are from Manhattan
  - o 15% are from the Bronx
  - 3% are from Staten Island.

## 2018 Accessibility Leaders

This segment of honorees acknowledges exemplary participation in the TLC's Accessible Dispatch Program, which dispatches wheelchairaccessible yellow or green taxis to passengers throughout New York City by app, web or by phone.

- The highest number of Accessible Dispatch trips provided by an honoree was 356 trips between September 2017 and August 2018.
- Accessibility Leaders have averaged more than 200 accessible trips each since the Accessible Dispatch program's citywide expansion in 2017.
- Four drivers Luis H. Alvarez, Kwabena Oppong, Bassirou Fall, and Kyaw Thu Ya have been honored for two consecutive years for their consistently high number of Accessible Dispatch trips.
  - > From what boroughs do our Accessibility Leaders hail?
    - o 33% live in Manhattan
    - 19% live in the Bronx
    - 14% live in Brooklyn
    - 14% live in Queens
    - 19% live outside New York City.

#### Safest Fleets, Bases & Van Companies:

#### This year's honorees include:

- Five yellow taxi fleets
- 17 community car service (Livery) bases
- Five commuter van authorities (companies)
- > Each type of For-Hire Vehicle base is represented:
  - Six Luxury Limousine
  - Three Black Car
  - Eight Livery bases

**All** of our Base and Commuter Van honorees had **ZERO** crashes involving their affiliated vehicles in the past year.

 Like leadership, safety flows from the top, and we are pleased to honor *two* businesses this year – Ann Service Corp. and Eight Star, Inc. – both of which have been on the TLC's Vision Zero Safety Honor Roll for *two consecutive years*.

# • Today's Fleet, Base & Van Company honorees are spread among the city's boroughs:

- Six bases are located in Manhattan
- Eight are located in Queens
- Five are located in Brooklyn
- One is located in the Bronx
- The remaining five are located outside the five boroughs

#### **Customer and Civic Service**

Today's ceremony includes four honorees include two that exemplified outstanding service to their passengers, and two that will be receiving mayoral citations for their aid in criminal investigations.

**Thierno Diakhate** helped the NYPD nab a passenger in his taxi who had just robbed a Chase Bank branch on Sixth Avenue in Manhattan in July 2018.

**Michael Morgan** assisted the NYPD in catching a "mailbox fisher" who had been *undelivering* the mail from a mailbox on the Upper East Side in March 2018.

#### About Vision Zero

Mayor Bill de Blasio launched the Vision Zero Action Plan in 2014, a comprehensive strategy designed to move the city closer to ending traffic fatalities. As one of three lead agencies – along with the NYPD and Department of Transportation -- charged with the achievement of this paramount goal, the TLC has implemented many different safety-focused initiatives, of which the annual recognition of the safest TLC-licensed drivers on the road, as well as the businesses at the forefront of sharing Vision Zero's message, is one.
