

# Renewal Instructions and Checklist

#### Dear Business Owners:

All license renewal requirements must be submitted by the expiration date of the license. If all requirements are not met by the expiration date, the license renewal will be denied.

If there are any changes to the **Business premises, Ownership and/or Business Name** then a change of application must be submitted to reflect such changes. Click <a href="here">here</a> for applications.

### NOTE:

## **Renewal Payment and Documents Submission Instructions**

- 1. **ON-LINE Payment:** Make renewal payment on https://www1.nyc.gov/lars/
  - \$1,500.00 renewal fee for a 3-year FHV Bases and Para-Transit license Authority
  - \$550 renewal fee for a 2-year Commuter Van (VN) license Authority
  - SHL Endorsement Renewal Application must be submitted via email to: <u>businessmr@tlc.nyc.gov</u>
     \$3,000.00 additional for a 3-year SHL-Endorsed renewal fee, <u>in person</u> by appointment **only**. We will review the application and coordinate an appointment date.
