A meeting of the Board of Directors (the "Board") of the New York City Transitional Finance Authority (the "Authority") was held on September 12, 2016 at approximately 11:35 a.m. at 255 Greenwich Street, Room 6M4, New York, New York.

Melissa Mark-Viverito, Speaker of the City Council, represented by Raymond Majewski,

constituting a quorum of the Board. Loran Radovicka served as secretary of the meeting.

Also in attendance were members of the public, officers of the Authority, and employees of various agencies of the City. Krystelle Carroll, the representative for Feniosky Peña-Mora, Commissioner of the Department of Design and Construction of the City, was unable to attend the roll call.

The meeting was called to order by Mr. Anders.

#### Approval of Minutes

The first item on the agenda was the approval of the minutes of the meeting of the Board of Directors which occurred on July 11, 2016. Mr. Anders noted that the Finance Committee of the Authority had recommended approval of the Ninety-First Series Resolution (a copy of which is attached hereto) by the Board. A motion was made and seconded to consider approval of the Ninety-First Series Resolution. There being no objections, the Ninety-First Series Resolution was approved.

**WHEREAS**, the Finance Committee has received and reviewed 91<sup>st</sup> Series Resolution Authorizing the Issuance of Fiscal 2017 Series B Future Tax-Secured Bonds; it is therefore

**RESOLVED**, that the Board approved the reviewed 91<sup>st</sup> Series Resolution Authorizing the Issuance of Fiscal 2017 Series B Future Tax-Secured Bonds.
