## NEW YORK CITY TRANSITIONAL FINANCE AUTHORITY ANNOUNCES DETAILS OF ITS UPCOMING SALE OF \$1.3 BILLION FUTURE TAX SECURED SUBORDINATE BONDS

The New York City Transitional Finance Authority ("TFA") announced today the details of its upcoming sale of approximately \$1.3 billion future tax secured subordinate bonds, comprised of \$1.1 billion of tax-exempt fixed rate bonds and \$173 million of taxable fixed rate bonds. Proceeds from the sale will be used to fund capital projects and convert certain floating rate debt to fixed rate debt.

Subject to market conditions, the pricing for the tax-exempt fixed rate bonds will take place on Tuesday, September 15, 2020, via negotiated sale through TFA's underwriting syndicate led by book-running lead manager Jefferies, with BofA Securities, Citigroup, J.P. Morgan, Loop Capital Markets, Ramirez & Co., Inc., RBC Capital Markets, Siebert Williams Shank & Co., L.L.C. and Wells Fargo Securities serving as co-senior managers.

Individual investors will have priority in placing orders for the tax-exempt bonds during a one-day retail order period on Monday, September 14, 2020.

Also on Tuesday, September 15, 2020, TFA intends to sell approximately \$173 million of taxable fixed rate bonds via competitive bid.
