WE EXPECT TO ISSUE APPROXIMATELY 1.073 BILLION OF NEW MONEY BONDS BUT HAVE BUILT IN A CUSHION TO ACCOMMODATE FLUCTUATING MARKET CONDITIONS. THE EXPECTED BREAKOUT OF THE SUBSERIES IS AS FOLLOWS: FISCAL 2021 SERIES B1 HAS A TOTAL EXPECTED ISSUANCE OF 900 MILLION FIXED RATE TAX-EXEMPT NEW MONEY BONDS. THE LEAD UNDERWRITER IS JEFFERIES. THE EXPECTED T.I.C. IS 2.89% WITH A NOT TO EXCEED T.I.C. OF 3.89%. FISCAL 2021 C2 IS, IT WILL BE AN ACCEPTED ISSUANCE OF APPROXIMATELY OF 173 MILLION OF FIXED RATE TAXABLE NEW MONEY BONDS. AND THE ISSUE WILL BE COMPETITIVELY BID. ADDITIONALLY, THE AUTHORITY EXPECTS TO REOFFER ITS OUTSTANDING VARIABLE-RATE FISCAL 2003 A2 AND A3 AND FISCAL 2003 C2 AND C3 AND FISCAL 2001 SERIES 1 AND SERIES 2 BONDS. AND THESE BONDS WILL ALSO BE COMPETITIVELY BID. THE EXPECTED INSTITUTIONAL PRICING AND BID ARE BOTH SET FOR SEPTEMBER 15, 2020. THE EXPECTED CLOSING DATE WILL BE SEPTEMBER 24, 2020. AND THE AUTHORITY STAFF FEEL SHE IS HIGHLY QUALIFIED TO TAKE ON THE ROLE OF ASSISTANT TREASURER. AS WE ALL KNOW IN MAY, WE LOST OUR EXECUTIVE DIRECTOR. AND ALL OF US HAVE BEEN PICKING UP ADDITIONAL RESPONSIBILITY AND SLACK IN HIS ABSENCE. AND I THINK THIS IS ADEQUATE—YOU KNOW, NOT ADEQUATE, BUT THE LEAST WE COULD DO TO RECOGNIZE THESE INDIVIDUALS' CONTRIBUTIONS THUS FAR AND PROSPECTIVELY. MS. TARBOX'S AND MS.
