RESOLUTION WHICH WOULD RECOMMEND THE BOARD OF DIRECTORS APPROVE THE 113th SERIES RESOLUTION AUTHORIZING THE ISSUANCE OF UP TO ONE BILLION OF FISCAL 2021 SERIES E FUTURE TAX-SECURED BONDS. WE EXPECT TO ISSUE APPROXIMATELY 900 MILLION OF NEW MONEY BONDS IN TOTAL WITH A BUILT-IN CUSHION TO ACCOMMODATE FLUCTUATING MARKET CONDITIONS. THE EXPECTED BREAKDOWN OF THE SUB SERIES IS AS FOLLOWS. THE FISCAL 2021 D1, AGAIN, TOTAL EXPECTED ISSUANCE IS ABOUT 700 MILLION OF TAX-EXEMPT, FIXED-RATE NEW MONEY,, AND RAMIREZ IS THE LEAD UNDERWRITER AND THE EXPECTED TRUE INTEREST COST IS 3.16%. THE RESOLUTION WILL AUTHORIZE AND NOT-TO-EXCEED TRUE INTEREST COST OF 4.66%. THE NEXT SUBSERIES...SERIES D2 WITH AN EXPECTED ISSUANCE OF APPROXIMATELY 112 MILLION OF TAXABLE, FIXED-RATE NEW MONEY. THESE BONDS WILL BE SOLD VIA COMPETITIVE BIDDING. THE EXPECTED T. I.C. IS 1.68% WITH A NOT-TO-EXCEED AUTHORIZED TRUE INTEREST COST OF 3.18%. THE FISCAL 2021 SERIES D3 IS APPROXIMATELY 88 MILLION OF, AGAIN, TAXABLE, FIXED-RATE NEW MONEY BONDS. THESE WILL ALSO BE COMPETITIVELY BID, AND THE EXPECTED T.I.C. IS 2.10% WITH A NOT-TO-EXCEED T.I.C. OF 3.6%. THE EXPECTING PRICING AND BID DATE IS OCTOBER 28. 2020. AND THE EXPECTED CLOSING DATE IS NOVEMBER 5. 2020.
