THE NEXT ITEM ON THE AGENDA IS A RESOLUTION WHICH WOULD RECOMMEND THE BOARD OF DIRECTORS APPROVE THE 125TH SERIES RESOLUTION AUTHORIZING THE ISSUANCE OF UP TO 1.6 BILLION OF FISCAL 23 SERIES D FUTURE TAX-SECURED BONDS. WE EXPECT TO ISSUE APPROXIMATELY 1.3 BILLION OF FIXED-RATE REFUNDING BONDS IN TOTAL, BUT HAVE BUILT IN A CUSHION TO ACCOMMODATE FLUCTUATING MARKET CONDITIONS. THE EXPECTED BREAKOUT OF THE SUBSERIES IS AS FOLLOWS: FISCAL 2023 SERIES D-1, THE EXPECTED ISSUANCE IS APPROXIMATELY 950 MILLION OF TAX-EXEMPT NEW-MONEY BONDS, THE LEAD UNDERWRITER IS WELLS FARGO, THE EXPECTED T.I.C. IS 4.75%, WITH A NOT-TO-EXCEED 6%. FISCAL 2023 SERIES D-2, THE EXPECTED ISSUANCE IS APPROXIMATELY 210 MILLION OF TAXABLE NEW-MONEY BONDS, THE EXPECTED T.I.C. IS 5.55% WITH A NOT-TO-EXCEED T.I.C. OF 7%, AND THIS WILL BE COMPETITIVELY BID. FOR FISCAL 2023 SERIES D-3, THE EXPECTED ISSUANCE AMOUNT IS APPROXIMATELY 140 MILLION OF TAXABLE NEW-MONEY BONDS, THE EXPECTED T.I.C. IS 5.9% WITH A NOT-TO-EXCEED T.I.C. OF 7%, AND THIS WILL ALSO BE COMPETITIVELY BID. THE EXPECTED INSTITUTIONAL PRICING AND THE BID DATE IS OCTOBER 26, 2022. THE EXPECTED CLOSING DATE IS NOVEMBER 3, 2022. THE RESOLUTION AUTHOR ALSO AUTHORIZES AN AMENDMENT TO THE INDENTURE TO CONFORM THE DEFINITION OF PERSONAL INCOME TAXES TO THE TFA ACT, WHICH WAS RECENTLY AMENDED TO ADD REFERENCE TO THE PASS-THROUGH ENTITY TAX OF THE TAX LAW. CONCURRENT WITH THE ISSUE OF THE 2023 D BONDS, THE AUTHORITY WILL ALSO BE RE-OFFERING ITS VARIABLE-RATE FISCAL 1999 SERIES A-1 BONDS AS FIXED-RATE SUBORDINATE BONDS. THE LAW DEPARTMENT RECENTLY ADVISED TFA TO, PURSUANT TO AMENDMENTS TO THE OPEN MEETINGS LAW, FULLY REMOTE MEETINGS WOULD BE ALLOWED SO LONG AS A STATE OF EMERGENCY IN THE CITY IS IN EFFECT AND THE TFA DETERMINES THAT THE CAUSE OF THE STATE OF EMERGENCY IMPACTS OR AFFECTS THE ABILITY OF THE BOARD OR THE COMMITTEES TO MEET IN PERSON. AS A STATE OF EMERGENCY RELATED TO COVID-19 REMAINS IN EFFECT IN THE CITY, AND COVID-19 CASES ARE RISING, TFA MANAGEMENT PROPOSES THE BOARD APPROVE A RESOLUTION WHICH WOULD ALLOW SUCH REMOTE MEETINGS. SUCH REMOTE MEETINGS WOULD REMAIN AUTHORIZED SO LONG AS THE STATE OF EMERGENCY BY THE MAYOR REMAINS IN EFFECT. ARE THERE ANY QUESTIONS? HEARING NONE, I'LL CALL THE ROLL FOR A VOTE. MR.
