Tony Bennett's World War II Experience Was a 'Front-Row Seat in Hell'

Singer Tony Bennett's stint in the U.S. <u>Army</u> during World War II led him to legendary entertainer Bob Hope, which inspired him to pursue a career spanning more than seven decades. Only after he announced he was suffering from Alzheimer's disease in 2021 did the crooner retire from performing live shows.

He continued to rehearse his repertoire, however, and broke the Guinness World Record for the oldest person to release an album of new material, at age 95. It was just one more honor earned by a man who spent a lifetime receiving awards and accolades for his work. Bennett died on July 21, 2023, two weeks shy of his 97th birthday.

His experience in World War II not only shaped the rest of his life, it put infantry rifleman Anthony Dominick Benedetto in the spotlight as a member of Special Services, singing for the Allied troops in the trenches, sometimes literally.

"The main thing I got out of my military experience was the realization that I am completely opposed to war," Bennett wrote in his 1998 autobiography, "The Good Life." "Although I understand why this war was fought, it was a terrifying, demoralizing experience for me... life can never be the same once you've been through combat."

From the age of 15, young Tony watched as his friends and relatives were drafted into service. Bennett turned 18 in the summer of 1944, and that November, he received a draft notice of his own. He was sent to the Army, completed basic training at Fort Dix, New Jersey, and became an infantry rifleman at Fort Robinson, Arkansas. [READ MORE]

The Afghan Adjustment Act of 2023: Everything You Need to Know



IMMIGRATION IMPACT Posted by <u>Dara Lind</u> | Jul 18, 2023 | <u>Benefits & Relief</u> Bipartisan groups of lawmakers in both the House of Representatives and the Senate reintroduced the <u>Afghan Adjustment Act</u> (AAA) last week. The bill, similar to a version introduced in the last Congress, would fix a problem that will only get more urgent: tens of thousands of Afghans who were evacuated or fled to the United States (or were stranded here) when the U.S. military withdrew from Afghanistan and the Taliban retook control in 2021 have no viable way to apply for permanent legal status in the U.S., leaving them in limbo.

The Biden administration is already conducting a second round of two-year grants of "<u>humanitarian parole</u>" for Afghan evacuees. But while humanitarian parole allows someone to temporarily live and work legally in the United States, it doesn't let them apply for a green card or any permanent status. Furthermore, like any discretionary immigration program, parole is subject to continued executive approval and could be eliminated by a future president – or struck down in court.

Right now, Afghan evacuees are faced with a patchwork of immigration options. Over 17,000 Afghans have filed asylum applications. While <u>hardly any of those</u> <u>applications have been denied</u>, it's not a guarantee for every evacuee. Fleeing a war isn't enough to qualify for asylum in the United States. And evacuees who haven't already filed an asylum application could be ineligible due to the one-year deadline for filing an asylum application, though U.S. Citizenship and Immigration Services has indicated it <u>will accept late asylum applications from certain</u> <u>parolees</u>.
