

**A RESOLUTION OF THE EXECUTIVE COMMITTEE OF THE NEW YORK CITY WORKFORCE
DEVELOPMENT BOARD AMENDING THE TIERED PRICING POLICY FOR
INDIVIDUAL TRAINING GRANTS**

September 10, 2024

WHEREAS, the Workforce Innovation and Opportunity Act (Sec. 680.310) provides Local Workforce Development Boards the authority to limit the maximum amount available through Individual Training Accounts, which the New York City Workforce Development Board locally calls “Individual Training Grants;”

WHEREAS, in 2008, the former Policy Committee approved a tiered pricing policy¹ to apply to the maximum amount of Individual Training Grants; and

WHEREAS, in 2009 the Policy Committee approved a separate pricing structure for Security Guard training programs² to reflect their unique market value and anticipated outcomes; and

WHEREAS, in 2013 the Policy Committee updated the maximum amount available³ for Individual Training Grants;

WHEREAS, the Mayor’s Office of Talent and Workforce Development and the NYC Department of Small Business Services have conducted market research and determined that the current tiered pricing structure pays well below market rate for certain types of training;
