Approval of Minutes

Chairman's Report

Ms. Kearns welcomed the Board. She began the meeting by announcing the appointment of two new board members and noted that their biographies were located in the board book. These members are:

NYC Office of Human Capital Development

Next, Ms. Kearns introduced Nnenna Lynch, Senior Policy Advisor of the Office of the Mayor who gave updates on the NYC Office of Human Capital Development (OHCD) and the

Executive Director interview process. The office is a merger between the NYC Workforce Investment Board (WIB) and the Mayor's Office of Adult Education (MOAE), in the Office of the Mayor.

Overview of Adult Education

Following the update on the new office, the Board received a presentation for discussion from Tara Colton of OHCD. She provided an overview of the changes in the GED exam and the shifting role of the Mayor's Office of Adult Education, which was established to a) create better outcomes for the City's adult education system, b) coordinate strategy among City agencies and other providers delivering adult education services, and c) in partnership with the City's providers, promote a state-of-the-art adult education system that serves more people with greater results.

Next, Ms. Kearns facilitated a discussion between the speaker and the members

Next, Ms. Kamath from SBS offered a summary of the request for proposals process for the Workforce1 Career Centers, detailing the timeline and process for the five competitions, as well as the rating criteria and overall goals for the solicitation.

Summer Youth Employment Update / Ladders for Leaders

Next, Suzanne Lynne, Deputy Commissioner of the NYC Department of Youth and Community Development (DYCD), gave the members a brief update on the Summer Youth Employment Program (SYEP). She thanked the member organizations for signing on and donating to the program.

Scholars at Work Update

Finally, to wrap up the agenda, Ms. Kearns introduced Kelly Richardson, Senior Advisor of SBS who gave an update about the Scholars at Work Program, describing how the program has evolved over the years. She added that the project partners—SBS, Center for Economic Opportunity, and the New York City Department of Education—were proud of their CTE students and thanked WIB member Scott Berger for hiring two students in permanent positions in his organization.
