Chairman Martin Prince began the meeting at 7:30 p.m. with the Pledge of Allegiance.

The above Community Liaisons were introduced and thanked for coming.

Mr. Prince stated that the purpose of tonight's hearing is a Uniform Land Use Review Procedure (ULURP) Hearing as follows:

IN THE MATTER of the replacement of the existing New York Public Library Branch at 2521 Glebe Avenue with new construction at 9 Westchester Square, the Westchester Square Replacement Library, under Uniform Land Use Review Procedure (ULURP) #160335PCX.

This Public Hearing has been scheduled for June 27, 2016 at 7:30 p.m. at 1200 Waters Place, Bronx, NY 10461.

Mr. Prince introduced Mr. G. Mihaltes who presented a slide show outlining the steps involved in the project. The NYPL wants to have a state of the art library to replace the one on Glebe Avenue. The design phase went before CB 10 in late 2014. Mr. J. Finegan described the ULURP process and Ms. R. Honig, Ms. T. Alston, Ms. K. Carrasco of NYPL, described the planned use of the building which will provide areas for reading, activities for all ages and will include storytelling, computer access, technology classes etc. The design is an open floor plan and will be a multi-purpose space. A survey was done by the Westchester Square Public Library and the results showed that the community wants more free public computers, wi-fi access and dedicated children's and teen spaces, which the new library will have. Additional staff will be hired as well.

The Library's height will be in keeping with the surrounding community and is very close to transportation. It will be a LEED (Leadership in Energy and Environmental Design) building. The project will begin in 2018 and is expected to be completed by 2020.

Mr. Michael Rivadenyra, on behalf of Council Member Vacca's Office thanked the presenters, NYPL staff, as well as the Board members. Council Member Vacca said the project is a very important one and will bring more to the Westchester Square neighborhood.

A question and answer session from Board members and the presenters began. There will be an elevator and the building will be ADA accessible. The costs will be approximately \$18 million for land acquisition, building, etc. Broken down, the cost for the building is approximately \$14.5 million, other costs include construction and purchase. Parking is not provided, the NYPL is not required to provide parking and the City of New York doesn't fund library parking. The site is close to public transportation and there is a parking facility nearby.

The Huntington Free Library (HFL) repairs will be a separate project; care will be taken to protect the structure of the HFL and all repairs will be done in accordance with the Landmarks Preservation Commission and that agency will be monitoring the project's progress. During construction, air quality testing will be done.

Questions unrelated to the ULURP Hearing were asked such as programming for the community, use of energy efficient glass for the windows/walls, acoustics, library hours of operation; numbers of visitors that have accessed the current library (answer = 87,000), design of building not being in line with Huntington Free Library; new library will slightly larger than the current one and the intended use of the Glebe Avenue building once the new one is operational.

Mr. Thomas Casey, Huntington Free Library President: any structure will be a complement to the Huntington Free Library. The Library project will improve the HFL and open up the garden with a community green space will bring more to the overall site.

Mr. Prince thanked the presenters.

PUBLIC PARTICIPATION SECTION:

- 1 Peter Sullivan, CB #10 Chair of Housing and Zoning: Mr. Sullivan reminded the Board members in attendance and the community that six months ago, the Board voted down the Mayor's Housing Plan along the transit hub and if this project does not go through, a developer will grab this land and this new project is the best solution for the property.
- 2 Dorothy Krynicki: lives in neighborhood and is in favor of project.
- 3 Lisa Sorin, Executive Director of the Westchester Square Business Improvement District read a statement from Ms. Sandy Lusk of the Westchester Square Zerega Improvement District, which was

in support of the project which will revitalize the area and be a great asset; Ms. Sorin said that project is a reinvestment in the community and is very much in favor; Westchester Square is a cultural corridor and will benefit from the new library.

4 – Dr. Carl Anderson, VP of Huntington Free Library: Dr. Anderson is very much in support of library as well as its design.

A floor resolution was read and voted on:

"**Resolved**...at the recommendation of Bronx Community Board #10 that the full Board approve the following Resolution: That the City of New York select and acquire the site at 9 Westchester Square for the development of a replacement branch for the existing New York Public Library Branch at 2521 Glebe Avenue, under the Uniform Land Use Review Procedure (ULURP) #160335PCX, and that this information be reported to the appropriate governmental agencies."

A motion to **accept** the floor Resolution was made by was made by Mr. Sullivan, seconded by Mr. Bieder and unanimously approved by all.

A motion to close the Public Participation Session was made by Mr. Misiurski, seconded by Mr. Talarico and unanimously approved by all.

Mr. Bieder asked for DCAS contact information for the Glebe Avenue property.

A motion to close the public hearing was made by Mr. Bieder, seconded by Mr. Accomando and unanimously approved by all.

Mr. Prince stated that the Municipal Services Committee meeting would commence and Mr. Russo began the meeting. Mr. Russo introduced Ms. Rhonda Benn Valerio, Family Worship Center, 3031 Cross Bronx Expressway, 10465 She addressed the Board with a request for a street activity permit for the aforementioned Church on Sunday, September 18, 2016. The street closure is one block in length from East Tremont to Dewey Avenues. The Family Worship Center discussed the closing of the street with the four surrounding businesses and each signed a petition that there would be no objection. Ms. Benn-Valerio answered questions from the Committee members about hours of operation of the event which will be a Health Fair as well as a Back to School event. The sponsor stated that the hours of the fair will end much earlier than 6:00 p.m. Approximate numbers of attendees will be 150-200 throughout the day. The only business to be affected is Alfie's Bar and should not interfere with the Sunday football crowd.

The following floor resolution was read:

There was a discussion about adding items to existing licenses under the "Change in Method of Operations", so that they can be added on the paper license, and the establishment would not be fined. It was brought out that even though changes were added, dancing was still not allowed, and fines would be issued if NYPD observed any such activity.

There was a discussion about starting an internship program with the area high schools and local businesses. The Committee will reach out to the schools in order to recruit students, and reach out to businesses that are willing to hire interns.

It was brought up that there are a series of stores fronting both sides of the corner at Westchester & Castle Hill Avenues that are scheduled to be demolished, with new construction planned. The owner of that property will be asked to attend the next meeting to advise the Committee of the plans for the area, and how the Board may be able to assist him.

There was a Motion to adjourn. The Motion was seconded.

We are pleased to send you the enclosed list of approved CityBench sites in the Bronx Community Board 10 district. As part of its CityBench program, the NYC Department of Transportation (NYC DOT) is conducting an analysis of bus corridors throughout New York City in search of suitable bench locations to serve bus passengers – particularly the elderly and mobility-impaired. We have evaluated the locations listed in the enclosure and determined that they are viable sites for benches, based on NYC DOT's clearance requirements.

The purpose of the three-year, federally funded CityBench program is to install benches throughout New York City to support transit use and walking, particularly for elderly and mobility-impaired New Yorkers. We therefore encourage you to identify any additional sites that would benefit from bench installations using our online form at www.nyc.gov/citybench. NYC DOT is typically installing benches on sidewalks that are at least 12 feet in width along bus routes, near senior centers, on commercial corridors, and near municipal, commercial, and recreational destinations; sidewalks must be at least 14 ft wide at bus stops. All benches are 7 ft 6 in. long and have seat dividers that prevent sleeping – please see photos of the bench on the reverse side of this letter. As City-owned property, the bench will be the responsibility of NYC DOT should any issue arise; likewise, NYC DOT will maintain the benches.
