- A. Tracy Shelton, director of KRVCDC announced an Energy Efficiency forum being held on Tuesday, June 15 at 7:30AM at Riverdale Greentree, 5693 Riverdale Avenue.
- B. Michael Gary reported on the following:
  - War veterans Herb Barret and Don Tannen were honored by Senator Espada.
  - CB8 Seniors were honored at Mother's Day events.
  - Awards were given to a group of women with the Senate "Woman of Distinction Award" for their personal and professional achievements.
  - Senator Espada held a town hall meeting in May addressing quality of life, safety, affordable housing, employment and education issues.
  - A \$25,000 grant secured by Senator Espada is funding Medicare Awareness Workshops.
  - CB8 Youth between ages 13 and 25 are encouraged to audition for a First Annual Bronx Youth Against Violence Talent Showcase and Forum on July 16<sup>th</sup>, auditions are on the 18<sup>th</sup> and 25<sup>th</sup>, 6 p.m. at the Bronx Library Center, 310 Kingsbridge Road.
  - Senator Espada has secured a \$5,000 state grant that will be used to coordinate "National Night Out" activities on Tuesday, August 3<sup>rd</sup>.
  - Senator Espada's \$10,000 grant will fund June 12<sup>th</sup> Run Against Obesity
  - There is a special Senate Proclamation for the "Celebration of Life" event sponsored by Amalgamated Park on June 15<sup>th</sup> which pays tribute to CB8 Holocaust survivors.
  - Senator Espada rent freeze bill passes June 2<sup>nd</sup> in Housing Committee

- C. Al Chapman, President, Kingsbridge Heights Neighborhood Improvement Association, addressed the Board regarding Terrace Healthcare Center proposal for an in-house methadone clinic. He reported residents feel it will have a damaging effect on the quality of life of residents and therefore should require further consideration before going forward.
- D. Kristen Hart of Fort Independence Park Neighborhood Association asked the board to postpone going forward on the proposal for an in-house and outpatient methadone clinic at the Terrace Health Care Center.
- E. Irving Ladimer announced there is a run against obesity at Van Cortlandt Parade Grounds on Saturday, June 12<sup>th</sup> at 10:00 a.m. You can register at YesTheBronx.org.
- F. Board member, Yael Levy announced the first ever Riverdale Riverfest event on Sunday, June 13 (rain date: June 20<sup>th</sup>) at College of Mount St. Vincent Campus, Marillac Lawn. She urged all to come to this event.
- 1. Approval of Regular Board Meeting Minutes of May 13<sup>th</sup>, 2010

The minutes were approved unanimously.

2. Discussion of Executive Board Committee Meeting Minutes of June 2<sup>nd</sup>, 2010

3. Chairman invited Captain del Pozo to address the Board.

Captain del Pozo announced the next meeting of the 50<sup>th</sup> Precinct Community Council will be held on June 10, 2010 at 7:30 PM. The Captain reported he has office hours every month and calls can be made to the Community Affairs Officer to arrange a meeting. Captain del Pozo reported on homicides in the district. The monthly crime statistics indicated crime was down 11% for the year; robberies were up 30% and arrests for robberies were up 52%; persons committing robberies were mostly young teens snatching iphone and cell phones.

- 4. Bronx Borough President's Office J. DeSio
  - Borough President Ruben Diaz, Jr. made the Bronx Community Board appointments and reappointments and welcomed new members, Steven Catechis, Brendan Contant, Dianne Kirksey-Floyd, Nils Graham, Colleen Hanley, Michael Heller, Thailary Lim, Amy Moore, Patricia Mullen, Robert Press and Alexandra Zizmor.
  - The Borough President joined elected officials, labor leaders and community groups at City Hall to announce the introduction of Fair Wages for New Yorkers Act which will mandate that the jobs created at projects that receive significant taxpayer subsidies must offer employees a "living wage" currently defined as \$10 with benefits, or \$11.50 per hour without benefits.
  - At the Bronx Ball the Borough President celebrated singer Jerry Vale, founder and chairman of Essence magazine Edward Lewis, Irish traditional music sensations Joanie Madden and Cherish the Ladies and the former Bronx Borough President and Congressman Herman Badillo into the Bronx Walk of Fame.

- The Chairman thanked A. P. Cassino, A. Goldman, J. Goris, B. Maybury, K. O'Brien and B. Trebach who were not reappointed to the board for their service and contributions to the community board. The Chair also thanked A. Fana and T. Feerick for their contributions. They did not reapply to the board. The Chair wanted the board to remember and acknowledge the contribution that C. Prentice made to the board. She passed away during this term.
- The Chair reported that the Borough President's office will be scheduling an orientation to the community boards for all board members at the Borough President's office in July. Responsibilities and obligations will be discussed.

- The Chair updated the new board members on which neighborhoods community board 8 represents.
- A committee sign up sheet was distributed to the board members. The Chair explained that board members are required to serve on two committees and attend all Land Use and Board meetings. All committee agendas and minutes are posted on the website.

  - The City Council is fully committed to no real estate tax increase.
  - There is concern about budget cuts to our schools.
  - There will be no cuts to senior centers.

## 10. Committee Reports

## A. Economic Development – R. Fanuzzi

- The Marble Hill and Riverdale Youthmarkets will open on July 8<sup>th</sup> from 2:00 PM to 6:00 PM. The Marble Hill Youthmarket is located at West 225<sup>th</sup> Street between Broadway and Bailey Avenue. The Riverdale Youthmarket is located at the Riverdale Neighborhood House. R. Fanuzzi thanked N. Stent for working with the city agencies and community partners including Department of Transportation helmet giveaway for the opening day at the Marble Hill location on July 8<sup>th</sup>.
- The South Riverdale Merchant's Association is now incorporated. R. Fanuzzi thanked Tracy Shelton for KRVCDC's involvement in economic development.
- The Plaza NYC program's application will be submitted next year due to time constraints this year.
- There will be a committee meeting in June to discuss how to create an Art's Sidewalk festival in South Riverdale for the fall.

#### B. Environment and Sanitation – S. Scheinbach

- S. Scheinbach thanked the nominating committee and board members for nominating him to Chair the Environment & Sanitation Committee again.
- S. Scheinbach presented the following resolution approved by the Executive Committee at the meeting held on June 2<sup>nd</sup>:

Support Senate and Assembly Bills to Establish a Moratorium on Hydraulic Fracturing and Horizontal Drilling -

**WHEREAS**, hydraulic fracturing and horizontal drilling to extract underground natural gas use huge volumes of water laced with chemicals that can potentially pollute the water supply; and

**WHEREAS**, at its June 2009 meeting, Community Board No. 8, Bronx, passed a resolution calling for the prohibition of hydraulic fracturing and horizontal gas drilling within New York State; and

**WHEREAS**, the New York State Department of Environmental Conservation has announced a decision that could allow hydraulic fracturing and horizontal gas drilling in the New York City watershed in the future; and

**WHEREAS,** the United States Environmental Protection Agency (EPA) is conducting a comprehensive study to investigate the potential adverse effect of hydraulic fracturing and horizontal gas drilling on water quality and public health; and

**WHEREAS,** there are companion bills pending in both houses of the New York State Legislature that would establish a moratorium on hydraulic fracturing and horizontal gas drilling until the EPA has released its report thereon; and

**WHEREAS,** the bills are known as Senate Bill 7592 and Assembly Bill 10490; therefore

**BE IT RESOLVED,** That Community Board No. 8, Bronx, supports Senate Bill 7592 and Assembly Bill 10490, and urges passage of these bills by the respective houses of the Legislature.

- S. Scheinbach reminded all that they should be involved in collecting illegal postings by either reporting them and/or by taking them down.
- C. Education S. Alexander reported on behalf of D. Bowden.
  - Dr. Jane Bedell from The Department of Health & Mental Health (DOHMH) spoke at the May Education Committee meeting on childhood obesity.
  - A letter from Committee Chair D. Bowden will be sent on behalf of the NYPL to keep the hours that are now in place.
  - Councilman Koppell announced the Council is working towards restoring the monies in the Education Budget. He reported that PS 24 will not be expanding their Gifted and Talented program but PS 7 will be expanding their program. There is a possibility that the Department of Education is considering the possibility of a new elementary school serving this area.
- D. Health, Hospitals and Social Services M. Khury
  - The Committee is planning a health forum and a health fair in the fall.
  - The Health, Hospitals and Social Services Committee had a special meeting on a proposal for a satellite methadone program at the Terrace Health Care Center. The purpose of the meeting was to provide information to the community about the clinic and to provide an opportunity for the surrounding community to express its views. While a resolution by the board was not necessary for OASIS to go ahead and implement the facility, it would have requested that the community be given an opportunity to have input via a community advisory board. However, the community board will not go forward with that resolution. A letter will be submitted to the regulatory agencies with the board's recommendations. C. Moerdler announced his support for the community's opposition to this program.

### E. Housing – T. Durham

On June 10<sup>th</sup> there is a hearing at City Hall at 10:00 AM. This purpose of the hearing
is to ask for an amendment to the law to inform the community board when the
Department of Homeless Services (DHS) has a transitional housing site for the

homeless in their community. Comments can be called in to Ms. Tavares at (212) 442-0140. Councilman Koppell said he feels the city should be required to notify the community of any proposed homeless site in their community.

- Sharon Frey was a guest speaker at the May meeting and reported on the BJCC Emergency Card Program Outreach to the Isolated Elderly. The program targets people who are physically unable to egress from their buildings. She came to gather ideas to help solve this problem of being denied access from property managers and landlords.
- There will be a committee meeting on Wednesday, June 16<sup>th</sup> with a speaker from DHS on the "Housing First" program.

#### F. Land Use – C. Moerdler

 C. Moerdler brought forth an annual resolution for the Land Use Committee to act on behalf of the full Board on any time sensitive applications or other matters that come before the Board over the summer while the Board is in recess. C. Moerdler made a motion for Community Board No. 8 to renew its annual resolution;

 C. Moerdler presented the following resolution seeking to address the problem that the Board of Standards and Appeals favor developers, contractors, property owners and the like and seems to ignore the recommendations of the board who try to represent the community as best possible:

**WHEREAS**, the New York City Board of Standards and Appeals ("BSA") has repeatedly demonstrated its indifference to the views of the community and its concerns respecting the character of its neighborhoods, notwithstanding the command of Section 72-21 of the Zoning Resolution that such be a vital factor; and

**WHEREAS**, the overwhelming majority of the Members of the BSA are drawn exclusively from professions that are dependant for their livelihoods upon the development, construction and related industries and, upon termination of their public service, frequently return to those sectors; and

**WHEREAS**, the decisions of the BSA have with increasing frequency been decidedly tilted against communities and in favor of development, construction and related industries;

**NOW BE IT RESOLVED**, that the Land Use Committee of Community Board No. 8 Bronx urges and requests the NYC Charter Revision Commission to:

Abolish the existing BSA and reconstitute the BSA and revise its membership, including the following:

- Not less than one member of the BSA, including any expanded membership, shall be a bona fide resident of each county comprising the City of New York and that in making such appointments the Mayor shall solicit and consider the recommendations of the respective Borough Presidents;
- A majority of the members of the BSA shall be persons who have not in the one

   (1) year prior to appointment engaged in any employment by or have received income from any industry or profession whose activities and interests shall be subject to the jurisdiction of the BSA, including, architects, engineers and real property owners, managers and brokers;
- 3. The term of office of members of the BSA shall be staggered for one (1) year terms, upon the completion of which such person shall be barred for one year from employment by or the receipt of earned income from any industry or profession whose activities and interests shall be subject to the jurisdiction of the BSA, including architects, engineers and real property owners, managers and brokers.

- I. Parks and Recreation B. Bender
  - The following resolution was presented:

WHEREAS, the Croton Filtration Monitoring Committee (CFMC) was created by The Council of the City of New York in Resolution No. 933 specifically to advise the Department of Environmental Protection (DEP) on all aspects of the design and construction of the filtration plant and all mitigation measures set forth in the Final Environmental Impact Statement (FEIS) and this Resolution;

**WHEREAS**, this same resolution called upon the Department of Parks & Recreation (DPR) to undertake a feasibility study on a pedestrian footbridge, crossing the Major Deegan Expressway linking the east and west portions of Van Cortlandt Park (VCP);

WHEREAS, the Final Report of the Van Cortlandt Park Pedestrian Bridge Feasibility Study was presented to the CFMC by the DEP and DPR at its April meeting, reflecting that such a pedestrian footbridge is "technically, legally and financially feasible:"

**WHEREAS**, the City Council Resolution No. 993 requires that if such conditions are met, the Mayor shall introduce the necessary budget provisions to the City Council to transfer sufficient funds from DEP to DPR to design and build the pedestrian footbridge;

**WHEREAS**, the CFMC has received letters from civic groups, community boards and concerned individuals within the community endorsing the design and construction of a pedestrian footbridge within VCP over the Major Deegan Expressway;

WHEREAS, that Bronx Community Board No. 8 asks the Mayor of the City of New York to immediately introduce the necessary budget provisions in the City Council to transfer funds from the DEP to the DPR in order for the DPR to design and construct a pedestrian footbridge within VCP across the Major Deegan Expressway as outlined in the Feasibility Study presented to the CFMC;

**AND FURTHER, BE IT RESOLVED,** that the funds used to design and construct the pedestrian footbridge shall explicitly not reduce or draw from the \$243 million already committed to improving VCP and developing and improving parkland throughout the Bronx, pursuant to the Statement of Findings for the Siting of the Croton Water Treatment Plant.
