EMPLOYER RESPONSIBILITIES: Required equipment for commercial bicyclists

Your employer must provide you with the following:











A bicycle helmet in good condition









Joe's 001

A unique 3-digit ID number











Retroreflective upper body apparel with the business' name and your unique 3-digit ID number on the back in lettering at least 1 inch high.










A business ID card to carry whenever you are riding on behalf of the business. It must include:



- Business name, address and phone number
- Your name, photo and
 3-digit ID number

2 EMPLOYER RESPONSIBILITIES: Required equipment for commercial bicycles

Your employer must provide the following equipment for each commercial bicycle:













A bell or other device capable of giving an audible signal (not a siren or whistle)













White headlight and red taillight













Reflex Reflectors













Brakes













Metal or plastic sign in good condition at least 3 inches by 5 inches with the business' name and a unique bicycle ID number for each bicycle in lettering at least 1 inch high.

The sign must be affixed to the rear or both sides of the bicycle.

YOUR RESPONSIBILITIES: Traffic Laws and Rules

You must obey all traffic laws and rules, including:























Yield to pedestrians























Ride in the direction of traffic























Stop at all red lights and stop signs























Stay off the sidewalk























Use a white headlight and red taillight at night























Wear a helmet























Use a bell to signal presence























Do not wear more than one earphone while riding






















Signal when turning























When riding on behalf of the business, commercial bicyclists must carry an ID card and must operate a bicycle that has a bicycle ID sign.

Follow these tips for safe cycling:













Don't Ride Distracted
Talking on the phone
while riding is
dangerous and
distracting.













Be Extra Cautious In Bad Weather

It's more difficult to see the road and other road users in the rain and snow.

Look out for sewer grates, metal plates and utility access covers which become slippery when wet and covered with snow.

Turn on your lights to stay visible to pedestrians, cars and trucks.









Stay Alert For Car Doors Opening Avoid getting "doored" by riding at least three feet away from parked cars.















Avoid the Blind Spot
Trucks have very large
blind spots. Leave extra
room when riding near
them.















Be Predictable

Don't weave in and out of traffic. Don't change lanes abruptly and keep at least one hand on the handlebars at all times.
