
# Background



#### **PROJECT BACKGROUND**

- 2009: concrete pedestrian islands, painted curb extensions and bike lanes installed
- 2017: the Prospect Park entrance closed to public vehicles
- 2018: park road entrances converted to shared space
- 2019: signal timing throughout the neighborhood optimized
- 2021: protected bike lanes scheduled to be installed along Fort Hamilton Pkwy and Parkside Ave
- Recent requests from FDNY and community for improved traffic flow



- Lack of clarity regarding which lane leads to exits
- Vehicles are required to merge into outside lanes in order to exit
  - Can lead to sideswipe collisions




PARK CIRCLE

- Lack of clarity regarding which lane leads to exits
- Vehicles are required to merge into outside lanes to exit
- Vehicles often make multi-lane merges from underused inner lanes
  - Leads to exiting vehicles blocking other movements




#### PROPOSED



#### PROPOSED


- All lanes lead to an eventual exit

- Qwick Kurb near major exits prevent vehicles from performing multi-lane merges






### **QUEUING PATTERNS**

#### Number of queuing vehicles are the same in both queuing patterns




### **MERGING PATTERNS**

#### EXISTING: 3 merges



#### PROPOSED: 0 merges



### SUMMARY

- Shift lanes throughout the circle towards exits
- Install buffers between lanes around circle and lanes exiting to Parkside Ave and Ocean Pkwy
- Install additional signage to guide vehicles



# **BENEFITS**

- Simpler, safer vehicular movements
- Reduce weaving for vehicles exiting the circle
- Improve vehicular operation


