- 1. Petitioner convenants that the revocable consent, if granted, will be for the private use of the petitioner.
- 2. Petitioner warrants that all taxes, fees, levies, fines and other monies due to the City of New York have been fully paid.
- 3. Petitioner agrees to pay, within 30 days of its receipt, an invoice for advertising fees for two notices in each of two newspapers to inform the public of the hearing on agreement terms. Hearing are held pursuant to section 371 of the City Charter.
- 4. Petitioner agrees to execute (sign) the revocable consent agreement and return it to the Department within 15 days of its receipt. Failure to do so may result in denial of consent.
- 5. Petitioner acknowledges that the final agreement will include provisions for yearly compensation to the City, maintenance of a security deposit and filing of proper insurance documents. Petitioner agrees to submit payment of security deposit and a certificate of insurance within 30 days of notification by the Department that such items are due
- 6. Petitioner agrees to pay the <u>filing fee</u> according to the revocable consent rules (section 7-08). Note: The filing fee shall be non-refundable.
