2.1 PA/ID 1-2020

The FDNY Learning Management System (LMS) is now available for use by all employees of the FDNY. The LMS, also called Sumtotal, has online training that can be accessed from any computer 24 hours a day and 7 days a week. There are over 5000 online training classes available to all employees of the FDNY. Please read the Learning Management System Policy, PA/ID 1-2020, to understand restrictions and guidelines for its use.

Accessing the Learning Management System can be accomplished by:

- 1. From the FDNY Intranet go to the Applications dropdown; select Learning Management System (LMS).
- 2. Or by typing the following URL into the address bar: https://fdny.sumtotal.host

Initial Login: Your login is your seven-digit employee reference number and your initial password is FDNYLMS1 (case sensitive). Upon your initial login, you will be prompted to create a new password and answer several security questions for your account. Once you have reset your password, you can access training classes.

2.2 REGULATIONS

Regulations, Chapter 17 titled *Leaves of Absence* dated January 1, 1997, is **amended** as follows:

Under Section 17.4.1 Delete: 1st paragraph Insert: New 1st & 2nd paragraphs, to read:

Deputy Chiefs shall, when notified of a serious illness of a spouse, registered domestic partner, child (biological, adopted, or in loco parentis), including the birth of the child, parent (step, foster or natural), brother or sister of a member, grant an emergency leave to member. Deputy Chief granting such leave shall complete and forward form BP-603.

Domestic Partner: Two people, both of whom are 18 years of age or older and neither of whom is married, who have shared responsibilities, who have lived together for one year or more on a continuous basis at the time of registration, and who have registered as domestic partners and have not terminated the registration
