Designed by A. W. Tillinghast, PCC measures 6726 yards from the longest tees and has a slope rating of 132 and a 72.5 USGA rating. The course features 3 sets of tees for different skill levels.

Formerly Dellwood Country Club, PCC is a private country club that provides exceptional services and facilities with family-oriented social activities. Located a mere 35 minutes from Manhattan, this 200 acre premiere club contains picturesque views featuring magnificent backdrops of rolling hills, breathtaking woodland scenery, majestic emerald green fairways and beautifully manicured greens.

The day of golf kicks off with registration at 9 a.m. followed at 10 a.m. by brunch/lunch. At noon, shot gun start will begin the play. The VIP reception follows the conclusion of play featuring dinner and awards ceremony and a live auction.

Entry fees starts at \$1,000 that includes greens fees, cart fees, locker, practice range, registration gift bag, brunch, and refreshments during outing, VIP cocktail reception and dinner.
