Sites that are of concern:

Bike Sharing Stations - 121 Street and Lenox Avenue, Harlem

- Strongly oppose the bike station on 121st street on the west side of Lenox.
- The placement 80 feet in from Lenox on a quiet, landmarked side street
- School / Student Safety – **Proximity of the Bike Station to the School** with multiple elementary schools on the block
- Three Handicapped / disabled people at 101 west 121st Street.
- Side street - not contextual
- **The Historic Value of 121 Street and the Mount Morris Park District**
- Perhaps it would fit better by the 116th street or 125th street subway station.

Whole Foods

Important timeline

- Whole foods will begin making deliveries June/ July
- Response from CB10 for the sign requested on 124th street needed between May /June.
- How long will you need to create your regulation? **NYCDOT**
- Whole Foods must provide coordinated delivery schedules that include the block businesses

Meeting: April 25, 2016

Attendees: Reverend William Wilkins and CB10 Chair of Transportation

Location: Greater Refuge Temple

- 130 -136 West 124th street Harlem Neighborhood Charter (middle of block elementary school)
- Charter Schools on Lenox and 124th

Discussion summary: Board members are aware that Whole Foods will need access to the block

Request: NO DELIVERIES ON SUNDAY before 6pm

- Services all day from 9am to 6pm
- Asking for no delivery traffic on Sundays **UNTIL AFTER 6PM**
- Morning Services Starts at 9am goes to 230pm
- Evening Service starts 4pm ends 6pm
- Limited Parking lot availability on 124th with only 100 parking spots
- The church congregation is between 1500 to 2000 persons on any given Sunday.
- Double parking on Sundays is permissible only up until 130pm on Adam Clayton Powell Blvd. between 124th -123rd streets

During the school week: Whole Foods can access the street from 9am - 3:30pm

School peak periods during the week

- School doors open at 6am
- Autistic children delivered by school buses between 730 am to 9am in morning
- Teachers and school personnel arrive at 7am

- 8am official start of day
- By 430 charter school time ends 3:30-4:30 in the evenings students are dismissed.
- Beginning of after school program until 530pm
- Evening church services from 6- 9pm

The leadership of the Great Refuge Temple is requesting to meet with and organize a formal introduction to the congregation and church.

Follow-ups: Presenters to return with requested items.

- Provide the loading schedules that includes the trucks from all of the tenants of the building and are not in conflict with deliveries made by the CBO's hours of activity of the block.
- Provide a majority listing of pick ups and drop offs times
- A schedule would be a step to provide assurances to residents of what to expect.
- Provide traffic counts (at later date)
- If loading bay is full how long can we expect a truck to be on the block waiting their turn to go into the loading bay (should not be an issue if adhering to a schedule).
- Visualization tools including some photographs. (received)
- Assessment after 6 months. September 2016.
- Request for all trucks to be equipped with crossover mirrors

Harlem Shake

- Agree with dedicated school crossing zone
- Truck retrofits are also needed
- Suggest truck delivery times as early morning after school starts (6AM to 11AM) and nights after school ends
- Request consideration to limit a NO STANDING sign to the middle of the same block, thus enabling us to continue truck loading for restaurant deliveries form 6 AM to 11 AM.
- Request a bicycle rack directly in front of the restaurant on the southwest corner of Lenox Avenue and 124th St
