GENERAL BOARD MINUTES WEDNESDAY, OCTOBER 6, 2010, 6:30 pm

Chair, Franc Perry, announced rules and order of the meeting. Community Board 10 called the meeting to order at6:17 p.m.

Chairman Franc Perry gave a description of the role of a **community board**.

Crystal McKay, reviewed appropriate behavior and protocol for community board meetings.

<u>Community First</u> – Henrietta Lyle, Vice Chair, opened the Community First segment of the meeting. She then called upon:

Maurice Cummings of Assemblyman Keith Wright's office reported that a September 10 was a successful breakfast and honored several people in the community. Finally, the Seniors' "Meet & Greet" event will continue to be held once a month at The Salvation Army at 137th Street and Lenox Avenue.

Ms. Dela Rosa of Assemblyman Daniel J. O'Donnell's office discussed an October 1 letter to Gov. Patterson, that Assembly member O'Donnell called for a moratorium on the drilling practice of hydraulic fracturing or "hydrofracking." Secondly, she announced a Breast Cancer Awareness Month event on October 16th, 2010. Free mammograms will be performed to the community.

Lemond Mayes of the Councilwoman Inez Dicken's Office talked about the many problems of the voting booths in the past September primary. From late openings to many poll sites ran out of ballots and did not provide privacy sleeves were the problems of some poll sites. If anyone had a problem, they should call 212-678-4505.

Dr. Hazel Dukes announced Fire Prevention Week October 3 – October 9 2010. The Health committee meeting was a success. She stressed that extinguishers should be monitored. Londell Davis is a local Businessman who sells fire extinguishers.
