Wadleigh Secondary School for the Performing and Visual Arts Principal Kyleema A. Norman

<u>Dr. K Samuels</u> - commented respect and disrespect within the community, change in the "sign in" procedure for the CB #10 meeting, found it disrespectful when minutes/and agenda are not available prior to the meeting. There is no plan for the community, know the number of the black businesses in the community, the public needs to know.

<u>Stephanie McGraw</u>, CEO and founder of WARM -"We All Really Matter" located in the Harlem community, her personal experience with domestic violence resulted in her founding the organization as she is a survivor of domestic violence after a 9 year abusive relationship. On October 24, 2019 there will be a panel discussion on domestic violence at Salem United Methodists Church.

<u>John McBride</u> - of HDFC Coalition, spoke about Local Law 64 of 2018, which was passed by the City Council which requires developers to register new apartment on a new HPD site. Requires every HDFC apartment owner to register their apartment every yearn a website operated by HPD, and to list their apartment again when it is offered for sale or rent. The system is cumbersome and punitive, as many HDFC shareholders are elderly, may not use computers, do not understand English, and cannot pay the fines levied against them for noncompliance.

<u>Mari Moss</u> - National Black Leadership on Commission Aids has undergone a name change to the National Black Leadership Commission on Health, the change was due to the health disparities impacting our community disproportionately. Specifically, the following properties at 362 West 125th Street and 56 West 125th Street have been identified and there are others.

Suggested that a be drafted resolution condemning negligence of developers, and it should be mandatory that developers must present their plans before CB #10 to insure that the structures being built and developed are in keeping with the standards and rules prescribed by city agencies.

Developers that are negligent should be published in the media, and city investigatory agencies should monitor building sites.

In the future, it is hoped that more board members will attend as it demonstrates our presence and commitment made to the Harlem community by CB #10. September 20th - At the District Services cabinet meeting, it was brought to light that the streets and sidewalks of the community are strewn with litter and trash, has become unsightly.

September 20 - attended an event at Raymour and Flanagan which was makeovers for men, which included haircuts, manicures for those in attendance.

September 23 - Attended meeting at Drew Hamilton Houses where Legionnaires Disease was found to be in five building on the site. Three out of the five buildings are being treated. NYCHA residents are fed up. All five buildings are being treated and monitored.

September 27 - attended Morningside Park ribbon cutting events with Mark Levine of CB #11, this was to unveil a new playground in the park, which was well attended by community residents and their children.

The statue is scheduled to be unveiled on Central Park'a Mall - Literary Walk on August 26th, 202 which will be the 100th anniversary of the ratification of the 19th Amendment which prohibits and the federal government from denying the right to vote to citizens of the United States on the basis of sex.

CB #10 supports the revised monument through the new design to more appropriately represent this historic movement.

Harlem Meer

The redesign for the Harlem Meer is a \$150mm project to reconstruct Lasker Pool and the surrounding buildings and environment. Built in 1966, it has served as a rural oasis in the middle of an urban area. The location has fallen into disrepair and must be replaced, reconstructed to better serve the surrounding community.

The skating rink and pool, and the visitors experience to the location will be enhanced.
