Meeting of Community Board #3 held on Monday, June 24, 2008 at 6:45 at IS 131, 100 Hester Street

Presentation of Gouverneur Healthcare Services by Mendel Hagler, Executive Director:

Mr. Hagler gave a presentation of the services provided by and the future of Gouveneur Healthcare Services. Gouvener is at 227 Madison Street. It will have new buildings containing new facilities. Mr. Hagler discussed the new Modernization Project of Gouverneur Healthcare Services. He stated that Gouverneur Healthcare Services cares for more than 100,000 patients a year. He stated that Gouverneur Healthcare Services serves the area of lower Manhattan and surrounding areas. Gouverneur Healthcare Services has a wide diversity of patients. Mr. Hagler went over the objectives of the Modernization Project. Among the many aspects of the Modernization project include doubling the available space on Gouverneur's lower floors where outpatient services are provided. New healthcare services such as a kidney dialysis unit and CT imaging will be available.

Presentation from Mashi Blech regarding the Time Bank:

The Time Bank is a type of volunteer service provided by the Visiting Nurse Service of New York.

Public Session:

Ted Reich: Ted is speaking on behalf of CODA. Ted would like the rezoning plan to include all of the Lower East Side. Ted would like CB3 to modify the rezoning plan for the LES.

Arek Tomazsevski: Arek is from the National Mobilization against Sweatshops (NMASS). Arek is against the rezoning plan. He expressed his concerns regarding the ramifications of the rezoning plan.

Juan Kim: he is here to say "shame on you" to the Community Board for approving the "racist rezoning plan."

Susan Howard: is from the Coalition to Protect Chinatown/LES. She is against the rezoning plan.

Celia Correa: she is from NMASS. She is against the Rezoning Plan and is worried about the future of the community.

Nika Nagasaki: she is against the "racist rezoning plan."

Quentin Maidment: He is a volunteer for the Chinese Staff Workers Association (CSWA). He is against the rezoning plan.

Carol Puttre: Carol is speaking in support of Met Foods achieving a fair price for their lease.

Elissa Schlick: She is representing the NYC Council of Dog Owners. She wants the City to address late-night noise and use of the Stanton St. dog run. She would like a high fence and a gate to protect the dog run. She also wants the dog run to set standard hours.

Amy Hobby: She is speaking in support of keeping the Stanton St. Dog run open.

Pat De Angelis: She is inviting people to attend the July 8th meeting of the local/CB3 Environment

Suzanne Travers: Suzanne is speaking in support of keeping the Stanton St. dog run open.

Colin Knight: He is speaking in support of keeping the Stanton St. Dog run open and the raising of a fence to keep out late-night noise and late-night use.

Kenneth Nieves: He is speaking in support of the dog run. He spoke of how large the voting constituency dog owners are and instructed the Community Board not to incur their wrath.

Eric Ablett: Eric is speaking in support of the Dog Run and of putting up a fence to keep out late-night noise and late-night use.

Amikole: She is from the Children's Liberation Day Care Center. She is speaking in support of the relocation of the CLDCC.

Marian Osmond: Marian is speaking in support of Met Foods achieving a fair price for their lease. She is asking the Community Board to vote in favor of a resolution supporting Met Foods achieving a fair lease.

Morris Faitelewicz: Morris is speaking in support of David Weprin's 10 point plan to restore to duty the Auxiliary Police Rescue Unit.

Lela Chapman: is at the meeting to announce the opening of the neighborhood farmers market.

Martha Danzee: she is speaking in opposition to the full OP liquor license for Joe Doe's, at 45 East 1st St. She believes the block is already saturated with too many bars and clubs.

Tom Parker: spoke about the upcoming Hudson River Park Arts Festival. He also spoke of the beauty of the waterfalls that are visible from Pier 36. Tom also introduced the new intern Eliza.

Assembly Speaker Sheldon Silver, Zach Bommer: Zach spoke about Assemblyman Silver's attendance at the graduation of the Chinatown's Head Start project. Assemblyman Silver participated in the Hispanic Federation's second annual family celebration "Vive tu Vida get up! Get Moving!" The Assemblyman initiated a free biking program for lower Manhattan.

Assembly member Deborah J. Glick, Matt Gordon: The Assembly member helped pass GENDA.

Assembly member Brian Kavanagh, Paula Castro: Paula spoke regarding the new "Block the Box" legislation sponsored by Assembly member Kavanagh.

State Senator Martin Connor, Eva Rippeteau: Senator Connor introduced legislation clarifying the 200-foot rule Eva announced the appointment of Jinick Green, a down-stater to the SLA. Senator Connor was able to secure funding for the Lower East Side Girls Club. Senator Connor supports Governor Patterson's recognition of same-sex unions from other states.

State Senator Thomas K. Duane, Romeo Ymalay: Senator Duane is outraged by the Rent Guidelines Board's (RGB) increases. Senator Duane will be marching in the Pride Parade. The Senator will be hosting two forums on financial literacy.

Council member Alan Gerson, Matt Viggiano: The Council member is asking the City Council to restore the Bath House which has gone unused for decades. The Council member is also seeking restoration of the Campaign Fiscal Equity money due from the state. The Closing of the NYCHA Senior centers are completely unacceptable to Council member Gerson. Council member Gerson appropriated \$550,000 to the Space and Science center in the Lower East Side. The Council member is also fighting for the reversal of the Community Board budget cuts.

Council member Rosie Mendez, Lisa Kaplan: The Council member is outraged by the cutting of services from NYCHA. The Council member and Alan Gerson are working to get more of the 11 points of the Community Boards plan adopted.

Renewal with Complaint History

2. Frank's, 88B 2nd Ave (op)

VOTE: To deny the renewal of the full on-premise liquor license for Frank's, 88B Second Avenue, unless the applicant agrees before the SLA to make as conditions of its license the following signed notarized stipulation, responding to resident complaints, that 1) it will close all of its doors and windows at 10:00 P.M. every night, and 2) it will make concerted efforts to keep waiting patrons from congregating on the sidewalk in front of the restaurant, including dedicating a staff member to disperse crowds.

Sidewalk Café Application

3. Belcourt, 84 E 4th St (unenclosed)

VOTE: To approve the application for a sidewalk café permit for twenty-two (22) tables and forty-four (44) seats for Belcourt, 84 East Fourth Street, because the applicant has signed a change agreement which will become part of its DCA license that 1) twelve (12) tables and twenty-four (24) seats will be located on the Second Avenue side of the establishment, eight (8) tables with sixteen (16) seats will be located on the Fourth Street side of the establishment and two (2) tables with four (4) seats will be on the corner, 2) its hours of operation will be from 11:00 A.M. to 11:00 P.M. Sundays through Thursdays and 11:00 A.M. to 12:00 A.M. Fridays and Saturdays, and 3) it will have an awnings extended over its café during its hours of operation to baffle any noise which might be heard by the residential tenants.

4. Raynick, 205 Allen St (unenclosed)

VOTE: To deny the application for a sidewalk café permit for three (3) tables with six (6) seats for Raynick, 205 Allen Street, because the following conditions would collectively minimize the public space utilized by pedestrians: 1) the proposed sidewalk café would be in close proximity to the busy southwest corner of Allen Street and Houston Street and its addition would restrict already heavy pedestrian traffic from this corner and from the F/V subway entrance which is located on this corner into a narrower sidewalk, 2) there is a bus stop located on this block of Allen Street within two (2) storefronts of this business, and 3) the residential apartment building in which this establishment is located maintains a garbage dumpster and discards its garbage immediately adjacent to the location proposed for the sidewalk café and the business located on the southwest corner of Allen Street and Houston Street also discards its garbage adjacent to this proposed area.

5. Kebab Garden, 128 1st Ave (unenclosed)

VOTE: To approve the application for a sidewalk café permit for two (2) tables and eight (8) seats for Kebab Garden, 128 First Avenue, because the applicant has signed a change agreement which will become part of its DCA license that 1) its hours of operation will be from 11:00 A.M. to 11:00 P.M. every day, and 2) its tables will be located against the façade of the establishment.

6. Meath Trails, 61 2nd Ave (unenclosed)

VOTE: To approve the application for a sidewalk café permit for eleven (11) tables and twenty-one (21) seats for Meath Trails, 61 Second Avenue, because the applicant has signed a change agreement which will become part of its DCA license that 1) it will close its café at 10:00 P.M. weekdays and 11:00 P.M. weekends, and 2) that it will not extend any "Happy Hour" offers to patrons seated in the sidewalk café.

7. Gerakas Enterprises, 117 2nd Ave (unenclosed)

VOTE: To approve the application for a sidewalk café permit for twelve (12) tables and twenty-four (24) seats for Gerakas Enterprises, 117 Second Avenue, because the applicant has signed a change agreement which will become part of its DCA license that 1) six (6) tables with twelve (seats) will be placed on the Second Avenue side of the establishment, consisting of three (3) tables each with four (4) seats, and six (6) tables with twelve (12) seats will be place against the façade on the 7th Street of its establishment, 2) it will close its café at 11:00 P.M. weeknights and 12:00 A.M. Fridays and Saturdays, 3) it will have an awning extended over its café during its hours of operation to baffle any noise which might be heard by the residential tenants, and 4) all pocket doors on both the 7th Street and Second Avenue sides of the business will closes at 10:00 P.M. every night.

8. NYLA Café, 101 Rivington St (modification, 5 tables/10 chairs to 19 tables/38 chairs)

VOTE: WHEREAS, NYLA, located at 101 Rivington Street, on the southeast corner of Ludlow Street and Rivington Street, has now applied for a modification of its sidewalk café permit from five (5) tables with ten (10) seats on Ludlow Street only to nineteen (19) tables with thirty-eight (38), fifteen (15) tables with thirty (30) seats to be located on Ludlow Street and four (4) tables with eight (8) seats to be located on Rivington Street; and

WHEREAS, Community Board #3 has long held that the increase in nighttime venues has resulted in persistent and numerous complaints regarding increased noise as well as increased pedestrian and

vehicular traffic in specific areas within this district and said complaints have evolved over time from complaints that were once only about specific rowdy businesses to complaints that are now about noise and congestion resulting from the sheer volume of eating and drinking establishments; and

WHEREAS, said conditions continue to be prevalent in and around Ludlow Street between Houston Street and Delancey Street which currently has twenty-one (21) eating and drinking establishments and Rivington Street between Norfolk Street and Orchard Street which currently has eleven (11) eating and drinking licenses; and

WHEREAS, the Seventh Precinct and Community Board #3 has asked the New York City Department of Transportation to permanently change signage on the west side of Ludlow Street between Houston Street and Delancey Street to "NO STANDING FROM 11:00 P.M. TO 6:00 A.M. FRIDAYS AND SATURDAYS" because the street and sidewalks have been overwhelmed by nighttime businesses and their attendant vehicular and pedestrian traffic and noise creating unsafe conditions for pedestrians and prevent police and other emergency vehicles from traveling down this street (Community Board #3 motion of November 2006 attached hereto); and

WHEREAS, said request has resulted in the New York City Department of Transportation permanently changing signage and eliminating residential parking on the west side of Ludlow Street between Houston Street and Delancey Street in response to the overwhelming street and sidewalk congestion and the unsafe conditions; and

WHEREAS, residents from buildings on Ludlow Street, both adjacent to and across the street from this location, previously appeared before the board at the time that this applicant originally appeared to complain of existing noise and impassable sidewalks and streets because of too many people and cars, including the testimony of one walker-bound tenant from the adjacent building, 124 Ludlow Street, that the sidewalks are currently too congested and dangerous for her to safely maneuver due to congestion from the patrons of existing businesses and expanding this sidewalk café would exacerbate these conditions; and

WHEREAS, a resident of Ludlow Street has now appeared in opposition to an extension of this sidewalk café because the sidewalks on this corner are presently so overcrowded that pedestrians are forced to walk in the street which creates dangerous conditions for pedestrians; and

WHEREAS, the applicant had previously conceded that there is street and sidewalk congestion from eating and drinking establishments on both sides of Ludlow Street on the blocks north and south of his establishment and immediately opposite his establishment, as well as on Rivington Street; and

WHEREAS, said applicant previously refused to sign a sidewalk café change agreement, limiting the size and hours of operation of its sidewalk café, to address and minimize the aforementioned street conditions; and

WHEREAS, this applicant instead entered into an agreement with the City Council and Councilmember Allan Gerson to operate a sidewalk café consisting of five (5) tables with ten (10) seats and closing at 9:00 P.M. Sundays through Thursdays and 10:00 P.M. Fridays and Saturdays; and

WHEREAS, a representative of Councilmember Gerson's office has stated that the present application to increase this sidewalk café is in violation of this agreement and without notice to said councilmember's office or the City Council; and

WHEREAS, the commanding officer of the 7th Precinct is opposed to an extension of this sidewalk café because 1) it would result in more congested street traffic and increasingly dangerous conditions on a corner which is already dangerous, 2) this precinct is already frequently asking this business to close its floor to ceiling glass windows extending across its entire façade to minimize the noise which emanates to the street and an extension of its sidewalk café would extend this noise onto a street already overwhelmed by nighttime noise, and 3) there have already been thefts of patrons within this establishment and extending its sidewalk café would increase the potential for such threats; now

WHEREAS, this applicant failed to appear before Community Board #3 himself, instead sending his attorney and manager to appear on his behalf, and both of them walked out in the middle of Community Board #3's hearing regarding this application;

THEREFORE, BE IT RESOLVED, that Community Board #3 urges the Department of Consumer Affairs to deny the modification of the sidewalk café permit for NYLA, located at 101 Rivington Street, to nineteen (19) tables with thirty-eight (38) seats, fifteen (15) tables with thirty (30) seats to be located on Ludlow Street and four (4) tables with eight (8) seats to be located on Rivington Street,

given the longstanding and documented history by Community Board #3 of pedestrian and vehicular traffic and noise on Ludlow Street and Rivington Street.

9. Bernie's, 121 Ludlow St (rw)

withdrawn

10. 26 Clinton St (op)

VOTE: WHEREAS, the applicant, 26 Clinton Street, is applying for a full on-premise liquor license for 26 Clinton Street and did not appear before Community Board #3 for review of its application or provide any application materials to review; and

WHEREAS, Clinton Street is a small, narrow, one (1) lane residential street, only three (3) blocks long, running from Houston Street to Delancey Street, and which is one of the most heavily trafficked areas in the Lower East Side because it operates as a through street for traffic traveling north from the Williamsburg Bridge to the FDR Drive and Avenue B; and

WHEREAS, Clinton Street is presently overwhelmed by nighttime licensed establishments of all types, as well as vehicular and pedestrian traffic congestion attendant to the volume of these businesses; and

WHEREAS, an investigation by the New York State Liquor Authority when the prior owner applied to upgrade its restaurant wine license revealed that this location is within two hundred (200) feet of Congregation Chasam Sopher, a free-standing synagogue, located at 8-10 Clinton Street; now

THEREFORE, BE IT RESOLVED, that Community Board #3 moves to deny the full on-premise liquor license for 26 Clinton Street, located at 26 Clinton Street.

11. Planet Rose Karaoke, 219 Ave A (expansion)

VOTE: WHEREAS, Planet Rose Karaoke, 219 Avenue A, is seeking an alteration of its full on-premise liquor license, by expanding its karaoke business into the adjacent storefront which is also located at 219 Avenue A, for the purpose of creating a private party room; and

WHEREAS, the prior use of said storefront was as a hair salon and said location has never been previously licensed; and

WHEREAS, there has been demonstrated consistent opposition to the addition of any other liquor licenses on this block of Avenue A, located between 13th and 14th Streets, because, excluding other licensed establishments, there are already at least nine (9) existing bars within five hundred (500) feet of this location, to wit Key Bar, The Phoenix, The Boys Room, Takeout Laundry, Forbidden City, Heather's Common Ground and Habbibi and which includes the applicant's existing business, Planet Rose Karaoke; and

WHEREAS, within the past several months, residential tenants of this block have appeared to oppose the granting of additional liquor licenses at 200 Avenue A, 210-212 Avenue A and 214 Avenue A, because they already have complaints of noise from patrons and music emanating from existing establishments, patrons congregating in front of and traveling between existing establishments; and

WHEREAS, the applicant has failed to state how its alteration would be of any legitimate public benefit, in that the applicant has stated that it would be of public benefit to provide patrons a private area to sing; now

THEREFORE, BE IT RESOLVED, that Community Board #3 denies the alteration of the full on-premise liquor license for Planet Rose Karaoke, 219 Avenue A, by expanding said license into the adjacent storefront.

12. Emilio Barletta, 32 St Mark's Pl (rw)

VOTE: WHEREAS, Emilio Barletta, 32 St. Mark's Place, is seeking to obtain a restaurant wine license to serve beer and wine at a new Italian restaurant; and

WHEREAS, the prior use of said location was as a falafel stand which had no liquor license; and

WHEREAS, there has been demonstrated consistent opposition to the addition of any other liquor licenses on this block of St. Mark's Place, located between Second and Third Avenues, because, there are already, by the applicant's own count, at least seventeen (17) liquor license on this single block, eleven (11) of which are full on-premise liquor licenses; and

WHEREAS, the numerous existing nighttime establishments have resulted in significant noise and vehicular and pedestrian traffic, conditions which have been specifically targeted for enforcement by the Ninth Precinct through the Model Block Program and which has resulted in a request by the commanding officer of said precinct that no new liquor licenses be issued on this street; and

WHEREAS, there are numerous Italian restaurants within a two (2) block radius of this location, including one located on 7th Street at Second Avenue and one located on 9th Street at Second Avenue; and

WHEREAS, the applicant has failed to state how its intended method of operation of an additional Italian restaurant is of any legitimate public benefit;

THEREFORE, BE IT RESOLVED that Community Board #3 denies the application for a restaurant wine license for Emilio Barletta, 32 St. Mark's Place.

13. Three Monkeys, 99 Rivington St (rw)

VOTE: WHEREAS, Three Monkeys, is seeking to obtain a restaurant wine license to serve beer and wine at 99 Rivington Street, located at the intersection of Rivington Street and Ludlow Street, and did not appear before Community Board #3 for review of its application or provide any application materials to review; and

WHEREAS, Community Board #3 has long held that the increase in nighttime venues in this area has resulted in persistent and numerous complaints regarding increased noise as well as increased pedestrian and vehicular traffic and said complaints have evolved over time from complaints that were once only about specific rowdy businesses to complaints that are now about noise and congestion resulting from the sheer volume of eating and drinking establishments; and

WHEREAS, said conditions continue to be prevalent in and around Ludlow Street between Houston Street and Delancey Street which currently has twenty-one (21) eating and drinking establishments and Rivington Street between Norfolk Street and Orchard Street which currently has eleven (11) eating and drinking licenses; and

WHEREAS, the Seventh Precinct and Community Board #3 has asked the New York City Department of Transportation to permanently change signage on the west side of Ludlow Street between Houston Street and Delancey Street to "NO STANDING FROM 11:00 P.M. TO 6:00 A.M. FRIDAYS AND SATURDAYS" because the street and sidewalks have been overwhelmed by nighttime businesses and their attendant vehicular and pedestrian traffic and noise creating unsafe conditions for pedestrians and prevent police and other emergency vehicles from traveling down this street (Community Board #3 motion of November 2006 attached hereto); and

WHEREAS, said request has resulted in the New York City Department of Transportation permanently changing signage and eliminating residential parking on the west side of Ludlow Street between Houston Street and Delancey Street in response to the overwhelming street and sidewalk congestion and the unsafe conditions; now

THEREFORE, BE IT RESOLVED, that Community Board #3 denies the application for a restaurant wine license for Three Monkeys, 99 Rivington Street.

14. JoeDoe, 45 E 1st St (trans/op)

THEREFORE, BE IT RESOLVED, that CB3 wants DOT to determine whether the parking regulations could be changed to "Truck Loading" or or regular street-side parking, and to help Plaintains Cash and Carry understand what combination would best serve the needs of their business. Plaintains Cash and Carry should return to a CB3 Transportation meeting with a specific request for regulations that can be implemented.

5. Request for support for Council Member Weprin's Auxiliary Officers Assistance Plan to provide officers protection from injury and restoration of vital Rescue Units

VOTE: WHEREAS, CB3 supports both the Auxiliary Patrol Units and the multiple precincts covering specialized Rescue Units currently known as Auxiliary Police Support Unit (APSU) who are the auxiliary arm and adjuncts of the NYPD Emergency Service Unit (ESU). We urge their complete revitalization and restoration of equipment, vehicles, training, status upgrade and medical care and NYPD ESU oversight for the Auxiliary Police Support Unit; now

THEREFORE, BE IT RESOLVED, that CB3 asks the NYPD not to disband the APSU, nor take away any of their equipment; and

BE IT FURTHER RESOLVED, that CB3 supports City Councilmember Weprin's 10-point Auxiliary Officers Assistance Plan, which calls for legislation which would require the NYPD to provide Auxiliary Officers with:

- 1. Bullet-proof vests
- 2. Mace
- 3. Expandable night sticks
- 4. Protective gas masks
- 5. Automatic External Defibrillators for Auxiliary Police Special Rescue Units

The Plan also includes legislation that would:

- 6. Increase penalties for attacking and/or injuring Auxiliary Officers by granting auxiliary the status of Peace Officers While on Duty.
- 7. Require the NYPD to provide appropriate benefits for disabled Auxiliary Officers and death benefits for families of Auxiliary Officers killed in the line of duty.
- 8. Mandate that the NYPD give regular reports to the City Council on the Auxiliary Program, including data on personnel, equipment, vehicles, training hours.

- 9. Require the NYPD to provide improved and increase training and self-defense classes for Auxiliary Officers to be administered by Police Academy instructors.
- 10. Provide for the full restoration of the Auxiliary Emergency Service Unit (AESU) name and function to allow Auxiliary Officers to properly serve as the Auxiliary arm of the NYPD Emergency Services Unit.

BE IT FURTHER RESOLVED, that CB3 calls upon our elect officials to take action to support the APSU and to pass legislation called for by Weprin's plan.
