Chairperson Alysha Lewis-Coleman

- CB3 has a Facebook page and it is looking for announcements from committees, task forces, etc. We're working on getting Twitter back.
- Be careful with flu season. Please look out for your senior neighbors.
- The census is coming. Please make sure you fill out your census!
- Michael Marino is working on attendance, and Lisa Kaplan will take it over shortly. Any communication you receive about attendance is notification, it does not mean you are being removed from the board.

## **District Manager's Report:**

District Manager Susan Stetzer

- Starting March 1, grocery stores and some other retail stores will no longer use plastic bags. Department of Sanitation has provided free bags
- There was a shooting at 103 Avenue A. Bar was using an outside promoter for the first time. Both people that were killed were from outside the neighborhood. Owner bought the bar as a corporate change so there was never an opportunity for the owner to come before the community board for comments.
- Yuh-Line Niou will be calling an inter-city bus meeting. People need to keep calling 311 to keep a record.
- There were complaints about safety issues at loading docks at Trader Joe's and Target on Clinton Street. 7th Precinct has put auxiliary patrols in the area. DOT was supposed to come to the community board meeting but another meeting was request, but they'll only come once a month so they'll be on March agenda.
- Civic Engagement Commission has four mandates:
  - Run a citywide participatory budgeting program with guidance from a participatory budgeting advisory committee;
  - o Partner with community-based organizations and civic leaders, increase awareness of City services, and assist New York City agencies in developing civic engagement initiatives;
  - Develop a plan to consider the language access needs of limited English proficient New Yorkers with regards to the Commission's programs and services and provide language interpreters at poll sites by the 2020 general election, with advice from a language assistance advisory committee; and
  - o Provide assistance to community boards.
- CB3 is first in the city in structural fires.
- There the pilot project on Ludlow and Orchard removing one lane of parking and extra sanitation pickups.

  Those restrictions are now in effect. Sanitation department is giving summonses for noncompliant parking.

2. Exec Committee Vote 2: Support for allocation under Senator Hoylman's Community Board budgeting program

#### VOTE:

**WHEREAS,** New York State Senator Brad Hoylman has introduced for the first time a Community Board Budgeting program, which will allocate funding from the State for capital projects in the Senate district based on Community Board recommendations; and

**WHEREAS,** each Community Board within Senator Hoylman's district has been asked to submit up to five eligible projects, which must cost at least \$50,000 but cannot exceed \$250,000 in total; and

**WHEREAS,** to be eligible, the projects must be either publicly owned, an independent not-for profit higher education institution, or a private school for blind, deaf, or disabled students; and

**WHEREAS,** in December 2019, the Community Board 3 Executive Committee chose to investigate possible capital needs at the Campos Plaza Community Center at 611 East 12th Street and at two New York Public Library branches in the district (Tompkins Square and Ottendorfer); and

**WHEREAS,** both library branches reported that were no current needs for capital funding at this time; and

WHEREAS, Campos Plaza reported that there were a number of capital needs at their Community Center, which currently hosts a Cornerstone Program run by University Settlement that provides free educational, arts, and health services for NYCHA residents and the surrounding community; and

WHEREAS, those capital needs as prioritized below from one through seven:

- 1) Kitchen ceiling replacement;
- 2) Fire suppression system;
- 3) Gymnasium light fixture replacement;
- 4) Gymnasium emergency exit doors replacement;
- 5) Gymnasium entry door replacement;
- 6) Basketball backboard replacement; and
- 7) Gymnasium floor including border replacement.

**WHEREAS,** these upgrades to the Campos Plaza Community Center would ensure that important free services for NYCHA youth and people of all ages in the surrounding community in our district would be located in safe, high quality facilities;

**THEREFORE BE IT RESOLVED,** Community Board 3 recommends that the funding allocation by Senator Holyman be dedicated in full for the Cornerstone Program run by University Settlement at Campos Plaza Community Center for the above mentioned upgrades. It should be noted that these are longneeded upgrades that are necessary to ensure the safety of the NYCHA families using the facility and have not been funded by NYCHA nor any other source as confirmed by the Office of Management and Budget.

WHEREAS, Da Yu Manhattan LLC, with a proposed business name of Dayu, has applied for a full onpremises liquor license to operate a two-story restaurant in the premises located at 81 Bowery, between Hester Street and Canal Street, New York, New York; and

WHEREAS, this applicant is seeking to operate a Chinese hot pot restaurant with a certificate of occupancy of two hundred thirty (230) people, thirty-six (36) tables and one hundred sixty (160) seats on two (2) floors with twenty-two (22) tables and one hundred four (104) seat on the ground floor and fourteen (14) tables and fifty-six (56) seats in the basement, an eight (8) foot bar with eight (8) stools on the ground floor, hours of operation of 11:00 A.M. to 11:00 P.M. Sundays through Thursdays and 11:00 A.M. to 12:00 A.M. Fridays and Saturdays, a kitchen open during all hours of operation, a fixed facade, fourteen (14) televisions, recorded background music and happy hours to 7:00 P.M.; and

WHEREAS, this premises is a previously unlicensed location on a wide commercial avenue; and

WHEREAS, the applicant counted four (4) full on-premises liquor licenses within five hundred (500) feet of this location; and

WHEREAS, this applicant has experience operating similar businesses in Boston and Florida, as well as operates a similar business located at 36-36 Prince Street, Flushing, New York, which has operated with a wine beer license for four (4) years, and the subject business has been operating for four (4) months; and

WHEREAS, the applicant provided petition signatures, fifty-four (54) of which are from area residents, in support of its application; and

**WHEREAS,** given that this business will operate as a full-service restaurant with daytime hours of operation and early closing times, Community Board 3 will approve this application for a full onpremises liquor license with stipulations governing the method of operation of the proposed business; now

**THEREFORE, BE IT RESOLVED** that Community Board 3 recommends the denial of the application for a full-liquor license for Da Yu Manhattan LLC, with a proposed business name of Dayu, for the premises located 81 Bowery, between Hester Street and Canal Street, New York, New York, unless the applicant agrees before the SLA to make as conditions of its license the following signed notarized stipulations that

- 1) it will operate as a full-service Chinese hot pot restaurant, with a kitchen open and serving food during all hours of operation,
- 2) its hours of operation will be 11:00 A.M. to 11:00 P.M. Sundays through Thursdays and 11:00 A.M. to 12:00 A.M. Fridays and Saturdays,
- 3) it will not commercially operate any outdoor areas,
- 4) it will close any front or rear façade entrance doors at 10:00 P.M. every night or when amplified sound is playing and will otherwise have a closed fixed facade with no open doors or windows,
- 5) it will play ambient background music only, consisting of recorded music, and will not have DJs, live music, promoted events, scheduled performances or any event at which a cover fee will be charged,
- 6) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 7) it may have "happy hours" to 7:00 P.M. each night,
- 8) it will not host pub crawls or party buses,
- 9) it will not have unlimited drink specials with food,
- 10) it will ensure that there are no wait lines outside and will designate an employee to oversee patrons and noise on the sidewalk,
- 11) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 12) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.

**WHEREAS,** The Monroe Group 29 LLC is seeking a full on-premises liquor license to operate a tavern in the premises located at 244 East Houston Street, between Avenue A and Avenue B, New York, New York; and

WHEREAS, the applicant is proposing to operate a tavern with a certificate of occupancy of one hundred ninety-six (196) people, twelve (12) tables and fifty (50) seats, a twelve (12) foot bar and a fourteen (14) foot bar with an aggregate sixteen (16) stools, hours of operation of 11:00 A.M. to 4:00 A.M. all days, less than a full kitchen serving food during all hours of operation consisting of a menu of appetizers and panini, three (3) to five (5) televisions, recorded music and DJs at background and entertainment levels, occasional events with cover fees, private parties, security, happy hours to 8:00 P.M. and wait lines outside; and

**WHEREAS,** the applicant has stated that this is a sale of assets of an existing tavern with a full onpremises liquor license; and

WHEREAS, the previous licensee at this location was approved a full on-premises liquor license by Community Board 3 in October of 2004 with stipulations that it would 1) serve food for the life of the license, 2) promptly address any resident complaints, 3) never use its backyard, and 4) never apply for a cabaret license; and

**WHEREAS,** the previous licensee was issued a full on-premises liquor license by the SLA on January 24, 2005; and

**WHEREAS**, there sixteen (16) full on-premises liquor licenses within five hundred (500) feet of this location per the applicant; and

**WHEREAS,** the applicant furnished petition signatures, forty-eight (48) of which are from area residents, in support of its application, and two (2) friends of the applicant appeared to speak on its behalf, stating that the principals are exemplary people with good moral character; and

WHEREAS, the applicant has no experience operating a licensed business but two (2) of the four (4) principals have experience working in eating and drinking establishments, including two (2) businesses located in the immediate area; and

WHEREAS, a resident of the neighboring large residential building appeared to complain that 1) the existing soundproofing is inadequate because she can hear music from DJs and noise from people and bass from the existing business in her apartment Fridays and Saturdays, from 9:00 P.M. to 4:00 A.M., 2) the existing business has a constant wait line when open with poor management of that line by the business which has made the sidewalk in front of the business inaccessible, 3) she often finds drunk people passed out in front of the business, and 4) the applicant did no outreach to residents of her building; and

**WHEREAS**, consistent with these complaints, there were seventeen (17) 311 commercial noise complaints about the previous business within the past year, five (5) of which required a police response to correct; and

**WHEREAS**, the applicant has agreed to contract with a sound engineer for recommendations about installing soundproofing and has agreed to ensure that sound from its business is inaudible in the apartments adjacent to the business; and

**WHEREAS**, given the concerns expressed by neighboring resident but recognizing that this is a previously licensed location with a similar method of operation, Community Board 3 would support this application for a full on-premises liquor license with stipulations governing the method of operation of the business which includes ensuring that sound is inaudible in neighboring apartments; now

**THEREFORE, BE IT RESOLVED** that Community Board 3 recommends the denial of the application for a full on-premises liquor license for The Monroe Group 29 LLC, with a proposed business name of Writing on the Wall, for the premises located at 244 East Houston Street, New York, New York, between Avenue A and Avenue B, unless the applicant agrees before the SLA to make as conditions of the license the following signed notarized stipulations that

- 1) it will operate as a tavern, with less than a full kitchen serving food during all hours of operation,
- 2) its hours of operation will be 11:00 A.M. to 4:00 A.M. all days,
- 3) it will not commercially operate any outdoor areas,
- 4) it will close any front or rear façade entrance doors at 10:00 P.M. every night or when amplified sound is playing and will otherwise have a closed fixed facade with no open doors or windows,
- 5) it will employ security guards all days, at least one (1) of which will be at the entrance outside,
- 6) it will install soundproofing consistent with the recommendations of a sound engineer and will work with neighboring building residents to ensure that sound and bass from the business will be inaudible in neighboring apartments,
- 7) it will play recorded music generally and may have DJs three (3) times per week, may charge a cover fee no more than twelve (12) times per year and may host private parties no more than twelve (12) times per year but will not have live music, promoted events or scheduled performances,
- 8) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 9) it may have "happy hours" to 8:00 P.M. each night,
- 10) it will not host pub crawls or party buses,
- 11) it will not have unlimited drink specials with food,
- 12) 12) it will ensure that any wait lines outs ide are against the façade of the building to allow pedestrians access to the sidewalk and will designate an employee to oversee patrons and noise on the sidewalk,
- 13) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 14) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.

VOTE: TITLE: Support "Donald Suggs Jr. Way" Co-Naming for Southwest Corner of E 6th St and Ave B

WHEREAS, Donald Suggs, Jr., a distinguished writer and activist, an African American, gay man, moved to his long-time residence of 526 E 6th St in 1990 and remained an important figure on the block until his untimely death in 2012; and

WHEREAS, Donald's work as a writer and senior editor at the now-closed Village Voice unearthed unique stories important to the LGBTQ community and to NYC culture at large, stories ignored by other media outlets at the time. He penned the first major article about the transgender Harlem ballroom scene in New York for the Village Voice. His writings from the Advocate to the New York Times and his activism, which began at Yale University, led to ground breaking discourse on black LGBTQ people around the world; and

WHEREAS, Donald was former board chairman for the public access cable network Manhattan Neighborhood Network (MNN). In 2001, he founded People Using Media to do Prevention, or the PUMP project, which taught young people from neighborhoods decimated by HIV how to produce HIV prevention videos to combat the spread of HIV within their communities. These young people went on to co-produce with Better World Advertising and Salt and Pepper Media HIV prevention videos for Harlemites airing on BET, LOGO, MTV, NY1 and VH1. Donald's bi-lingual HIV prevention work extended to Central and South America and included Latino and African immigrant communities in the

U.S. His work continues to be cited for changing the landscape of American HIV messaging campaigns; and

WHEREAS, A petition for co-naming the southwest corner of E 6 St and Ave B as "Donald Suggs Jr. Way" demonstrated substantial neighborhood awareness and support. The petition gathered 340 signatures from the blocks of E 6th St between Ave A and B and the block of Ave B between E 5th and 6th St, consisting of 315 residents and 27 owners/managers of business/institutions. The block has 410 residential units and 19 businesses, so the petition drive exceeded the 75% thresholds called for in the CB 3 Guidelines for Street Co-naming; and

WHEREAS, Donald Suggs Jr. meets the criterion in the CB 3 Guidelines for Street Co-naming titled "Accomplishment during lifetime:"

An individual who had demonstrated an extraordinary and consistent long-term commitment to benefit the community. The individual's accomplishments would not be considered if done in connection with the operation of a commercial enterprise. The individual must have been deceased for at least 2 years.

THEREFORE, BE IT RESOLVED, that CB 3 Manhattan supports co-naming the southwest corner of E 6th St and Ave B as "Donald Suggs Jr. Way." This street co-naming would be a celebration of the progressive ideals, open mindedness and artistic life of the East Village, which Donald stood for, embodied and loved.

## **Bus Stop Application**

5. Bus Stop Application: LX Transportation LLC (on Canal St, from Orchard St to Allen St; In front of 59 Canal St)
Destination: Columbus, Ohio

VOTE: TITLE: Deny a Curbside Bus Stop for LX Transportation LLC at 59 Canal St

WHEREAS, LX Transportation LLC has applied for a designated bus stop for curb-side loading/unloading operations located in front of 59 Canal St, between Orchard and Allen St. The buses will operate under the LX Transportation brand name, providing service between New York and Columbus, OH with 1 departure per week – at 11:00 pm on Thursday. The applicant stated his intention to expand operations to a few nights per week if business is successful. Express Bus would be approved for only one bus at a time loading/unloading; and

WHEREAS, This location at 59 Canal Street is an existing curbside bus stop that would be shared with two other permitted bus operators: Virginia Seagull Travel with four arrivals/departures daily, and Z&D Tours with three arrivals/departures daily. If LX Transportation is approved, there would be up to a combined 7 arrivals/8 departures at this location. Directly around the corner, there is another curbside bus stop at 32 Allen Street with at least a combined 15 arrivals/departures daily, shared by at least two other bus operators: Eastern Coach with 14 arrivals/departures daily, and No. 1 Bus Tour with one arrival/departure daily; and

WHEREAS, The number of bus operations on this stretch of Canal Street – a small local street with a single moving lane in each direction – has surpassed the saturation point because of the other permitted curbside bus stops in the immediate area as well as numerous unpermitted buses using these stops. This has contributed to unsafe streets and has caused negative impacts on the surrounding community; and

WHEREAS, the Community Board 3 District Office receives complaints regularly about issues concerning the Canal Street corridor and the proliferation of permitted and unpermitted bus operators in the immediate area. The following issues were discussed at the Community Board 3 Transportation Committee meeting:

- Noise buses are noisy and crowds of riders are disruptive through conversations and confrontations with pedestrians;
- Sanitation Issues Garbage is left in the streets and riders use the street and parks as bathrooms;
- Security Concerns Riders commonly enter residences' vestibules for protection from the elements;
- Vehicle Congestion Riders use ride shares and private cars to arrive and leave the designated bus stop; and
- Respect for Community LX Transportation was not communicating appropriately with the CB 3 office in advance of its application review, resulting in the community thinking that the application would come up as an agenda item at two monthly meetings. The office had to cancel the agenda item shortly before the December 2019 committee meeting, leaving very little time for the

community to learn of the agenda change and modify their plans to attend. The applicant did confirm three hours before the January 2020 committee meeting after receiving the invitation on December 18, 2019, but only after repeated attempts to confirm his presence that were ignored. The applicant admitted that this is because this stop is a "sidebar" business to test this new location. This disrespectful behavior resulted in many hours spent by CB 3 staff and portends poor future relations with the community by LX Transportation; and

WHEREAS, CB 3 is concerned that LX Transportation would not agree to provide a storefront for the use of customers, so they may wait to board their bus and use the restroom facilities. This will inevitably cause crowds of passengers jockeying for position on the sidewalk, which will create nuisance, safety and sanitation issues; and now

THEREFORE, BE IT RESOLVED, that CB 3 Manhattan objects to issuing another permit at the 59 Canal Street location, and recommends that DOT should not issue a permit for LX Transportation LLC to operate their bus service at a designated curbside bus stop located in front of 59 Canal St.

THEREFORE, BE IT FURTHER RESOLVED, that CB 3 Manhattan encourages LX Transportation LLC to identify a storefront for the use of customers, so they may wait to board their bus and use the restroom facilities. If LX Transportation is unable to lease a full storefront, they should attempt to negotiate an agreement to share facilities with another business near the bus stop.
