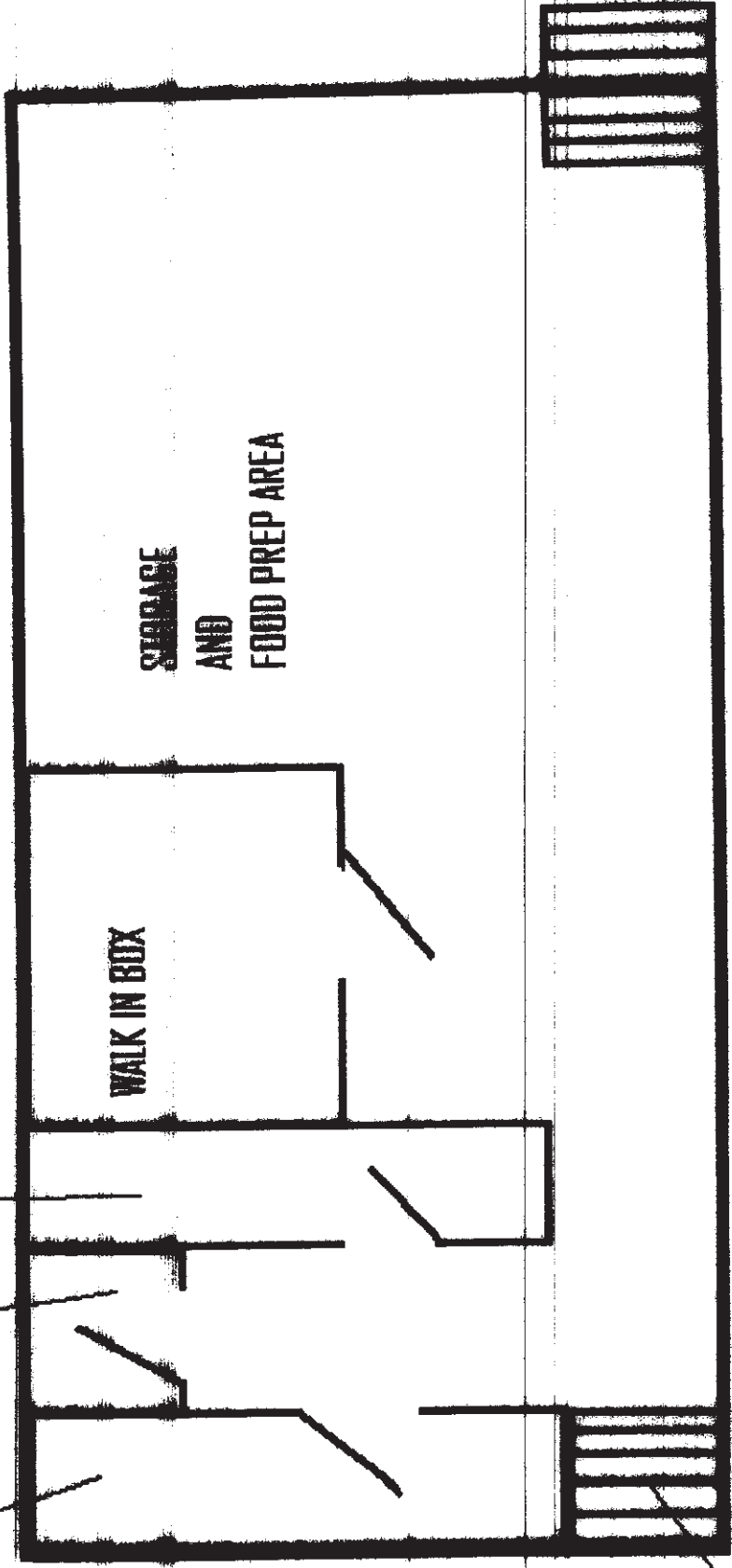

BASEMENT DIAGRAM

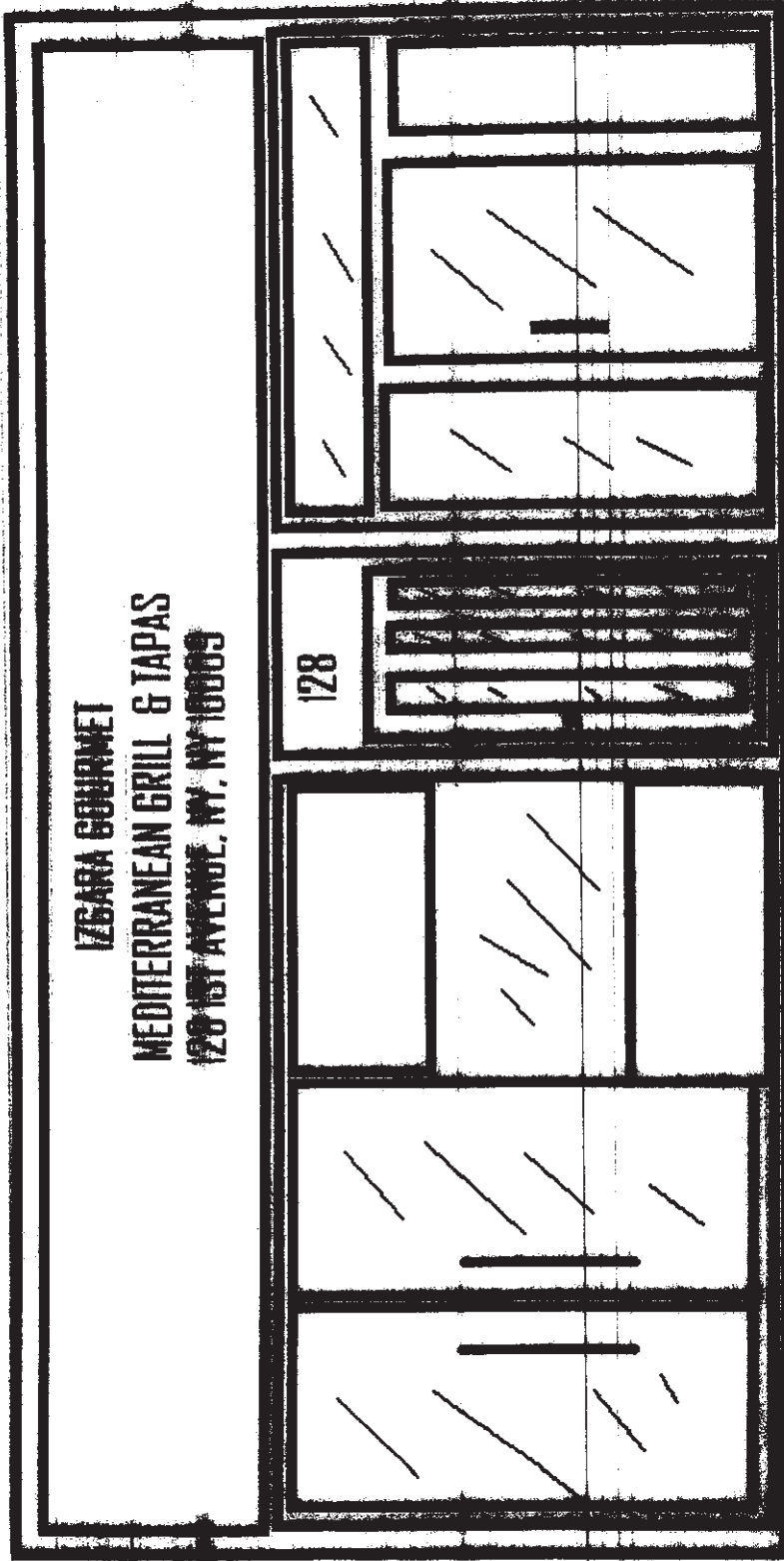

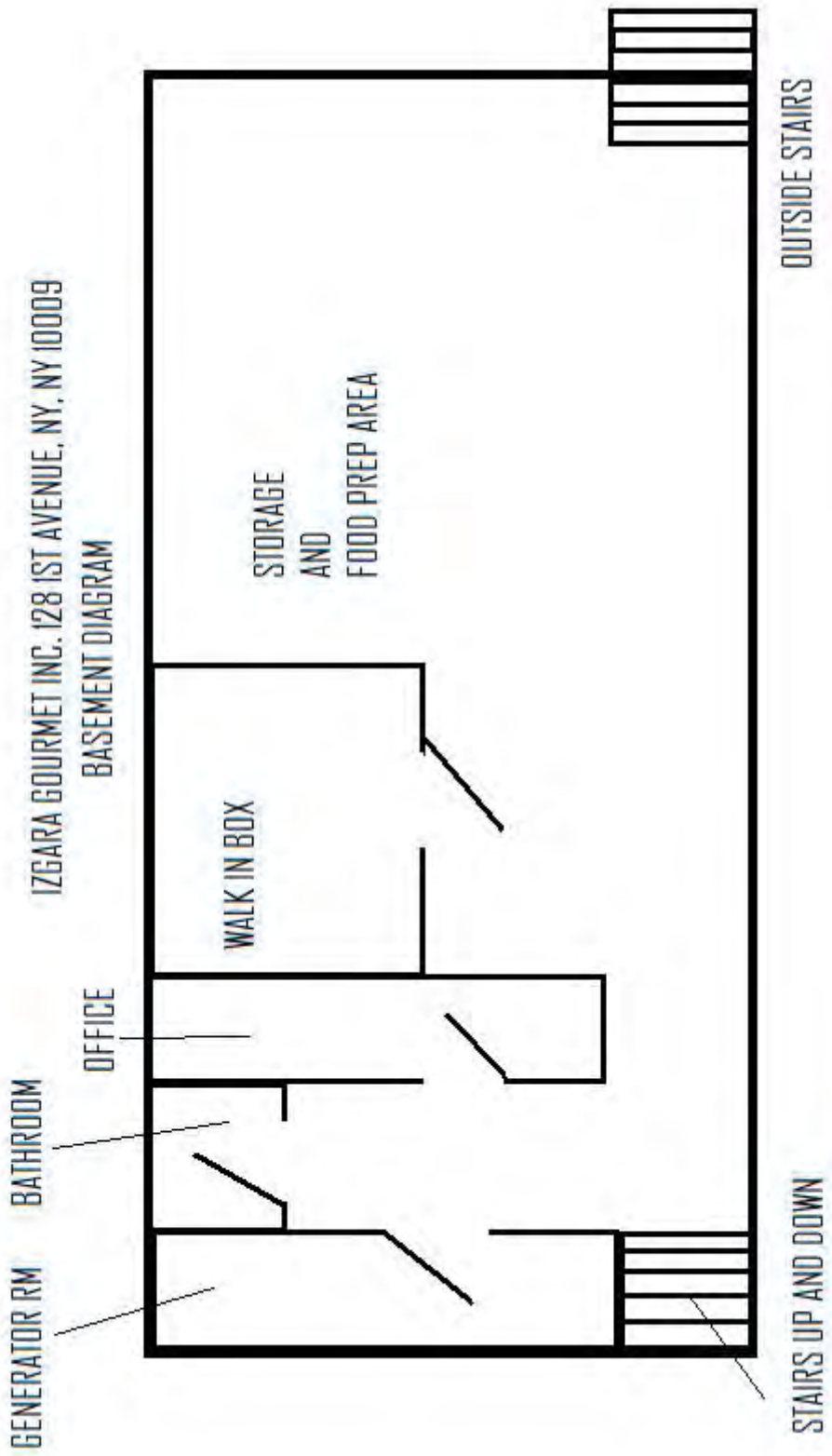
