The host will also suggest a local neighboring establishment to visit while waiting so as to keep the sidewalk clear.

The host on duty will direct customers out from in front of the establishment, whether that is while entering or exiting the establishment or while being placed on a wait list. No crowds will be allowed in front of the building.


