
Despite there being more than 3 on premises liquor licenses within 500 feet of the proposed establishment, we believe that Temakase NYC LLC will be an asset to the community for the following reasons:

1. The applicant principal Liron Michaeli is the owner of another similar establishment that is located in Brooklyn NY. The establishment is called Poke Stop Inc and is currently in conditional approval with the State Liquor Authority (Serial Number 1318272.)
2. Poke Stop has maintained great reviews across multiple platforms.
3. Exhibit A shows the Google reviews (4.2/5 with 98 reviews), Seamless reviews (4.5/5 with 325 reviews), Yelp reviews (4/5 with 80 reviews), and the GrubHub reviews (4.5/5 with 45 ratings). Maintaining consistent and widespread positive reviews is a testament to the service they provide.
4. The menu will mirror that of Poke Stop. This focuses on Japanese cuisine in a healthy, “quick bite” style establishment. (Exhibit B)
5. The planned establishment only has a proposed 22 seats for dine in. The goal is for the alcoholic beverages to be complementary to the dishes offered at the restaurant.
6. In addition, this location has been previously licensed with an On-Premises license (Serial Number 1311897.) This means we would not be adding a new license to the area, but merely replacing one that has previously served the community.

Taking the above list into consideration, the applicant would like an opportunity to serve this community. We also believe the issuance of a license in this location would not hinder existing licenses due to the applicant’s small size and planned method of operation.
