PLANS FOR TRAFFIC AT 306-308 East 6th street (fun hat IIc dba Beetle House.

- 1. We have been in business at this address since 2016. We have managed traffic using Stanchions and a host.
- 2. We have not have any traffic issues over the last four years using our system of stanchions (when necessary) and having a host at our door directing people.
- 3. We do not have onsite parking and encourage our guests to use public transport whenever possible.
- 4. As we are taking on larger space, traffic issues will be less of an issue as we have more space for people to wait for tables, and more tables to seat them at.
- 5. We have not and will not allow gatherings at our entry or for our gusts to block the sidewalk. Again, we have not had these issues in the four years we have been operating at this address.
