


215 CHRYSTIE LLC – CURRENT GROUND FLOOR GARDEN LAYOUT

Dear Susan and Ed:

We represent the referenced licensee, which intends to file applications with the New York State Liquor Authority ("SLA") for a change in method of operation and an alteration.

The licensee agreed to stipulations with Manhattan Community Board 3 in August 2016 and would now like to change certain of its stipulated method of operation, as to the ground floor garden area only, as follows:

- 1. Increase the occupancy of the garden space from no more than 40 people to seating for 61 people.
- 2. Allow waitstaff service of food and beverages in the garden space Presently patrons may eat and drink in the garden space but must purchase food and alcohol inside.

The licensee will also file an alteration application with the SLA to redesign the seating layout of the ground floor garden and increase the number of tables and seats. Copies of the current and proposed garden diagrams are included.
