WIB and SBS Host Delegation from China



On January 9, The NYC Workforce Investment Board (WIB) and NYC Department of Small Business Services (SBS) staff discussed the City's workforce development programs with a delegation from Hubei Modern Service Industry Study Mission. The delegation visited

to learn more about New York City's workforce development efforts and Business Improvement Districts. The interest of this delegation is another example of the international attention received by New York City's business-driven workforce development system.

WIB Policy Director Attends Conference of Mayors

On January 16-17, WIB Policy Director, Stephanie Martinez and SBS staff, attended the U.S. Conference of Mayors Workforce Development Council (WDC) Annual Winter Meeting in Washington, DC. At this meeting, members of the WDC gathered to share best practices in workforce development programming and advocacy efforts. The WDC heard from Members of the House and Senate Committees responsible for WIA reauthorization, including Congressman Chaka Fattah (D-PA) a key House appropriator, as well as workforce expert John Colbert, regarding the recent stimulus legislation and WIA reauthorization. As follow-up to this meeting, the WIB staff will be convening calls between Chicago, L.A. and San Diego to brainstorm and share best practices about additional programming to spend stimulus dollars both quickly and smartly. Additionally, WIB staff will be working with the Department of Youth and Community Development (DYCD) to articulate key aspects of their Summer Youth Employment Program in order to share with other areas who do not currently operate summer programs, and provide guidance on how to ramp-up quickly with this new infusion of funds.

Operator Consortium Meets

The Operator Consortium (OC) of the NYC Workforce Investment Board met on December 18, 2008. The purpose of the OC is to provide the key "operators" of the public system; NYC Department of Small Business Services (SBS), NYS Department of Labor (NYSDOL), and City University of New York (CUNY), a forum to discuss policy implementation for the Workforce1 Career Center system. At the meeting, new members of the OC Shanna Gumaer from SBS and Mary Kelly from NYSDOL, as well as long time member Mia Simon from CUNY, discussed how to action the OC work plan developed in 2008. Members agreed that prior to deciding what areas the OC will commit their focus in 2009, Mary and Shanna will meet in the interim to review current customer flow and new demands on the system. This research will allow the OC to prioritize work based on the current issues facing the Centers. The next OC meeting will be in early March.

Labor Market Information:

Private sector employment in New York City fell by 49,100, or 1.5 percent, to 3,211,700 for the 12-month period ending December 2008.

Growth was largest in:

- Educational and health services (+6,300)
- Leisure and hospitality (+1,300)

Financial activities lost jobs over the year (-18,800), as did professional and business services (-8,900), natural resources, mining and construction (-7,000), manufacturing (-7,300), and trade, transportation and utilities (-13,200).

Policy Corner by the WIB's Policy Director

To ensure that WIB Members are aware of changes in Washington and Albany that affect our work in New York City, the *WIB Wire* will now feature a policy corner to provide Members with relevant and timely information regarding workforce legislation and policy. This month's Policy Corner focuses on the much talked about Congressional stimulus bill, which includes new funding for workforce development. On January 28, the U.S. House of Representatives passed H.R. 1, the American Recovery and Reinvestment Act of 2009, by a vote of 244 - 188. The bill included \$1.2 billion for WIA Youth formula funding (or funding disseminated to local areas through the current WIA allocation formula), \$1 billion for WIA Dislocated Worker formula funding and \$500 million in WIA Adult formula funding. The Mayor's

Washington legislative office and John Twomey at the New York Association of Training and Employment Professionals (NYATEP) have indicated that if House bill language remains unaltered through the Senate bill, we can assume that NYC's share can be estimated at,

- *16.8 million in Adult Funds
- *\$11.2 million in Dislocated Worker Funds
- *\$36.4 million in Youth Funds
- *Total Funds: \$64.4 million over 2 years.

The Senate will consider their version of the stimulus bill as early as next week. Once the Senate passes their version of the legislation the bill will go to conference. In order to hit the ground running both SBS and DYCD are busy planning to spend down the funds. In next month's *Wire* we will provide updated numbers on the final stimulus package, as well as provide the Board with a memo in mid-February detailing the impact of the stimulus on the public workforce system.

Why are you a member of the WIB?
