WIB and SBS Participate in Workforce Innovation Fund Retreat

On May 21st, WIB and SBS staff joined partners from local foundations on a day-long retreat to develop common goals for future investments in local workforce development programs. The New York City Workforce Invostion Fund is comprised of SBS, the New York City Workforce Investment Board, and a group of local private foundations whose purpose is to pool resources to spur innovation. The Workforce Innovation Fund's current projects include the New York City Sectors Initiative, two training and employment initiatives in healthcare and biotechnology; the Sector Strategies Practicum, a year-long program designed to build the capacity of New York City-based organizations to launch and grow sector initiatives; and a Public Workshop Series, designed to increase awareness of sector initiatives in the City. In the coming months, the Workforce Innovation Fund will meet to develop a plan for future initiatives informed by the recent retreat.

WIB Workforce Policy Committee Passes Training Provider Resolution

On May 22, the NYC Workforce Investment Board (WIB) Workforce Policy Committee passed a resolution regarding compliance standards for New York State licensed training providers. The resolution allows SBS to require that courses offered by training providers receiving vouchers from the Workforce1 Career Centers be approved by an appropriate licensing body. This is another step in promoting accountability across the training offerings funded by the City.

NYC Labor Market Information Service (NYCLMIS) Introduced at Quarterly Meeting

On June 12, the New York City Labor Market Information Service (NYCLMIS) was introduced at the NYC WIB quarterly meeting. The NYCLMIS provides labor market analysis primarily intended for the public workforce system and undertakes research and technical assistance projects to inform policy makers of critical issues affecting New York City's labor market and economy. The service is a joint endeavor of the NYC WIB and Center for Urban Research (CUR) at the Graduate Center of the City University of New York (CUNY). Lesley Hirsch, the Research Director of the NYCLMIS presented a preview of findings from the soon to be released Transportation Sector Profile. Coro Fellow Completes Research on Turnover Costs

Over the last month, **Jorge Rios**, a Coro Fellow with the WIB, completed his research project on turnover rates and costs within key industries in New York City. His research centered on providing accurate occupation-specific turnover rates in three key industries: healthcare and social assistance, retail, and accommodation and food services and identifying strategies for the City's Department of Small Business Services (SBS) to engage businesses to market services that reduce turnover. To complete this research, Jorge conducted desk research and interviews with WIB members in these industries as well as other important community stakeholders. His research was presented to key SBS staff and will be used in future business engagement and outreach. Thank you to **Kathy Kearns** for her active participation in this project.

Kathy Kearns is Senior Vice President at Continuum Health Partners, the parent company of Beth Israel Medical Center, St. Luke's-Roosevelt Hospital Center, Long Island College Hospital, and The New York Eye & Ear Infirmary, in New York City.
