

# WIB Hosts Economic Trends Roundtable



The New York City Workforce Investment Board (WIB) hosted an NYC Economic Trends Roundtable discussion on Friday, May 16th to raise program staff and stakeholder awareness on current labor market conditions.

WIB member Mark Elliott, President, Economic Mobility Corporation, facilitated a roundtable discussion between Jim Brown from the NYS Department of Labor, Jason Bram from the Federal Reserve Bank, and WIB Executive Director Blake Foote. Over sixty attendees, including 11 WIB members, joined the panelists and shared their insights on emerging industry trends and

labor market forecasts, including impacted occupations that the workforce development system should be paying close attention to in the coming months.

# WIB and SBS Craft Policy Paper for the U.S. Conference of Mayors

Over the last month, the WIB and the NYC Department of Small Business Services (SBS) have worked closely with the U.S. Conference of Mayors (USCM) to develop a white paper with USCM members from across the country detailing the core principles for a business-driven workforce system. This white paper will be used by the USCM as a key document when speaking with presidential candidates and members of Congress regarding potential Workforce Investment Act reauthorization and/or other key workforce programming. As such, the paper highlights six essential tenets for workforce programming: business-driven, locally-controlled, funded to reflect its importance, appropriately measured, strongly youth focused, and built on partnerships. The draft of this white paper was presented by NYC WIB Executive Director Blake Foote at the USCM conference in New Orleans April 23-24, and edits will be incorporated into a final set of documents for the Mayors' June meeting in Miami.

WIB Chair Stuart Saft was on hand as Mayor Michael R. Bloomberg and City Council Speaker Christine C. Quinn unveiled the newly-renovated Queens Workforce1 Career Center and NYC Business Solutions Center on April 25th. The Jamaica, Queens based Center now offers additional training and recruitment rooms and computer stations and a revamped communications system. The Mayor and Speaker were joined by state and local elected officials, and Queens-based business owners and jobseekers. At the press conference, Mayor Bloomberg noted that, "Since aligning our workforce training and small business services in 2003, we've placed New Yorkers in 50,000 jobs and helped thousands of local businesses become more competitive by providing them with hiring assistance. Our Workforce1 Career Center and NYC Business Solutions Center in Jamaica achieved a record number of job placements last year, and after the expansion it will be positioned to serve even more New Yorkers." The Queens Workforce1 Center is home to several Center for Economic Opportunity (CEO) investments, including the Income Plus Career Advancement program and the soon-to-be launched Transportation Sector Center.
