2. PUBLIC FORUM

<u>Janet Forte, Rep. Reverend Tumino of St. Thomas The Apostle</u>, read a letter of opposition to the proposed traffic change direction on 87th Street between Jamaica Ave. and 88th Ave.

<u>Philip Condon, Kew Gardens Resident</u>, recommended enhancing CB9's presence on Social Media, stating that it will advance the dissemination of community information to residents that have expressed concerns to its few residents "in the know".

<u>Michael Moore, Kew Gardens Resident</u>, addressed the board regarding the Kew Gardens Traffic Proposal being put forward by the DOT stating that:

- It will significantly impact the residents living near Park Lane South.
- Larger numbers of drivers will use the surrounding streets to avoid the congestion at the intersections of 115th St and Park Lane South and Park Lane South and Metropolitan Ave.
- Dangerous increase in traffic speed and volume on Mayfair, Curzon and 116th Streets is an issue.
- The stop sign at 115th St and 84th Ave is completely ignored.
- A traffic light at 115th St will dramatically increase traffic flow down 112th St.
- Further regulation of traffic at Park Lane South and Metropolitan Ave will increase the traffic flow down Curzon and Mayfair Rd.
- More crashes occurred on 116th St than at the intersection of Park Lane South and Metropolitan Ave.

9. Education & Youth Services Committee Report – Seth Welins, Chair

1: Excelsior Scholarship

The NYS legislature passed a law that would offer tuition college scholarships for N.Y.S. students enrolled in either 2 or 4-year SUNY and CUNY College. Students whose families earn less than \$100K would be eligible for this scholarship. The income cap will rise to \$125 in 2019.

There are several important eligibility requirements for this scholarship:

A: Students must be registered for at least 30 credits per/semester

B: They must graduate in 2 years for 2-year schools and 4 years for 4-year schools.

C: They must use other grants and scholarships before they can receive Excelsior funds.

D: After graduation, they must continue to reside in New York for the number of years they received their scholarship. If they do leave New York before the four year period, their scholarships will be converted into a loan that they will have to repay.

E: This scholarship is only available to citizens, permanent residents and refugees.

F: Students must maintain an <u>unspecified?</u> Grade point average to continue receiving their scholarship. We will have to see the detailed provisions of this program in order to assess its full impact on students and colleges.

2: Charter Schools

Many charter schools receive very large donations and grants. For example, Success Academy's 2014 IRS 990 form showed that they received nearly \$5 million in 2013 and nearly \$11 million dollars in 2014.
