HOVING ANNOUNCES "SCHOOLYARD OF THE FUTURE" AND TOP ARCHITECTURAL APPOINTMENTS

Parks Commissioner Thomas P.F. Hoving unveiled a model of "the schoolyard of the future" at a press conference at The Arsenal today.

Designed by architect Richard Stein, the new playground will be installed at P.S. 55 in the Annadale section of Staten Island.

Commissioner Hoving said that "The new design is a radical change from the chain link fenced plot of asphalt this Department has traditionally provided for jointly-operated school playgrounds. The unique features of this new playground", said Commissioner Hoving, "are that it retains the ancient oak trees on the site, that it provides a number of different levels that break up the visual monotony and provide for a variety of activities and, last but perhaps most important, it demonstrates that good design need not cost more." Commissioner Hoving noted that the new design cost approximately \$100,000 less than an original Board of Education plan that would have destroyed the old oak trees and installed a huge retaining wall around the playground.

Another design for a new park at Rochdale Village in Queens, also by Richard Stein, was shown at the press conference. Commissioner Hoving said that "The intention of the design is to provide a social link between the housing project and the residents of the neighborhood." The Rochdale Village park is designed so that it opens both toward the middle income project of some 6,000 residents and toward the community. Commissioner Hoving also pointed out that "The architect has created a terrain with mountains, valleys and plateaus on a flat site so that major use zones are delineated." Some of the active sports that the Rochdale playground will

encompass are football, soccer and baseball. There is another section for roller skating and softball.

Commissioner Hoving also announced the appointment of two top architectural aides: Arthur Rosenblatt, A.I.A., as Director of Park Design; and Charles E. Thomsen, A.I.A., as Assistant Director of Park Design.

(Biographies of the two architects are available.) Commissioner Hoving said, "Mr. Rosenblatt has been working here in the Department since January, 1966, on a foundation grant from Urban America, Inc., as my Design Consultant because there had been no provision for an architect on the top level of the Department of Parks' staff. In this position, he has been responsible for the selection of architects for Park Department projects and for the overall guidance of the Department's design program. He will continue in this capacity as a City employee."

Commissioner Hoving announced that "Mr. Thomsen's duties include coordination of the Park Department's vest-pocket park program and administering the \$450,000 Federal grant for the development of portable parks."

"As new design projects, such as these announced today come forth," said Commissioner Hoving, "they will more than justify the need for architects of this caliber at the top level of government."

The P.S. 55 playground in Staten Island is located west of Preston Avenue between Osborne Avenue and Koch Boulevard. It had been budgeted at \$300,000 but costs have now been reduced by the new design to \$200,000. The playground facilities will include an amphitheatre seating 500; a games area which provides for skelly, hop scotch, shuffleboard and basketball; and a group of concrete sculptures by Costantino Nivola.

The Rochdale Village Park is located at New York Boulevard and 139th Avenue. The total estimated cost is \$584,200.

Statement by Architect, Morris Lapidus, A.I.A. - "When Commissioner Thomas Hoving asked our firm to undertake the design of a swimming pool complex for a block in the Bedford-Stuyvesant area of Brooklyn, we not only accepted with pleasure and anticipation, but we knew in advance that this would be an exciting architectural venture.

Although the project is called a swimming pool, it is, in fact, a neighborhood park, providing full community facilities for young and old alike; facilities not only for swimming during the hot summer months but a large recreation area that may be, and should be, used twelve months a year. To design such a complex was not only a challenge but an opportunity to combine the lessons learned from designing resorts for all kinds of people in many parts of the world, as well as the design of many large housing and community complexes scattered along the Eastern seaboard.

"Except for the swimming pool, the entire project will be carried out in reinforced concrete. The locker facilities, as well as all other utility spaces, will be partly below street level. The locker rooms will be reached by inviting ramps from Marcy Avenue. There are no buildings as such. The roof over the locker rooms and administrations areas, showers and toilets, as well as other utility

spaces, become play areas such as amphitheaters, picnic plaza and many other community facilities. Climbing pyramids for children will house the ventilating system. Vent pipes for the plumbing below will become a forest of trees to be climbed by children. A cascading water fall, dropping into a lagoon will be used by toddlers as water slides and a wading pool. The area for snacks and picnicking can become an amphitheater for puppet shows or for community concerts or serious dramatic presentations. The bleachers, facing the swimming pool, become a terraced piazza complet with varying sized balconies for large groups, small groups and couples. Every square foot of space is designed for multiple use during warm weather and cold, during the day and during the evening. The swimming pool and the diving pool (they are two separate entities) are made entirely of aluminum. The swimming pool is 250 feet by 100 feet and is one of the largest installations of its kind. The aluminum pools are an innovation in New York City. They will be completely maintenance free and will overcome the problems of possible cracking or other faults which occur in large pools of this size when formed of their normal material, concrete, The large pool may be used for swimming during the cold months by placing a plastic air bubble over it, or it may be turned into a half-dozen basketball courts or several touch football fields. The ultimate allweather uses are still to be determined. The concrete that will be used in the construction of the Bedford-Stuyvesant pool will employ many textures and treatments. Here will be found no dull concrete walls or floors. The flexibility of concrete will be utilized to its fullest capacity to produce excitement and besity, aside from the unusual and

varying textures of the surfaces, we intend to have inlays of colored ceramic glass, which will create large murals on a number of the walls. Floors will be covered with non-slip epoxy in bright, vibrant primary colors and unusual patterns. Great economies are anticipated from the use of concrete and aluminum.

Parks Commissioner Thomas P.F. Hoving announces that the Richard Morris Hunt Monument, located on Fifth Avenue at 71 Street, Central Park will be re-dedicated with ceremonies on Saturday, October 1, 1966 at 11:00 A.M.

The Richard Morris Hunt monument is a semi-circular granite entablature supported on a high base by eight square pillars and four Ionic columns. The latter stand on a projection which serves as a back to a low seat. In the center two pilasters support a projection of the entablature. In front of the screen between them is a simple pedestal, on which stands a bronze bust of Richard Morris Hunt. On a lower pedestal against each end of the structure, stand two female figures heroic size, representing painting and sculpture and architecture, in simple classic costumes. The one at the left holds palette and brushes in the left hand, and in the right a hammer. The right figure holds a model of a building.

Erected in 1898 by the Art Societies of New York in recognition of his services to the cause of art in America, climatic conditions, air borne pollutants, and vandalism necessitated the rehabilitation of this work of art.

The figures were completely and expertly repaired and repatinated to original pompeian green, then reset on pedestals. Many granite blocks of the structure were reset to true alignment and all jointing was raked and repainted. Granite throughout was acid washed and the marble tile esplanade was repaired.

All of the rehabilitation was done by the Park Department personnel under the supervision of Walter Beretta, Monument Artisan.


PARKS COMMISSIONER HOVING CAMPAIGNS FOR PROPOSITION I, THE \$200,000,000 RECREATION BOND ISSUE.

Parks Commissioner Thomas P.F. Hoving began to stump this week for Proposition I, the \$200,000,000 Recreation Bond issue that will appear on the ballot on November 8th. At a luncheon before the Rotary Club of the Bronx at the Concourse Plaza Hotel today, Commissioner Hoving urged a "Yes" vote for the bond issue proposition, "because it will make millions of dollars available for acquisition and development of New York City park facilities".

"New York City cannot afford to turn this proposition down", Commissioner Hoving told the Bronx Rotarians. Noting that, "New York is a wealthy state while New York City is impoverished", Commissioner Hoving said, "We must work toward getting back a fairer share of our tax dollar that goes to Albany as well as to Washington." "The passage of Proposition I will not give us our fair share of the \$200,000,000 State Recreation Bond issue, but it is a step in the right direction. Our \$25,000,000 share, plus the undetermined amount that we may receive from it for marinas and for historical sites, is important money and we can spend it for the benefit of City dwellers", Commissioner Hoving said.

Commissioner Hoving will speak again this week for Proposition I at a dinner meeting of the United States Olympians on Wednesday, November 2nd, at 7 P.M., at the Seventh Regiment Armory, Park Avenue at 66th Street; and at a luncheon of the Park Association of New York on Thursday, November 3rd, at the National Arts Club, 15 Gramercy Place, New York City.

HOVING ANNOUNCES "SCHOOLYARD OF THE FUTURE" AND TOP ARCHITECTURAL APPOINTMENTS

Parks Commissioner Thomas P.F. Hoving unveiled a model of "the schoolyard of the future" at a press conference at The Arsenal today.

Designed by architect Richard Stein, the new playground will be installed at P.S. 55 in the Annadale section of Staten Island.

Commissioner Hoving said that "The new design is a radical change from the chain link fenced plot of asphalt this Department has traditionally provided for jointly-operated school playgrounds. The unique features of this new playground", said Commissioner Hoving, "are that it retains the ancient oak trees on the site, that it provides a number of different levels that break up the visual monotony and provide for a variety of activities and, last but perhaps most important, it demonstrates that good design need not cost more." Commissioner Hoving noted that the new design cost approximately \$100,000 less than an original Board of Education plan that would have destroyed the old oak trees and installed a huge retaining wall around the playground.

Another design for a new park at Rochdale Village in Queens, also by Richard Stein, was shown at the press conference. Commissioner Hoving said that "The intention of the design is to provide a social link between the housing project and the residents of the neighborhood." The Rochdale Village park is designed so that it opens both toward the middle income project of some 6,000 residents and toward the community. Commissioner Hoving also pointed out that "The architect has created a terrain with mountains, valleys and plateaus on a flat site so that major use zones are

For information: delineated. To Some of the active sports that the Rochdale playground will

. .encompass are football, soccer and baseball. There is another section for roller skating and softball.

Commissioner Hoving also announced the appointment of two top architectural aides: Arthur Rosenblatt, A.I.A., as Director of Park Design; and Charles E. Thomsen, A.I.A., as Assistant Director of Park Design.

(Biographies of the two architects are available.) Commissioner Hoving said, "Mr. Rosenblatt has been working here in the Department since January, 1966, on a foundation grant from Urban America, Inc., as my Design Consultant because there had been no provision for an architect on the top level of the Department of Parks' staff. In this position, he has been responsible for the selection of architects for Park Department projects and for the overall guidance of the Department's design program. He will continue in this capacity as a City employee."

Commissioner Hoving announced that "Mr. Thomsen's duties include coordination of the Park Department's vest-pocket park program and administering the \$450,000 Federal grant for the development of portable parks."

"As new design projects, such as these announced today come forth," said Commissioner Hoving, "they will more than justify the need for architects of this caliber at the top level of government."

The P.S. 55 playground in Staten Island is located west of Preston Avenue between Osborne Avenue and Koch Boulevard. It had been budgeted at \$300,000 but costs have now been reduced by the new design to \$200,000. The playground facilities will include an amphitheatre seating 500; a games area which provides for skelly, hop scotch, shuffleboard and basketball; and a group of concrete sculptures by Costantino Nivola.

The Rochdale Village Park is located at New York Boulevard and 139th Avenue. The total estimated cost is \$584,200.

HOVING INVITES NEW YORKERS TO MIDNIGHT SCIENTIFIC "HAPPENING"

Parks Commissioner Thomas P.F. Hoving invited New Yorkers to witness a scientific "happening" that takes place only once every thirty-three and one-third years, in the Sheep Meadow in Central Park on Wednesday night, November 16th, from midnight to 3 A.M. The "happening" is the expected meteor shower of Leonids, which provided its most spectacular display on November 12, 1833.

The Parks Department has asked a team of astronomers from the Hayden Planetarium to be on hand to tell the assembled star-gazers, via a public address system, what is happening. Dr. Thomas D. Nicholson, Chairman of the Hayden Planetarium, will be in charge of the lectures. He will be assisted by Dr. Franklin M. Branley. Dr. Kenneth L. Franklin, and Dr. Martin Steinbaum. The lecturers will be assisted by electric beam pointers which shine 300 feet up into the air and will be used to point out the various star formations. Commissioner Hoving suggested that parents put their children to bed early and then wake them close to midnight and bring them to Central Park "because the magnificence of this shower of stars may not repeat itself for another 133 years". The Parks Commissioner also urged parents to bring warm blankets and thermos jugs of hot chocolate or coffee.

Astronomers have predicted, weather permitting, that the November 16th meteor shower will probably equal the extraordinary one of 1833 when thousands of streams of light seemed to be falling from the sky like snowflakes. Research after the 1833 occurrence uncovered a history of these showers dating back to 585 A.D. Scientists were able to make predictions that the meteor showers of Leonids occur every 33-1/3 years. There were minor displays of the November meteor shower in 1866, 1899 and 1933. The Sheep Meadow in Central Park is west of the center of Central Park from West 66th to West 71st Streets.

Hoving will present plans and a model for a unique swimming pool and recreation complex for the Bedford-Stuyvesant section of Brooklyn at a community meeting at the Salvation Army Headquarters, 601 Lafayette Street in Brooklyn, on Tuesday evening, November 22nd at 7:30 P.M.

The pool, to be located at Kosciousko Street and Marcy Avenue, is budgeted at \$1,900,000 and was designed by Morris Lapidus Associates, architects for such showcase swimming clubs as the Eden Roc in Miami Beach and the Arawak in the British West Indies. Morris Lapidus was also the architect for Miami Beach's Fontainbleau Hotel pool, made famous by the James Bond film, "Goldfinger". Mr. Lapidus will be at the Bedford-Stuyvesant meeting to explain his conception to the community.

An interesting sidelight for feature editors is the fact that Morris Lapidus was born and raised in Bedford-Stuyvesant.

FACT SHEET ON NEW BEDFORD-STUYVESANT SWIMMING-RECREATION COMPLEX

LOCATION: Kosciousko Street and Marcy Avenue, Brooklyn

COST: \$1,900,000.00

Statement by Architect, Morris Lapidus, A.I.A. - "When Commissioner Thomas Hoving asked our firm to undertake the design of a swimming pool complex for a block in the Bedford-Stuyvesant area of Brocklyn, we not only accepted with pleasure and anticipation, but we knew in advance that this would be an exciting architectural venture. Although the project is called a swimming pool, it is, in fact, a neighborhood park, providing full community facilities for young and old alike; facilities not only for swimming during the hot summer months but a large recreation area that may be, and should be, used twelve months a year. To design such a complex was not only a challenge but an opportunity to combine the lessons learned from designing resorts for all kinds of people in many parts of the world, as well as the design of many large housing and community complexes scattered along the Eastern seaboard.

"Except for the swimming pool, the entire project will be carried out in reinforced concrete. The locker facilities, as well as all other utility spaces, will be partly below street level. The locker rooms will be reached by inviting ramps from Marcy Avenue. There are no buildings as such. The roof over the locker rooms and administrations areas, showers and toilets, as well as other utility

spaces, become play areas such as amphitheaters, picnic plaza and many other community facilities. Climbing pyramids for children will house the ventilating system. Vent pipes for the plumbing below will become a forest of trees to be climbed by children. A cascading water fall, dropping into a lagoon will be used by toddlers as water slides and a wading pool. The area for snacks and picnicking can become an amphitheater for puppet shows or for community concerts or serious dramatic presentations. The bleachers, facing the swimming pool, become a terraced plazza complet with varying sized balconies for large groups, small groups and couples. Every square foot of space is designed for multiple use during warm weather and cold, during the day and during the evening. The swimming pool and the diving pool (they are two separate entities) are made entirely of aluminum. The swimming pool is 250 feet by 100 feet and is one of the largest installations of its kind. The aluminum pools are an innovation in New York City. They will be completely maintenance free and will overcome the problems of possible cracking or other faults which occur in large pools of this size when formed of their normal material, concrete, The large pool may be used for swimming during the cold months by placing 3 a plastic air bubble over it, or it may be turned into a half-dozen basketball courts or several touch football fields. The ultimate allweather uses are still to be determined. The concrete that will be used in the construction of the Bedford-Stuyvesant pool will employ many textures and treatments. Here will be found no dull concrete walls or floors. The flexibility of concrete will be utilized to its fullest capacity to produce excitement and beauty, aside from the unusual and

varying textures of the surfaces, we intend to have inlays of colored ceramic glass, which will create large murals on a number of the walls. Floors will be covered with non-slip epoxy in bright, vibrant primary colors and unusual patterns. Great economies are anticipated from the use of concrete and aluminum.

Feder, who worked with us in designing the illumination for the first mall in the United States - - The Lincoln Road Mall on Miami Beach.

This is the same Feder who illuminated the John F. Kennedy Airport and parts of Central Park.

"The Bedford-Stuyvesant Park and Swimming Pool will be a place to sit, a place to rest, to dream, to relax, a place for children to climb, slide, to explore, to pretend, to exercise and to release an overabundance of energy. It will be a place to socialize in pairs or in groups, it will be a place for movement, both horizontally and vertically, and even in a side wise direction. In effect, this park will be able to create environments for the old as well as for the young, or an environment for the entire community. It has been designed for competitions and exhibitions, for a musements and serious music, dance and drama, as well as a place for children's puppet shows and pageants.

"The Bedford-Stuyvesant Park will not be just a swimming pool and a group of locker buildings, nor will it be a playground with slides, swings and sand boxes. It is intended to be a living space. One of the great living spaces in the world is the Piazza de San Marco in Venice, which is the focal life for the city and the community. The Bedford-Stuyvesant neighborhood park will in its way become a large living space intended for the enjoyment of members of the entire community."

Tuition is free and the course consists of practical and theoretical instruction in lifesaving skills, water safety, rescue techniques and other procedures and practices taught by special Park Department instructors.

Applicants must be male citizens of the United States who will have reached their 17th birthday on the day of appointment and can pass a non-competitive free-style swimming test of 50 yards in 35 seconds. The minimum height and weight requirements are 5'7" and 135 lbs., at time of registration. Candidates will not be considered eligible for appointment if they have reached their 35th birthday.

Applications are available until the end of December at all public, private and parochial and Hebrew high schools, university and college placement offices; all YMCA, YMHA, and Red Cross Chapter offices; also, at all borough offices of the Department of Parks. Applications will be accepted by the register clerk at East 54th Street Pool at 342 East 54th. Street, Manhattan.

The instructive classes will begin early in January 1967, and enrollees will be required to attend 14 sessions (2 hours weekly) which will be held afternoons and evenings each weekday, and mornings and afternoons on Saturdays. Applicants will be given their choice of class periods.

Successful candidates will receive certificates of qualification at the termination of the course.

New York City's ice-skaters will get a treat for the holiday season as the long-awaited Louis D. Lasker Memorial Swimming Pool-Ice Skating Rink opens on Wednesday, December 21st. Parks Commissioner Thomas P.F. Hoving and Mayor John V. Lindsay will take part in the dedication ceremonies at 2:00 P.M.

Upon completion of the brief formal program, exhibition skaters from the Park Figure Skating Club will put on a show on ice.

The rink will be open to the public for the rest of the day and evening after the dedication ceremonies are concluded at approximately 4 P.M. Regular ice skating sessions will be in operation but there will be no charge for admission on December 21st. (A schedule of skating sessions is attached.)

William Rosensohn, a nephew of the late Loula D. Lasker, will make a presentation of the gift on behalf of the Lasker family and Philip W. Haberman, Jr., an executor of the Estate of Loula D. Lasker, will take part in the ceremonies. The Lasker Family gift of \$600,000 was supplemented by over \$2 million of City funds to create this dual purpose facility. The ice-skating rink converts to a swimming pool in the summer time, providing for year-round recreational use.

Manhattan Borough President Percy E. Sutton will also speak at the dedication ceremonies.

The Louis D. Lasker Memorial Rink and Pool was scheduled to open in February, 1966, but a serious flood caused extensive damage to the freezing equipment. Parks Department and construction personnel have been working around the clock in recent months to get the rink open prior to the holiday season.

Designers of the Lasker Rink and Pool were Fordyce & Hamby, Architects, of 717 Fifth Avenue.

NIGHT SKIING NEW FEATURE AT VAN CORTLANDT PARK SKI SLOPE

The Van Cortlandt Park ski slope will be illuminated for night skiing until 11:00 P.M., said Parks Commissioner Thomas P.F. Hoving, announcing the opening of the official ski season at Van Cortlandt Park in the Bronx, on Friday, December 23rd.

Started as an experiment last year, night skiing proved so successful that it has been incorporated into the regular schedule of the Van Cortlandt Park Ski Area's fifth season. "It enables thousands of New Yorkers to leave their offices and be on the slopes in less than an hour," said Art Peterson, director of the ski area.

The ski area will be open from noon to 6 P. M. on weekdays (Wednesdays and Fridays until 11 P. M.) and from 10 A. M. to 6 P. M. on Saturdays, Sundays, holidays, and during the Christmas week. General admission, including the use of tows, is \$4.40 for adults and \$2.40 for juniors 12 years of age and under. After 3 P. M. daily, there is a discount of \$1.00 on the general admission price.

Several major improvements have been made in the Van Cortlandt Park Ski Area which accommodates 500 to 1000 skiers. A new beginner's area has been developed with provisions for full instruction and the ski school staff, which offers group and private instruction at regular times during the day, has been expanded. Four electrically powered rope tows have been repositioned to enlarge the skiing hills.

In addition, free shuttle transportation from the subway and the Van Cortlandt Park parking lot to the slopes has been provided for skiers. A snack bar at the base lodge and a grandstand area for spectators is available.

Citing the Van Cortlandt Park Ski Area as a place where people can be safely introduced to skiing, Mr. Peterson added, "We're not in competition with Vermont or New Hampshire. Our function is one of preparation -- breaking in new equipment, practicing, or just plain learning how to ski slowly and in safety.

A special ski package that includes admission, tows, rental of equipment and one hour of instruction is being offered to Van Cortlandt Park skiers for \$8.40 for adults, \$6.40 for juniors under 12 years of age.

Parks Commissioner Thomas P.F. Hoving announces that the Richard Morris Hunt Monument, located on Fifth Avenue at 71 Street, Central Park will be re-dedicated with ceremonies on Saturday, October 1, 1966 at 11:00 A.M.

The Richard Morris Hunt monument is a semi-circular granite entablature supported on a high base by eight square piliars and four Ionic columns. The latter stand on a projection which serves as a back to a low seat. In the center two pilasters support a projection of the entablature. In front of the screen between them is a simple pedestal, on which stands a bronze bust of Richard Morris Hunt. On a lower pedestal against each end of the structure, stand two female figures heroic size, representing painting and sculpture and architecture, in simple classic costumes. The one at the left holds palette and brushes in the left hand, and in the right a hammer. The right figure holds a model of a building.

Erected in 1898 by the Art Societies of New York in recognition of his services to the cause of art in America, climatic conditions, air borne pollutants, and vandalism necessitated the rehabilitation of this work of art.

The figures were completely and expertly repaired and repatinated to original pompeian green, then reset on pedestals. Many granite blocks of the structure were reset to true alignment and all jointing was raked and repainted. Granite throughout was acid washed and the marble tile esplanade was repaired.

All of the rehabilitation was done by the Park Department personnel under the supervision of Walter Beretta, Monument Artisan.

Mayor John V. Lindsay today announced that five of the nation's leading architectural firms will enter an architectural competition for the design of a \$5.7 million combined stable and police precinct house in Central Park.

The architectural firms invited to compete are Edward L. Barnes, Marcel Breuer & Associates, Kelly & Gruzen, Philip Johnson Associates and Whittlesey, Conklin & Rossant.

The Mayor was scheduled to make the announcement in a joint press conference with Parks Commissioner Thomas P.F. Hoving at 10:00 a.m. today (September 30) in City Hall.

Mayor Lindsay said that this was "the single most important architectural competition held in New York City since Olmsted and Vaux won the competition for the design of Central Park in 1858."

The Mayor noted that "this competition is unique in the history of architectural competitions because there are built-in safe-guards so that the combined police and stable facility will be built within our budget."

The Mayor explained that each architect will be assigned a professional estimator who will scrutinize all budget items in the firm's entry to insure that the design does not go over the \$5.7 million limit. Entries which, in the opinion of the estimators, exceed the cost limit will not be considered in the judging.

Mayor Lindsay said, "The assigning of estimators to each architect is a landmark in the history of municipal architectural competition. In the past too many competitions for public buildings have ended up as mere architectural exercises because the cost control factor was absent."

The Mayor said that funds for the competition come from Stephen Currier, a private philanthropist, who is providing \$15,000 for each entrant.

The Mayor said that the first prize winner will receive an additional \$10,000 as well as the commission for the design of the police-stable facility. Stephen Currier also will provide \$8,000 for the second-prize winner and \$5,000 for the third prize.

The combined police-public stable will be located south of 86th Street Transverse Road near the present 22nd Precinct station house. One of the conditions of the competition is that the existing 22nd Precinct station house, designed by Calvert Vaux, will remain and be a useful adjunct to the new precinct house and stable.

The judges of the architectural competition will be Parks Commissioner Hoving; Police Commissioner Howard R. Leary; Stephen Currier, President of Urban America, Inc.; Arthur Rosenblatt, member of the American Institute of Architects (AIA), design consultant to Commissioner Hoving; William Breger, AIA; Lewis Davis, AIA; Paul Rudolph, AIA; and M. Paul Friedberg, landscape architect.

Program requirements for the facility have been researched over a 4½ month period by Bentel & Bentel, Architects, of Locust Valley, New York. Bentel & Bentel's staff visited stable facilities throughout the country to study public facilities of this type. Fred Bentel will serve as professional advisor to the competition.

The competition will close in late December, 1966, and the judging will take place in January, 1967.

The stable facilities will provide 150 stalls for the mounted police, 150 stalls divided between privately-boarded and hack horses, as well as space for Polo Association horses. There will be a multi-purpose indoor ring for horse shows and polo matches, which will be designed so as to permit division for horse training and public and private classes.

"The entire facility is to be designed from the point of view of the park user", Mayor Lindsay said. The building will intrude as little as possible on park land and many of the activities within the stables, such as the training and exercising of police mounts, may be observed by groups of City school children.

The funds for the construction of the combined facility will be divided equally between the capital budgets of the Police and Parks Departments.

In commenting on the history of the precinct-stable facility, Commissioner Hoving said that shortly after he became Parks Commissioner, he began discussions with the Mayor and Police Commissioner Leary to change the plans for the facility which had been put forward under the previous administration.

Commissioner Hoving said that there had been complaints from both City Planning Commissioners, Mrs. Randolph C. Guggenheimer and Harmon H. Goldstone, that the facility as originally designed was both architecturally obtrusive and provided inadequate public facilities.

The Parks Commissioner said he, the Mayor and Commissioner Leary reviewed the original plans, decided they were inadequate, and solicited financial assistance from Stephen Currier for the competition.

Commissioner Hoving said that a number of distinguished architects currently are doing work for the Parks Department, including John Carl Warnecke, F.A.I.A.; Paul Rudolph; Edward L. Barnes, A.I.A.; and Philip Johnson, F.A.I.A.

"Among the highlights of the Halloween Party" said Commissioner Hoving, "will be a children's costume parade and pumpkin-carving, chalk-drawing and doughnut-eating contests". Refreshments will be available as well as prizes for everyone entering the contests, and there will be free pumpkins for families taking part in the pumpkin-carving competitions.

At the press conference Tuesday morning, Commissioner Hoving was presented with a gigantic pumpkin by Richard Gott of the Coca-Cola Company on behalf of the upcoming television show, "It's the Great Pumpkin, Charlie Brown". The Coca-Cola Company, which is sponsoring the show on Thursday evening, October 27th, will provide 2,400 pumpkins and free Coca-Cola for the Parks Department's Halloween Party.

Commissioner Hoving was also confronted with a real, live witch Tuesday morning who demonstrated the art of competing in a doughnut-eating contest. The witch, and the doughnuts which will be given out at the Sunday Halloween Party, are provided by Mister

STATEMENT BY THOMAS P.F. HOVING, COMMISSIONER OF PARKS, AT THE DEPARTMENTAL HEARING BEFORE THE CITY PLANNING COMMISSION ON 1967-68 CAPITAL BUDGET REQUEST,

OCTOBER 26, 1966

The 1967-68 Capital Budget Request of the Parks Department is a clear mirror of the pressing recreational needs of New York City for the coming year. This budget has been considered, planned and prepared in an entirely new way.

It is the accurate reflection not only of hundreds of manhours of work by the Department's professional staff with considerable help from the City Planning Commission, but equally
important, it is the result of many regularly scheduled discussions with the Borough Presidents, their staffs, numerous
Community Planning Boards and countless civic associations. In
short, it is a community-inclined and community-impelled document.
It is a grass-roots budget for development and improvement. It
makes its appearance in this fashion because we feel that the
Parks Department must reflect the specific recreational needs of
all segments of the City's population, after continuing and
detailed discussions with each and every community.

The presentation of this year's budget differs from preceding years, too. Formerly, it was the custom to supply elaborate books, furnished with photos of each site under consideration, neatly bound and embellished properly. This has not been done this year because we discovered that the preparation of the book cost our Room 100—the Engineers and Architects—no less than \$105,300.

This year's budget is an ambitious undertaking. The total request is \$81,250,000. Of this amount \$30,508,000 involves land acquisition, \$35,000,000 involves ongoing projects, \$8,100,000 involves rehabilitation projects in both design and construction and \$2,000,000 for the design alone of new projects.

The size of this request takes into consideration the clear fact that the City must continue to add to its land holdings in order to bring about a correct balance of open space throughout the entire City. It is an attempt to meet the changed and changing needs of open space requirements. It faces squarely the fact that, in the future, we will have to re-study the intrinsic value of retaining certain park holdings and facilities that no longer contribute significantly to the recreational life of New York.

From the first day that I assumed the office of the Commissioner of Parks, I have been reviewing the operations of this Department in an effort to establish methods and procedures which will provide for more efficiency.

In this regard, I have reached the conclusion that only a bold step concerning the financing of the engineering and architectural work of the Department will eliminate a very wasteful and archaic procedure. I therefore am revising my budget request to include an amount of \$2,000,000 under Project P-11 instead of \$300,000 to provide for the salaries of the engineering and architectural staff. Why? Under the present system, the engineers

and architects are paid by a set percentage of the costs of each capital task they perform. We have found that some jobs have cost the taxpayer three to four times the amount budgeted for the job. In other cases, we have discovered that money originally allotted for design had to be diverted solely to meet the payroll. It is our contention that it is right and proper to pay those individuals charged with working on Capital projects out of Capital Funds, as has been the practice since the early days of the Department, but that the current system of a percentage of each Capital job is outworn, inefficient and inflexible. It doesn't recognize the need for long-range plans, nor does it permit free choice to assign certain tasks to our architects and engineers which would be more effectively done by outside consultants. Further, it burdens our payroll division with an artificial, archaic and overwhelmingly complicated accounting system.

In January, this parks administration encountered a large backlog of unassigned jobs, some going back to 1963-64. Now I am happy to announce that all formerly unassigned Capital projects of 1963-64, 1964-65, 1965-66, and 1966-67 have been given out. We are demonstrating a strong ability to move. The tally of unexpended or "pipeline" moneys now is far below the amount of ten months ago. We are able now, and in future months will be even more capable of getting the vitally needed jobs for parks and recreation done faster.

Although most projects may be eligible for Federal, and some for State aid, all amounts in this request have been stated in City funds. The reason is that in the past the City has been required to provide first-instance money, and Federal funds have been available as reimbursement. The few cases where Federal or State aid is indicated concern projects where the work is performed by the Federal or State Government and the City makes the reimbursement.

I believe this Budget Request is an absolute necessity. You will be interested to know that after many intra-departmental discussions involving the priorities of these projects, the present figure was obtained from the initial submission of more than one-hundred million dollars. We have pared down considerably.

I fully realize that other areas of community life have always been considered more important than parks. Nevertheless, it is imperative that we face up to the vital and continuing needs of a Parks Department of a highly creative and progressive nature.

Without the capital funds, we can neither "bank" new lands for the growing population, nor rehabilitate what facilities we already possess, nor reach out into fresh fields.

PARKS COMMISSIONER HOVING CAMPAIGNS FOR PROPOSITION I, THE \$200,000,000 RECREATION BOND ISSUE.

Parks Commissioner Thomas P.F. Hoving began to stump this week for Proposition I, the \$200,000,000 Recreation Bond issue that will appear on the ballot on November 8th. At a luncheon before the Rotary Club of the Bronx at the Concourse Plaza Hotel today, Commissioner Hoving urged a "Yes" vote for the bond issue proposition, "because it will make millions of dollars available for acquisition and development of New York City park facilities".

"New York City cannot afford to turn this proposition down", Commissioner Hoving told the Bronx Rotarians. Noting that, "New York is a wealthy state while New York City is impoverished", Commissioner Hoving said, "We must work toward getting back a fairer share of our tax dollar that goes to Albany as well as to Washington." "The passage of Proposition I will not give us our fair share of the \$200,000,000 State Recreation Bond issue, but it is a step in the right direction. Our \$25,000,000 share, plus the undetermined amount that we may receive from it for marinas and for historical sites, is important money and we can spend it for the benefit of City dwellers", Commissioner Hoving said.

Commissioner Hoving will speak again this week for Proposition I at a dinner meeting of the United States Olympians on Wednesday, November 2nd, at 7 P.M., at the Seventh Regiment Armory, Park Avenue at 66th Street; and at a luncheon of the Park Association of New York on Thursday, November 3rd, at the National Arts Club, 15 Gramercy Place, New York City.

The unique features of this new playground", said Commissioner Hoving, "are that it retains the ancient oak trees on the site, that it provides a number of different levels that break up the visual monotony and provide for a variety of activities and, last but perhaps most important, it demonstrates that good design need not cost more." Commissioner Hoving noted that the new design cost approximately \$100,000 less than an original Board of Education plan that would have destroyed the old oak trees and installed a huge retaining wall around the playground.

Another design for a new park at Rochdale Village in Queens, also by Richard Stein, was shown at the press conference. Commissioner Hoving said that "The intention of the design is to provide a social link between the housing project and the residents of the neighborhood." The Rochdale Village park is designed so that it opens both toward the middle income project of some 6,000 residents and toward the community. Commissioner Hoving also pointed out that "The architect has created a terrain with mountains, valleys and plateaus on a flat site so that major use zones are

encompass are football, soccer and baseball. There is another section for roller skating and softball.

Commissioner Hoving also announced the appointment of two toparchitectural aides: Arthur Rosenblatt, A.I.A., as Director of Park Design;
and Charles E. Thomsen, A.I.A., as Assistant Director of Park Design.

(Biographies of the two architects are available.) Commissioner Hoving said,


"Mr. Rosenblatt has been working here in the Department since January, 1966, on
a foundation grant from Urban America, Inc., as my Design Consultant because
there had been no provision for an architect on the top level of the Department
of Parks' staff. In this position, he has been responsible for the selection
of architects for Park Department projects and for the overall guidance of the
Department's design program. He will continue in this capacity as a City
employee."

Commissioner Hoving announced that "Mr. Thomsen's duties include coordination of the Park Department's vest-pocket park program and administering the \$450,000 Federal grant for the development of portable parks."

"As new design projects, such as these announced today come forth," said Commissioner Hoving, "they will more than justify the need for architects of this caliber at the top level of government."

The P.S. 55 playground in Staten Island is located west of Preston Avenue between Osborne Avenue and Koch Boulevard. It had been budgeted at \$300,000 but costs have now been reduced by the new design to \$200,000. The playground facilities will include an amphitheatre seating 500; a games area which provides for skelly, hop scotch, shuffleboard and basketball; and a group of concrete sculptures by Costantino Nivola.

The Rochdale Village Park is located at New York Boulevard and 139th Avenue. The total estimated cost is \$584,200.

HOVING INVITES NEW YORKERS TO MIDNIGHT SCIENTIFIC "HAPPENING"

Parks Commissioner Thomas P.F. Hoving invited New Yorkers to witness a scientific "happening" that takes place only once every thirty-three and one-third years, in the Sheep Meadow in Central Park on Wednesday night, November 16th, from midnight to 3 A.M. "happening" is the expected meteor shower of Leonids, which provided its most spectacular display on November 12, 1833.

The Parks Department has asked a team of astronomers from the Hayden Planetarium to be on hand to tell the assembled star-gazers, via a public address system, what is happening. Dr. Thomas D. Nicholson, Chairman of the Hayden Planetarium, will be in charge of the lectures. He will be assisted by Dr. Franklin M. Branley, Dr. Kenneth L. Franklin, and Dr. Martin Steinbaum. The lecturers will be assisted by electric beam pointers which shine 300 feet up into the air and will be used to point out the various star formations. Commissioner Hoving suggested that parents put their children to bed early and then wake them close to midnight and bring them to Central Park "because the magnificence of this shower of stars may not repeat itself for another 133 years". The Parks Commissioner also urged parents to bring warm blankets and thermos jugs of hot chocolate or coffee.

Astronomers have predicted, weather permitting, that the November 16th meteor shower will probably equal the extraordinary one of 1833 when thousands of streams of light seemed to be falling from the sky like snowflakes. Research after the 1833 occurrence uncovered a history of these showers dating back to 585 A.D. Scientists were able to make predictions that the meteor showers of Leonids occur every 33-1/3 years. There were minor displays of the November meteor shower in 1866, 1899 and 1933. The Sheep Meadow in Central Park is west of the center of Central Park from West 66th to West 71st Streets.

FACT SHEET ON NEW BEDFORD-STUYVESANT SWIMMING-RECREATION COMPLEX

LOCATION: Kosciousko Street and Marcy Avenue, Brooklyn

COST: \$1,900,000.00

Statement by Architect, Morris Lapidus, A.I.A. - "When Commissioner Thomas Hoving asked our firm to undertake the design of a swimming pool complex for a block in the Bedford-Stuyvesant area of Brooklyn, we not only accepted with pleasure and anticipation, but we knew in advance that this would be an exciting architectural venture. Although the project is called a swimming pool, it is, in fact, a neighborhood park, providing full community facilities for young and old alike; facilities not only for swimming during the hot summer months but a large recreation area that may be, and should be, used twelve months a year. To design such a complex was not only a challenge but an opportunity to combine the lessons learned from designing resorts for all kinds of people in many parts of the world, as well as the design of many large housing and community complexes scattered along the Eastern seaboard.

"Except for the swimming pool, the entire project will be carried out in reinforced concrete. The locker facilities, as well as all other utility spaces, will be partly below street level. The locker rooms will be reached by inviting ramps from Marcy Avenue. There are no buildings as such. The roof over the locker rooms and administrations areas, showers and toilets, as well as other utility

spaces, become play areas such as amphitheaters, picnic plaza and many other community facilities. Climbing pyramids for children will house the ventilating system. Vent pipes for the plumbing below will become a forest of trees to be climbed by children. A cascading water fall, dropping into a lagoon will be used by toddlers as water slides and a wading pool. The area for snacks and micnicking can become an amphitheater for puppet shows or for community concerts or serious dramatic presentations. The bleachers, facing the swimming pool, become a terraced plasza complet with varying sized balconies for large groups, small groups and couples. Every square foot of space is designed for multiple use during warm weather and cold, during the day and during the evening. The swimming pool and the diving pool (they are two separate entities) are made entirely of aluminum. The swimming pool is 250 feet by 100 feet and is one of the largest installations of its kind. The aluminum pools are an innovation in New York City. They will be completely maintenance free and will overcome the problems of possible cracking or other faults which occur in large pools of this size when formed of their normal material, concrete, The large pool may be used for swimming during the cold months by placing : a plastic air bubble over it, or it may be turned into a half-dozen basketball courts or several touch football fields. The ultimate allweather uses are still to be determined. The concrete that will be used in the construction of the Bedford-Stuyvesant pool will employ many textures and treatments. Here will be found no dull concrete walls or floors. The flexibility of concrete will be utilized to its fullest capacity to produce excitement and beauty, aside from the unusual and

varying textures of the surfaces, we intend to have inlays of colored ceramic glass, which will create large murals on a number of the walls. Floors will be covered with non-slip epoxy in bright, vibrant primary colors and unusual patterns. Great economies are anticipated from the use of concrete and aluminum.

"The lighting for the entire area will be designed by Abe Feder, who worked with us in designing the illumination for the first mall in the United States - - The Lincoln Road Mall on Miami Beach.

This is the same Feder who illuminated the John F. Kennedy Airport and parts of Central Park.

"The Bedford-Stuyvesant Park and Swimming Pool will be a place to sit, a place to rest, to dream, to relax, a place for children to climb, slide, to explore, to pretend, to exercise and to release an overabundance of energy. It will be a place to socialize in pairs or in groups, it will be a place for movement, both horizontally and vertically, and even in a side wise direction. In effect, this park will be able to create environments for the old as well as for the young, or an environment for the entire community. It has been designed for competitions and exhibitions, for a musements and serious music, dance and drama, as well as a place for children's puppet shows and pageants.

"The Bedford-Stuyvesant Park will not be just a swimming pool and a group of locker buildings, nor will it be a playground with slides, swings and sand boxes. It is intended to be a living space. One of the great living spaces in the world is the Piazza de San Marco in Venice, which is the focal life for the city and the community. The Bedford-Stuyvesant neighborhood park will in its way become a large living space intended for the enjoyment of members of the entire community."

Applications are available until the end of December at all public, private and parochial and Hebrew high schools, university and college placement offices; all YMCA, YMHA, and Red Cross Chapter offices; also, at all borough offices of the Department of Parks. Applications will be accepted by the register clerk at East 54th Street Pool at 342 East 54th. Street, Manhattan.

The instructive classes will begin early in January 1967, and enrollees will be required to attend 14 sessions (2 hours weekly) which will be held afternoons and evenings each weekday, and mornings and afternoons on Saturdays. Applicants will be given their choice of class periods.

"The fact that I showed the Loewy-Snaith plan to the Mayor," said Commissioner Hoving, "or that I met with representatives of Loewy-Snaith at an earlier date to discuss their Mall proposal confers no special status on the idea." Commissioner Hoving said, "I show many proposals to the Mayor and I meet with many groups in the City which have ideas to promote. This is not the same thing as an official endorsement."

LASKER RINK AT HARLEM MEER WILL OPEN

New York City's ice-skaters will get a treat for the holiday season as the long-awaited Louis D. Lasker Memorial Swimming Pool-Ice Skating Rink opens on Wednesday, December 21st. Parks Commissioner Thomas P.F. Hoving and Mayor John V. Lindsay will take part in the dedication ceremonies at 2:00 P.M.

Upon completion of the brief formal program, exhibition skaters from the Park Figure Skating Club will put on a show on ice.

The rink will be open to the public for the rest of the day and evening after the dedication ceremonies are concluded at approximately 4 P.M. Regular ice skating sessions will be in operation but there will be no charge for admission on December 21st. (A schedule of skating sessions is attached.)

William Rosensohn, a nephew of the late Loula D. Lasker, will make a presentation of the gift on behalf of the Lasker family and Philip W. Haberman, Jr., an executor of the Estate of Loula D. Lasker, will take part in the ceremonies. The Lasker Family gift of \$600,000 was supplemented by over \$2 million of City funds to create this dual purpose facility. The ice-skating rink converts to a swimming pool in the summer time, providing for year-round recreational use.

Manhattan Borough President Percy E. Sutton will also speak at the dedication ceremonies.

The Louis D. Lasker Memorial Rink and Pool was scheduled to open in February, 1966, but a serious flood caused extensive damage to the freezing equipment. Parks Department and construction personnel have been working around the clock in recent months to get the rink open prior to the holiday season.

Designers of the Lasker Rink and Pool were Fordyce & Hamby, Architects, of 717 Fifth Avenue.



FACTS ABOUT THE LOULA D. LASION NUMBERIAL SWIMMING POOL-SKATING RINK

This combined swimming pool-skating rink, located in the Harlem Meer section of Central Park, is the first such facility to be constructed in the city of New York. Designed by Fordyce & Hamby Associates, Architects, it can accommodate about 2,000 skaters or swimmers at one time.

The swimming pool's oval form has a total circumference of 750 ft. with a maximum diameter of 245 ft. in a north-south direction and 195 ft. in an east-west direction. The area of the pool is about 33,500 square feet and the area of the skating rink within it is 23,000 square feet, approximately the same area as the present Wollman Rinks in Central Park and Prospect Park in Brooklyn. The floor slab of the pool contains the refrigerant piping necessary to transform it into a skating rink.

The heavy flood which occurred last February and which delayed the opening of the rink-pool complex had one fortunate result: it enabled us to re-examine the design of the pool and provide a portable ramp at one end which will permit non-swimming children to bathe in safety, as the pool has a uniform water depth of 3 ft. 6 in.

The water for the pool is supplied by four waterfalls, each 20 ft. high and 7 ft. wide, and 80 small jet fountains set between them which rise from 3 to 10 feet, all forming a water curtain around the south edge of the pool. The entire area will be illuminated at night.

The building adjoining the swimming pool-skating rink also serves a dual function. During the winter, it will house areas for clothes checking, skate rental and changing, and a skate shop. During the summer season, these facilities will become lockers.

The first aid room, mechanical equipment spaces, toilets, storage areas and supervisor's office serves both facilities, and there are observation facilities on the roof of the building for spectators.

The site of the Loula D. Lasker Memorial Swimming Pool-Skating Rink at the southwest end of Harlem Meer in Central Park, within the

curve of the East Drive was selected for its naturally hollow countour which permitted construction in the existing shape of the land without major excavations. The existing stream feeding the Meer has been diverted below the pool.

The mechanical equipment is also designed for dual use, i.e., the same boilers and tanks which will produce hot water for showers in the summer time, heat the building during the winter.

The pool and rink are constructed of concrete while the buildings are of brick and precast stone.

The final cost of the swimming pool-skating rink is \$2,650,000 of which the Estate of Loula D. Lasker donated \$600,000.

Thomas P.F. Hoving, Commissioner of Parks and Bernard B. Zients, Executive Head of Gimbels New York will join together at Gimbels to officially open a Theater Workshop for all school children in the City of New York on Wednesday, December 28, 1966 at 10 a.m., 6th Floor Auditorium.

This pilot project under the joint sponsorship of the New York City
Parks and Gimbels New York is designed to encourage the establishment
of quality theater by and for children in the five boroughs of New York and
is completely free of charge.

The Workshop, under the direction of Gordon Duffey of the Parks Department will present two full length plays this season. The plays produced will be one musical play and two short operas for children. One play is an original musical "Asterisk on the Moon" (book and lyrics by Gordon Duffey, music by Edward Mannato). This play will be for younger children. There will also be performances of two short operas for older children, "He Who Says Yes" and "He Who Says No" (librettos by Bertholt Brecht, music by Kurt Weill).

In addition, weekly sessions in creative drama, jazz forms and movement, singing and acrobatics for the stage will be held for all children who register for participation in the Workshop.

Registration for participation in the Gimbels-Parks Department

Theater Workshop will take place in Gimbels 6th Floor Auditorium beginning

December 28th through December 31st, 1966 - between the hours of 10 to 12 noon and from 4 to 6 p.m. Any school child in New York (from grades 1 through 12) may register for the Workshop and audition for one of the two productions.

Mr. Hoving stated that "the New York City Parks Department is delighted to participate with Gimbels in bringing creative, educational drama to the children of New York." He went on to say "that although the Parks Department has long been involved in bringing theater closer to youngsters, this is the first time they have found a "winter park" in which to carry on their activities during the Winter Season."

Actual workshops and play rehearsals will be held in the Auditorium at Gimbels New York until the end of May, 1967. During the summer, the Workshop will take its activities to parks and playgrounds in the five boroughs.

Mr. Zients of Gimbels stated that "this unique program is part of Gimbels' overall effort to encourage young people to participate more fully in the arts and thereby gives Gimbels the chance to provide the means and facilities to increase such participation."

NIGHT SKIING NEW FEATURE AT VAN CORTLANDT PARK SKI SLOPE

The Van Cortlandt Park ski slope will be illuminated for night skiing until 11:00 P.M., said Parks Commissioner Thomas P.F. Hoving, announcing the opening of the official ski season at Van Cortlandt Park in the Bronx, on Friday, December 23rd.

Started as an experiment last year, night skiing proved so successful that it has been incorporated into the regular schedule of the Van Cortlandt Park Ski Area's fifth season. "It enables thousands of New Yorkers to leave their offices and be on the slopes in less than an hour," said Art Peterson, director of the ski area.

The ski area will be open from noon to 6 P. M. on weekdays (Wednesdays and Fridays until 11 P. M.) and from 10 A. M. to 6 P. M. on Saturdays, Sundays, holidays, and during the Christmas week. General admission, including the use of tows, is \$4.40 for adults and \$2.40 for juniors 12 years of age and under. After 3 P. M. daily, there is a discount of \$1.00 on the general admission price.

Several major improvements have been made in the Van Cortlandt Park Ski Area which accommodates 500 to 1000 skiers. A new beginner's area has been developed with provisions for full instruction and the ski school staff, which offers group and private instruction at regular times during the day, has been expanded. Four electrically powered rope tows have been repositioned to enlarge the skiing hills.

Van Cortlandt Park parking lot to the slopes has been provided for skiers.

A snack bar at the base lodge and a grandstand area for spectators is available.

Citing the Van Cortlandt Park Ski Area as a place where people can be safely introduced to skiing, Mr. Peterson added, "We're not in competition with Vermont or New Hampshire. Our function is one of preparation -- breaking in new equipment, practicing, or just plain learning how to ski slowly and in safety.

A special ski package that includes admission, tows, rental of equipment and one hour of instruction is being offered to Van Cortlandt Park skiers for \$8.40 for adults, \$6.40 for juniors under 12 years of age.
