<sup>1</sup> Pursuant to § 1-15(b)(3) of the Board’s minimum standards and in compliance with § 6-05(g)(3), the Department declares an emergency variance when an individual remains in de-escalation confinement for more than six (6) hours. The Board can monitor placements in real time by utilizing the Inmate Tracking System and De-Escalation Authorization forms.

<sup>2</sup> Housing areas used for De-Escalation remained the same for all 3 reporting months as the abovementioned housing areas in Table 5. The Department does not report housing areas publicly; specific housing areas are reported confidentially directly to BOC.
