*** MINUTES ***

Informational presentation and discussion with representatives for the Department of Transportation on a temporary art installation entitled "Las Bicicletas" involving the installation of sculptures at various parks and open space locations in the district from June through September 2014.

The committee chair, Glenn Kelly said that he will speak to the CB6 Board about getting the mounted screen in the Community Room working and steps outlined in writing attached to it.

Glenn introduced Chris Hrones of the Department of Transportation and artist Gilberto "Juan" Aceves Navarro and Emily Colasacco, of DOT's Public Art program, and three other DOT members.

Juan introduced the art project, U.S. debut "Las Bicicletas," a Mexican artist. The bicycles project began in 2008 in Mexico City, 2010 in Monterey in an industrial zone, 2012 in Monterey in 122 black, white, red coming to NYC – 10 locations – planned to be visited by bikers too.

- Atlantic Avenue at Columbia Street 30 bikes with 3 different installations 3/8" wide, painted/baked. There will be plaques at every site and smart phone applications.
- Bartel Pritchard Square at 15th Street entrance to Prospect Park.
- Louis Valentine Park on the pier.
