*** **MINUTES** ***

Continued review of a preliminary design proposal by the Department of Parks & Recreation for the Renovation of Ennis Playground located between $2^{nd}/3^{rd}$ Avenues and $11^{th}/12^{th}$ Streets.

Martin Maher from the Department of Parks & Recreation made the presentation and recommended creating a "Friends of Ennis Park" group.

Question: Can we rearrange play areas to limit the likelihood of adult congregation near the residences?

Answer: Can't put basketball courts next to residences. "Friends of Ennis Park" will keep Police attention on the park in the event of illegal noise. Also, definitive open and closed times will enable enforcement of noise codes. Community can request open and closed hours.

There is free play area close to houses and Parks is reluctant to change. Next door residents feel concerned about noise.

Parks is concerned about DOT maintaining lights and wants to keep the design and not move the path.

A proposal for additional space for barbecue not in the park was made by Mark Shames.

Motion made by Mark Shames, seconded by Suzanne Turet:

Recommend approval of the Ennis Playground design as presented with the following conditions:

- That there be incorporated into the design an additional entrance entrance/exit to the park.
- That efforts be made forthwith to identify and establish an alternative site in the Gowanus area for outdoor barbecuing.
