Purpose: This bulletin prospectively rescinds 31 Buildings Bulletins (BBs) and 14 Technical Policy and

City Construction Codes.

Prospectively rescinded documents are not applicable to projects filed under the 2014 New York City Construction Codes. They will appear on the Department website with the watermark "ONLY FOR PROJECTS FILED BEFORE 12-31-14; SEE BUILDINGS BULLETIN 2014-015." (The referenced BB 2014-015 gives more detail on the effective date of the 2014 Construction Codes.)
